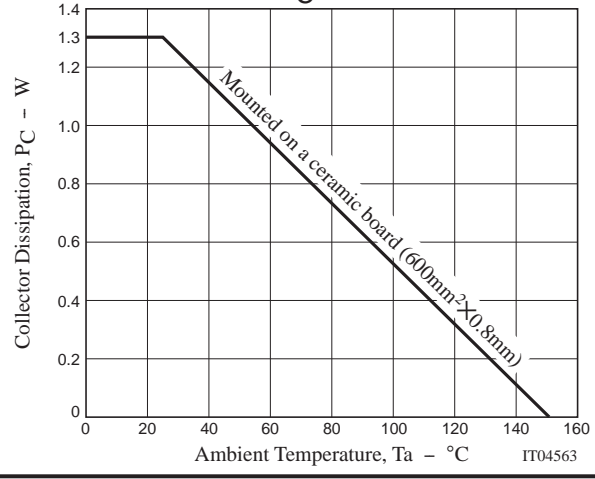
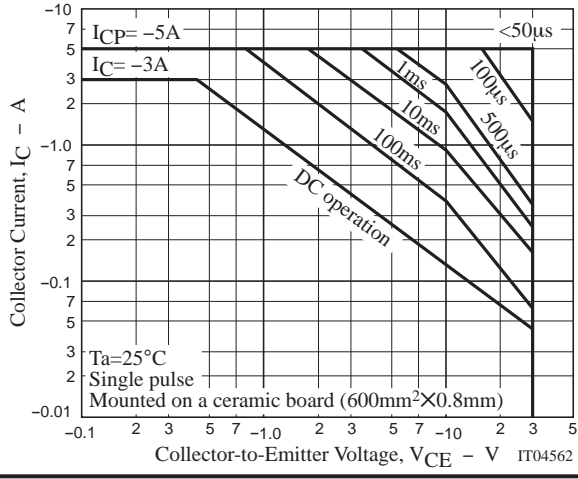
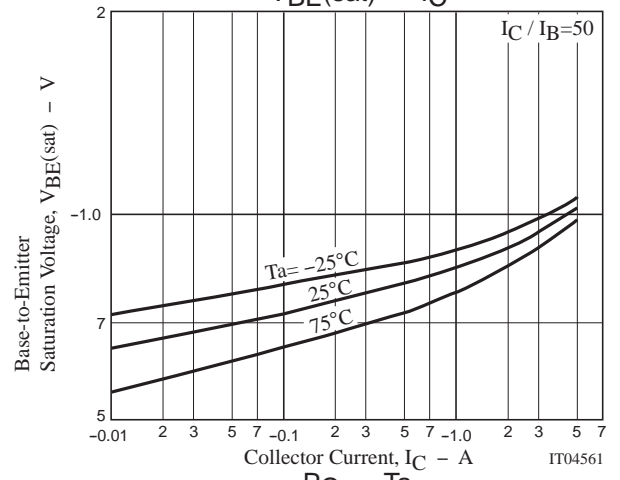
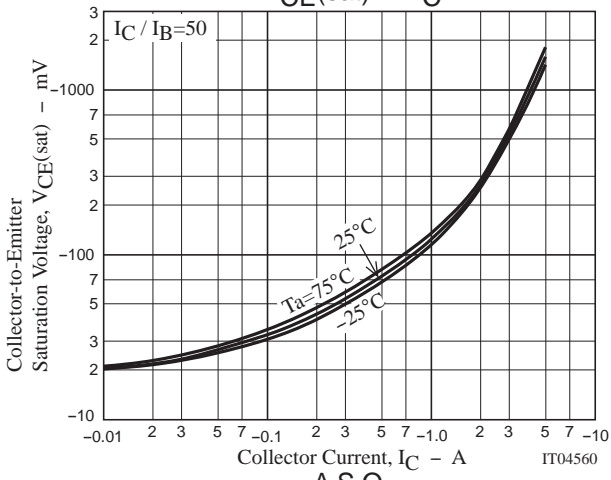
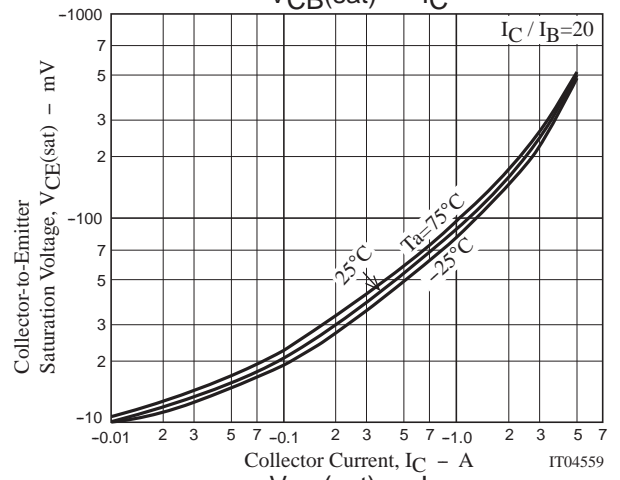
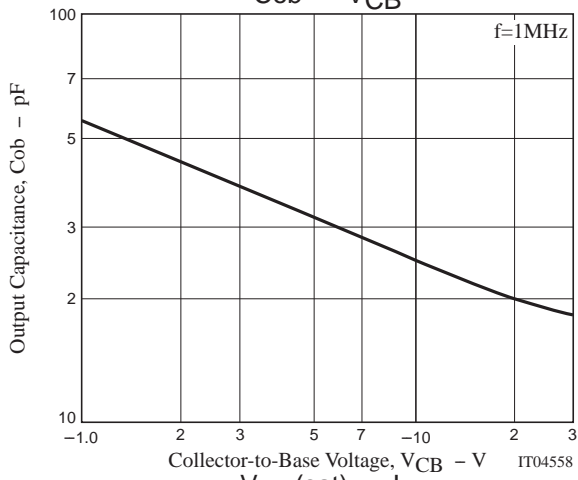
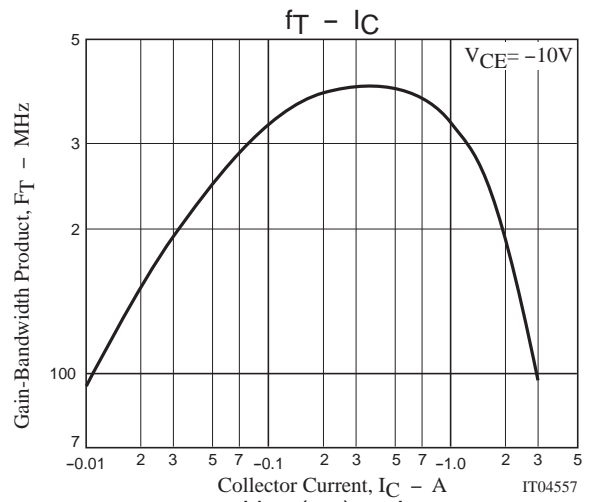
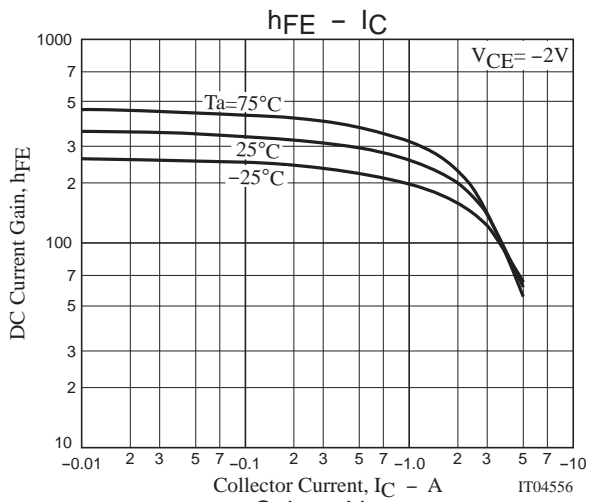
## Switching Time Test Circuit

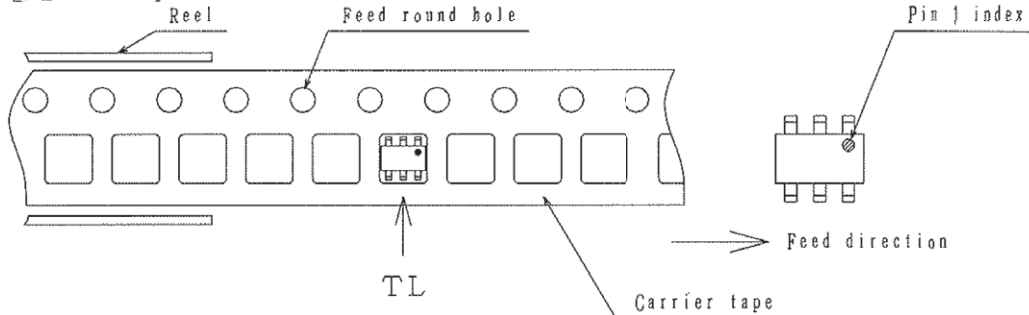

2-2. Device placement direction

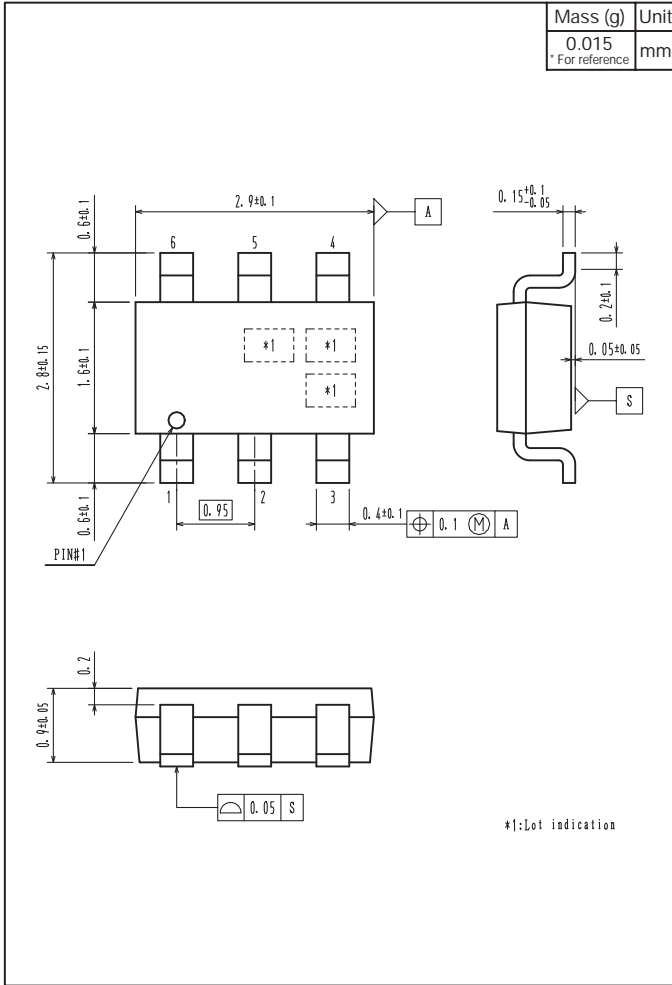

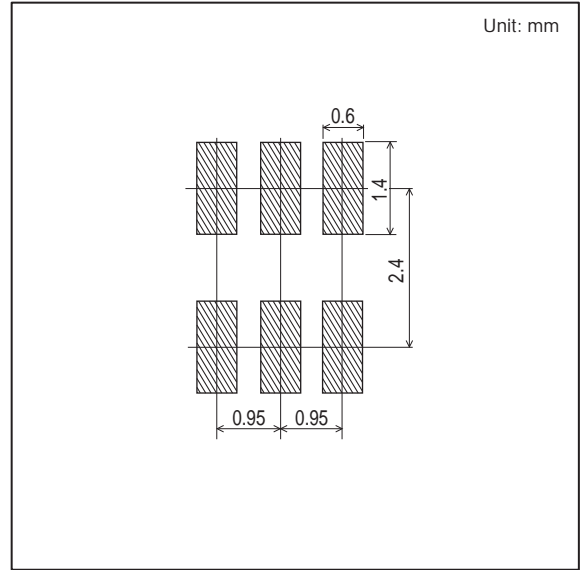
