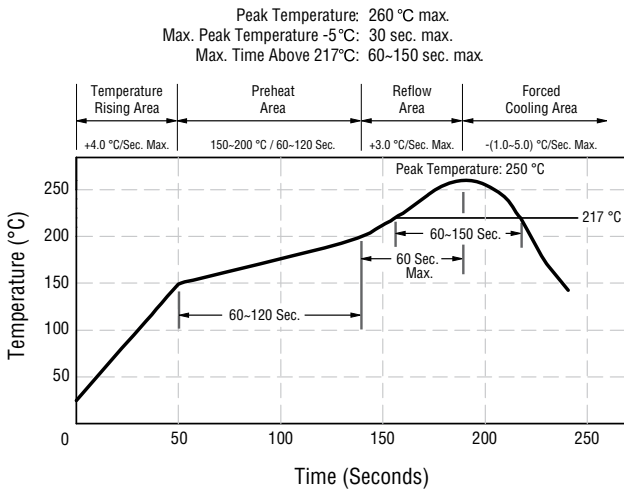

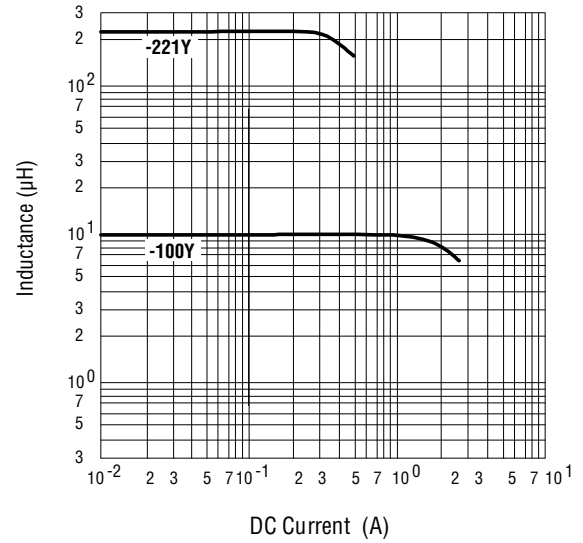

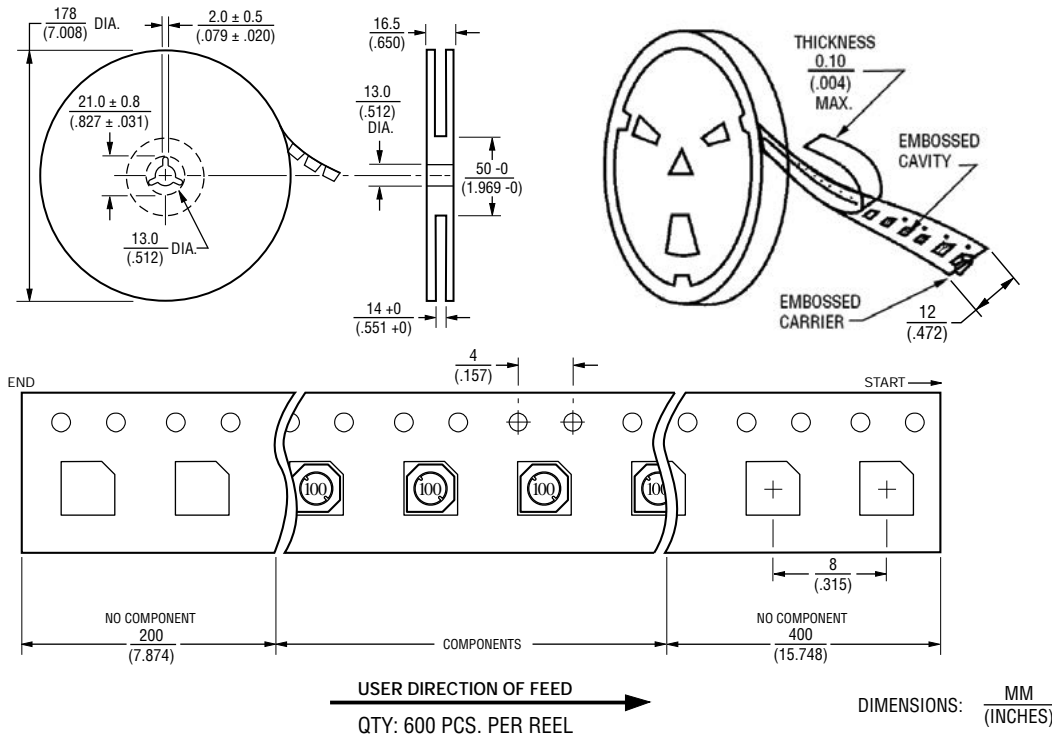
Soldering Profile
