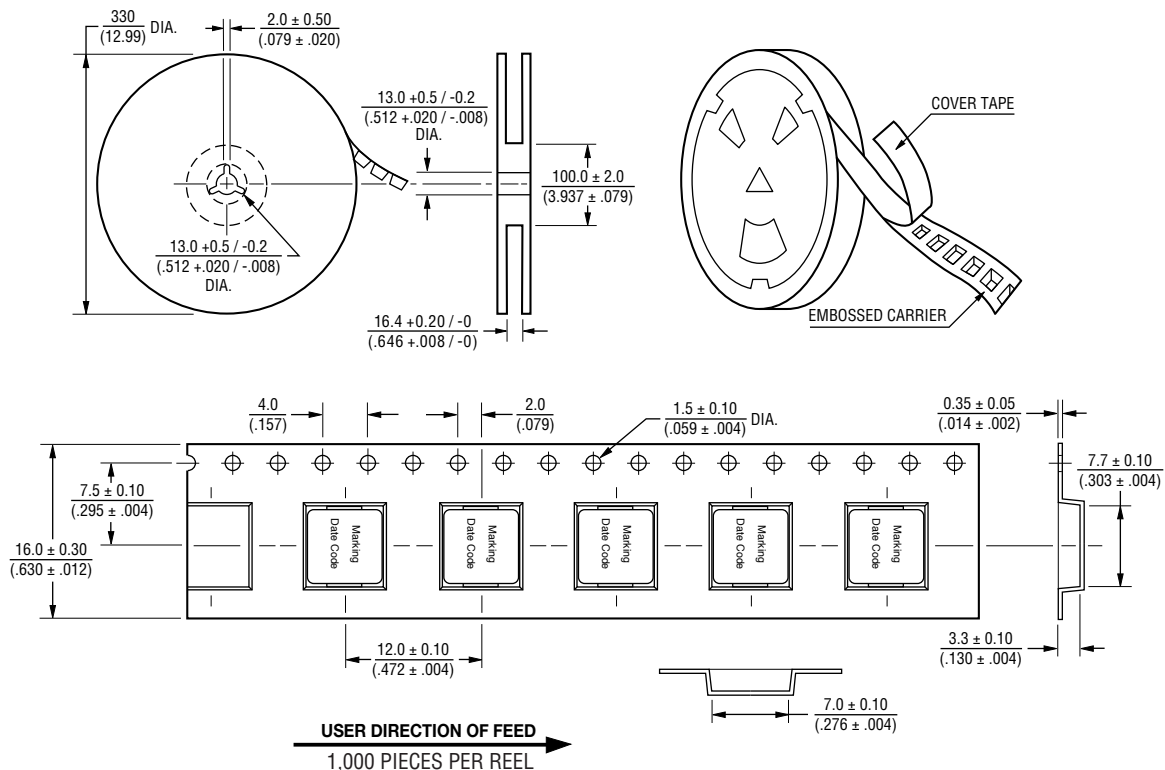
## L vs. I Charts (Continued)
