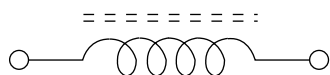

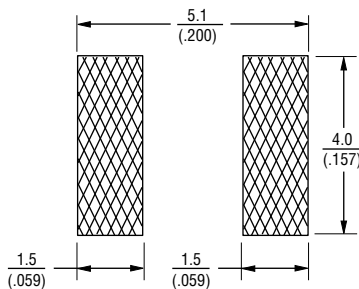
Electrical Schematic

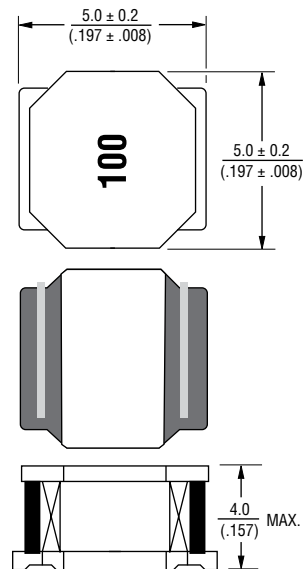

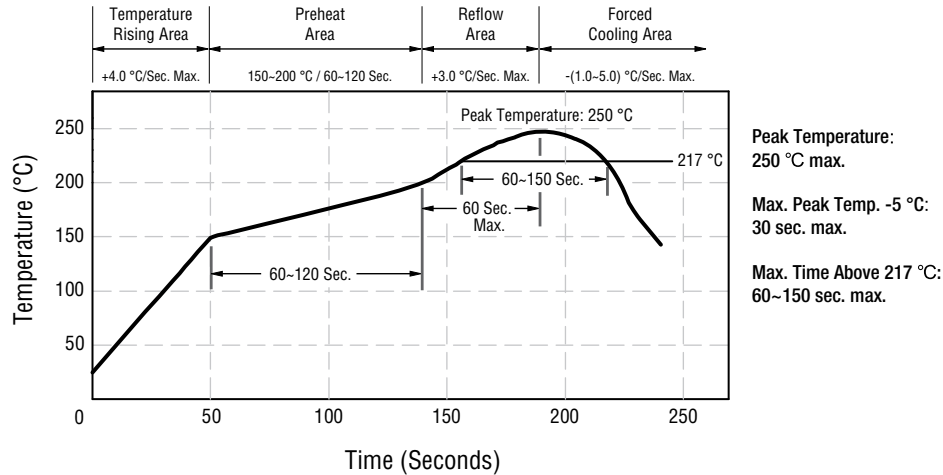

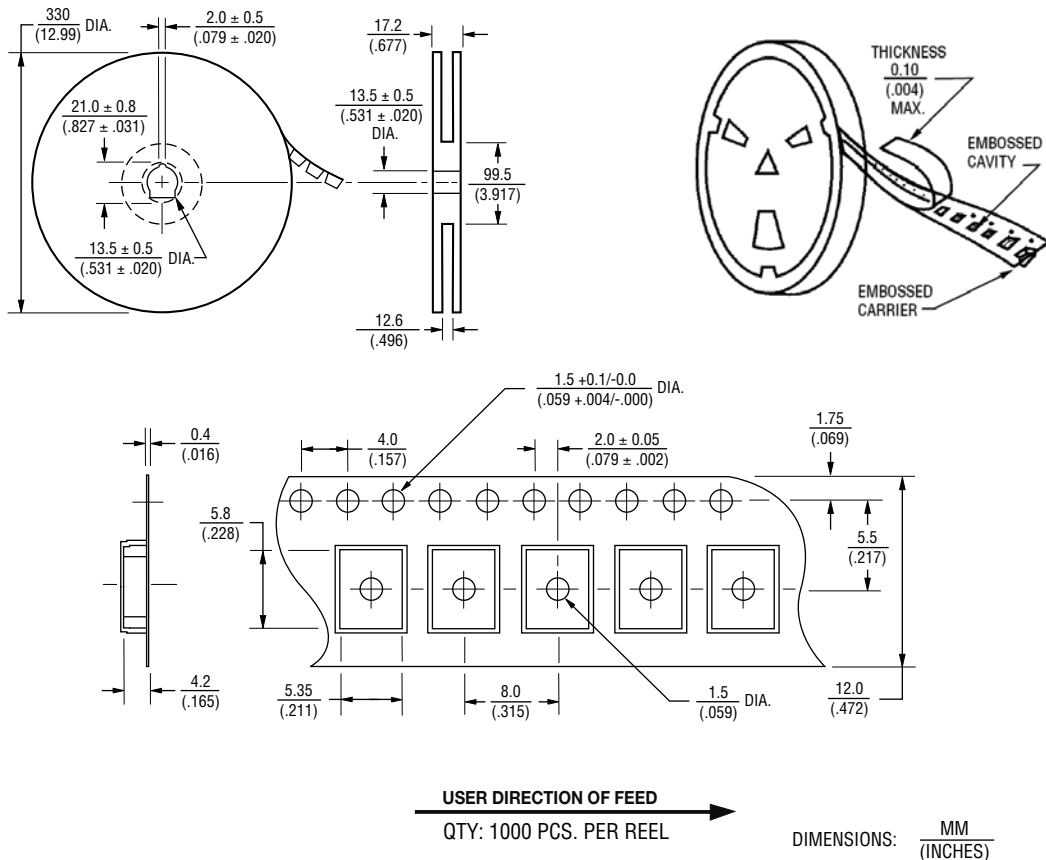
