## 1. General description

Bidirectional ElectroStatic Discharge (ESD) protection diode designed to protect one signal line from the damage caused by ESD and other transients.

The device is housed in a SOD882 leadless ultra small Surface-Mounted Device (SMD) plastic package.

- Bidirectional ESD protection of one line
- Ultra small SMD plastic package 1 x 0.6 x 0.48 mm
- ESD protection up to 30 kV
- Very high surge robustness;  $I_{PP} = 12\text{ A}$  for 8/20  $\mu\text{s}$ ; average measured

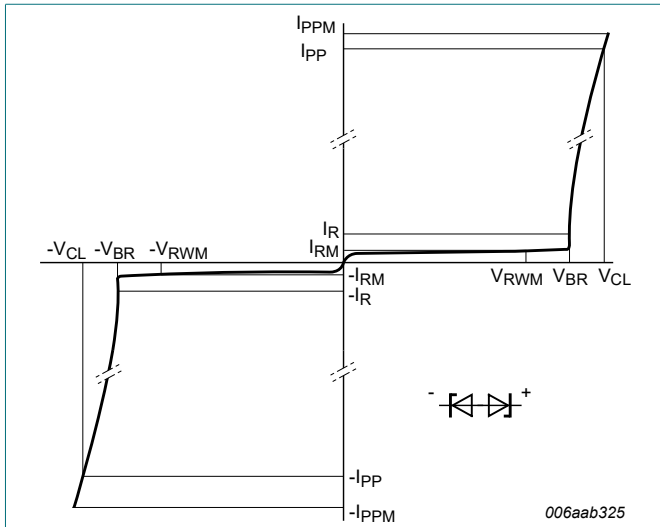


Fig. 3. V-I characteristics for a bidirectional ESD protection diode

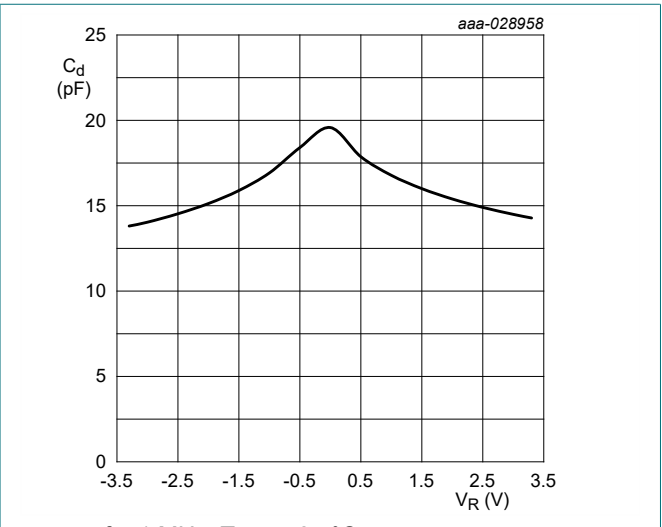
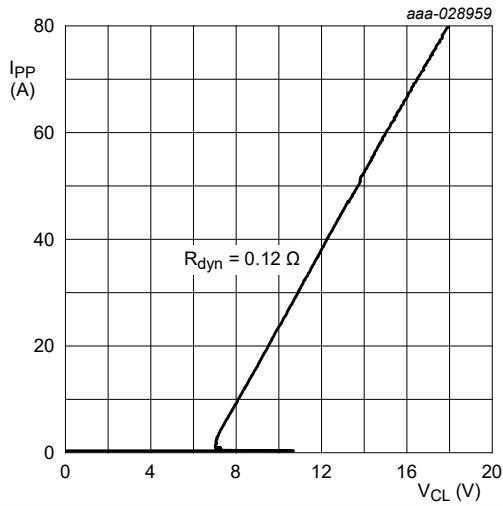
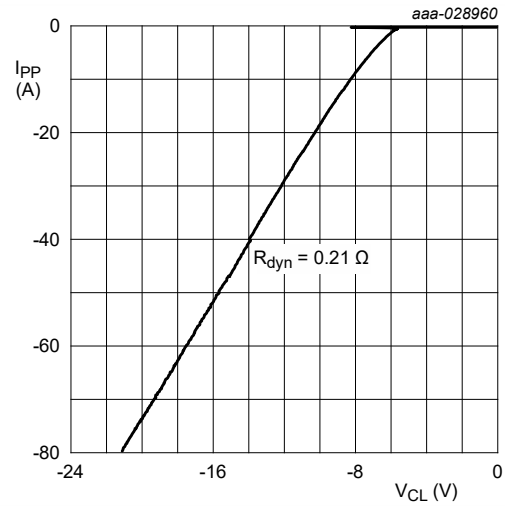


Fig. 4. Diode capacitance as a function of reverse voltage; typical values  
 $f = 1\text{ MHz}; T_{amb} = 25\text{ }^{\circ}\text{C}$



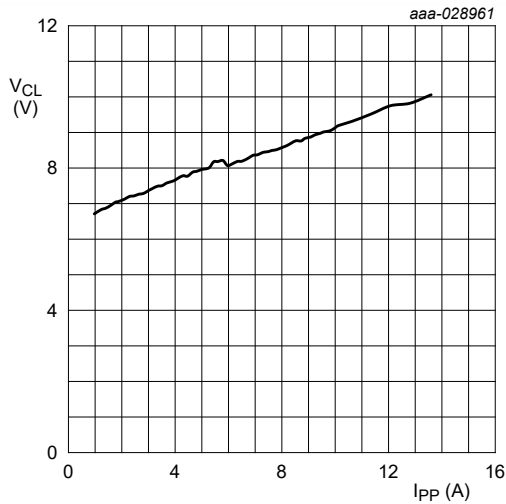
Transmission Line Pulse (TLP);

**Fig. 5. Dynamic resistance with positive clamping; typical values**



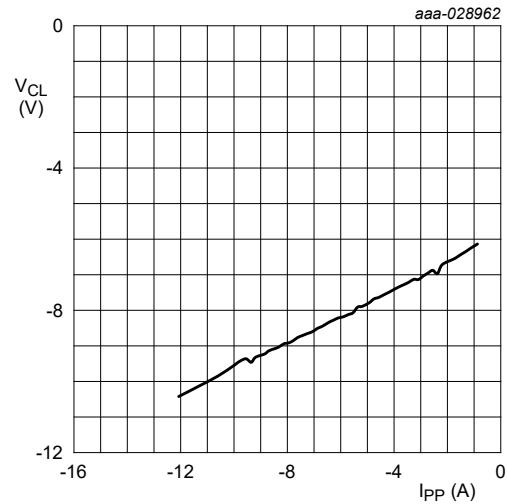

**Fig. 7. Positive clamping voltage (8/20 μs pulse); typical values**

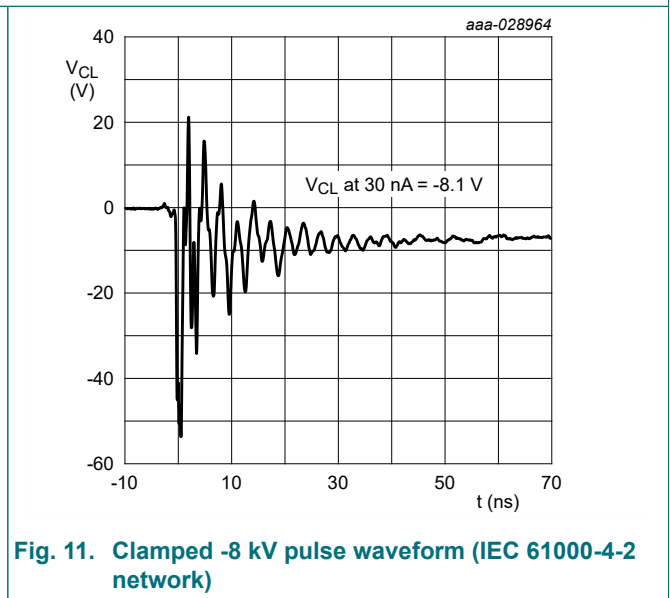
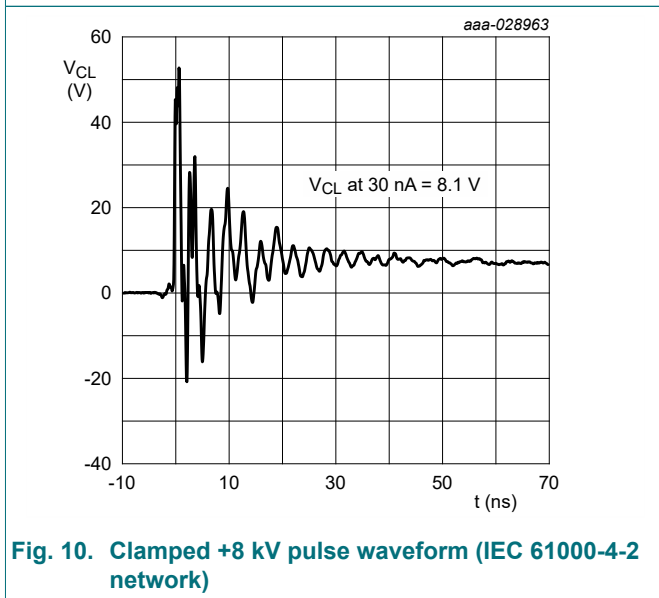


IEC 61000-4-5;  $t_p = 8/20 \mu\text{s}$ ; negative pulse

## 10. Application information

The device is designed for the protection of one bidirectional data line from surge pulses and ESD damage. The device is suitable on lines where the signal polarities are both positive and negative with respect to ground.

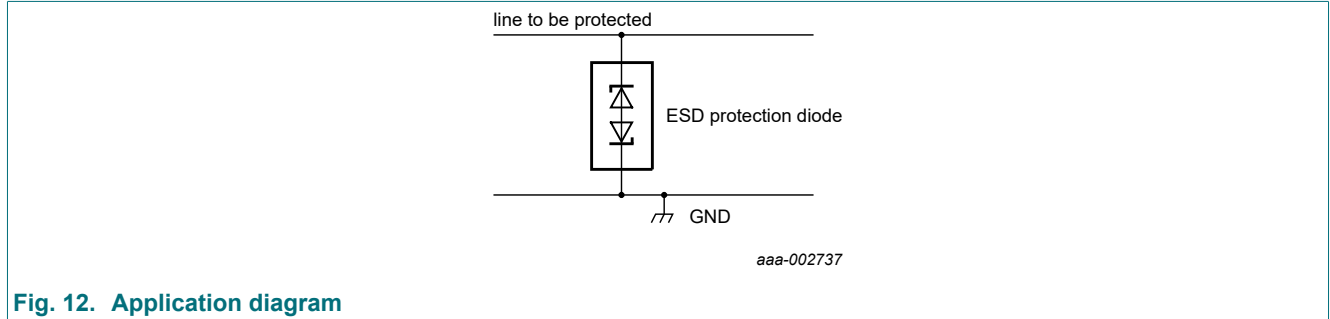


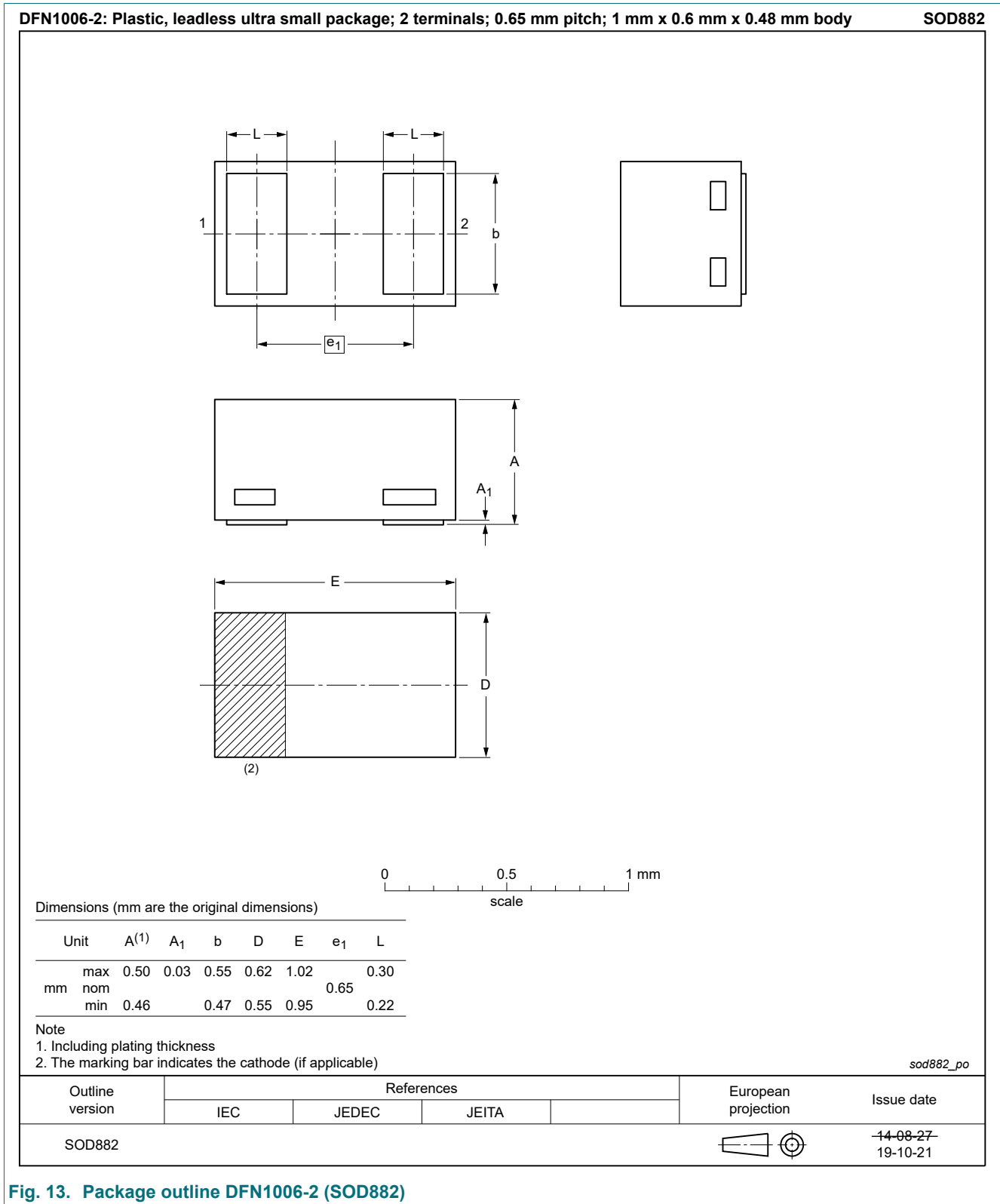
Fig. 12. Application diagram

### Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

1. Place the device as close to the input terminal or connector as possible.
2. Minimize the path length between the device and the protected line.
3. Keep parallel signal paths to a minimum.
4. Avoid running protected conductors in parallel with unprotected conductors.
5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
6. Minimize the length of the transient return path to ground.
7. Avoid using shared transient return paths to a common ground point.
8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.

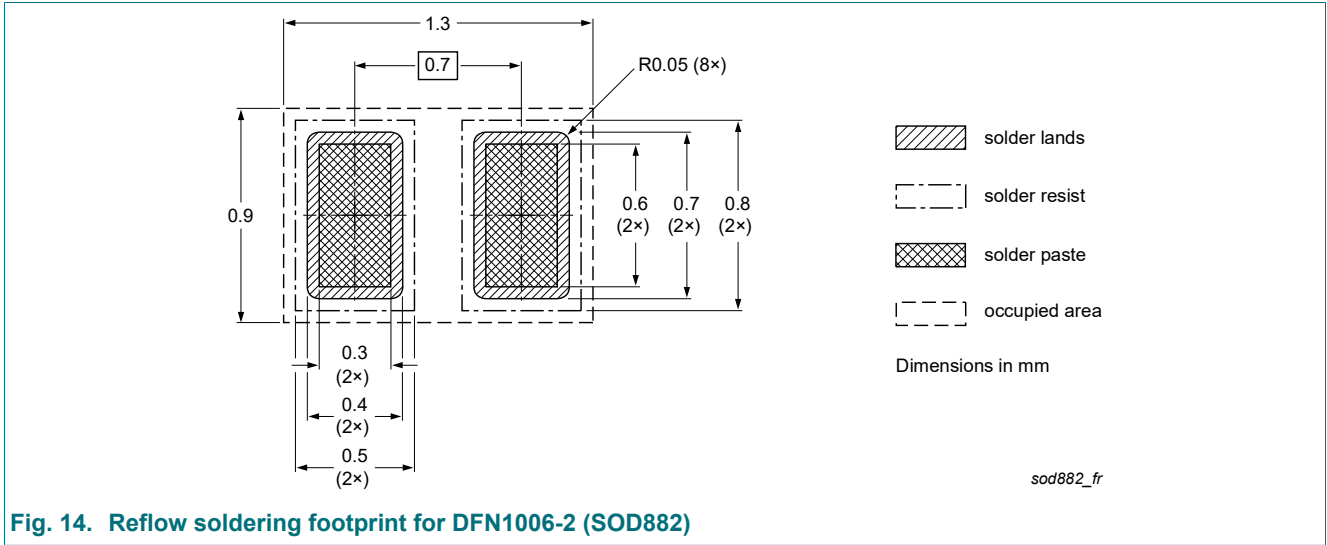


Fig. 14. Reflow soldering footprint for DFN1006-2 (SOD882)
