1. General description

The 74AUP1G11 is a single 3-input AND gate. Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times. This device ensures very low static and dynamic power consumption across the entire V_{CC} range from 0.8 V to 3.6 V. This device is fully specified for partial power down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.




Fig. 1. Logic symbol




Fig. 2. IEC logic symbol





Fig. 3. Logic diagram





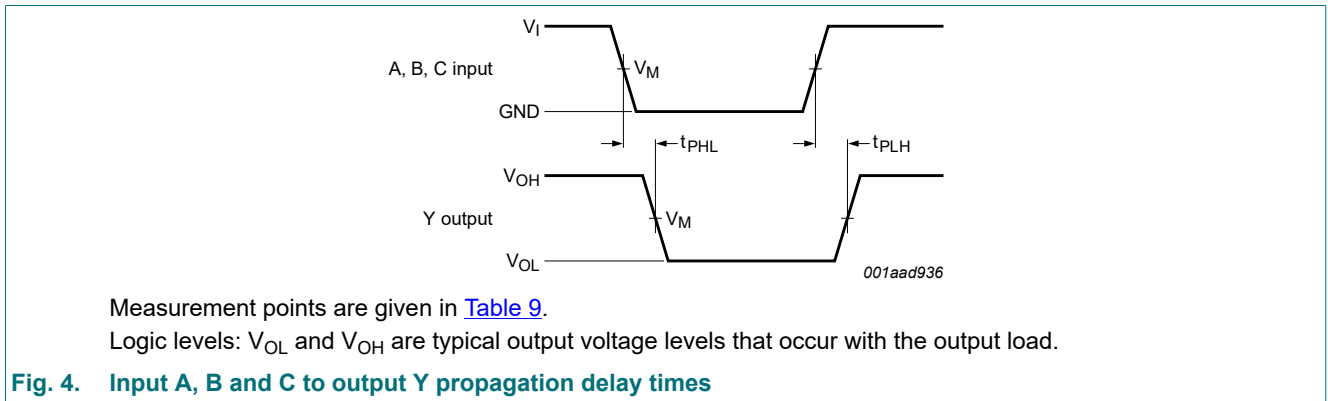
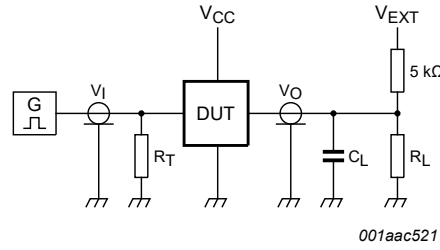
