## 1. General description

The 74HC04; 74HCT04 is a hex inverter. The inputs include clamp diodes that enable the use of current limiting resistors to interface inputs to voltages in excess of  $V_{CC}$ .

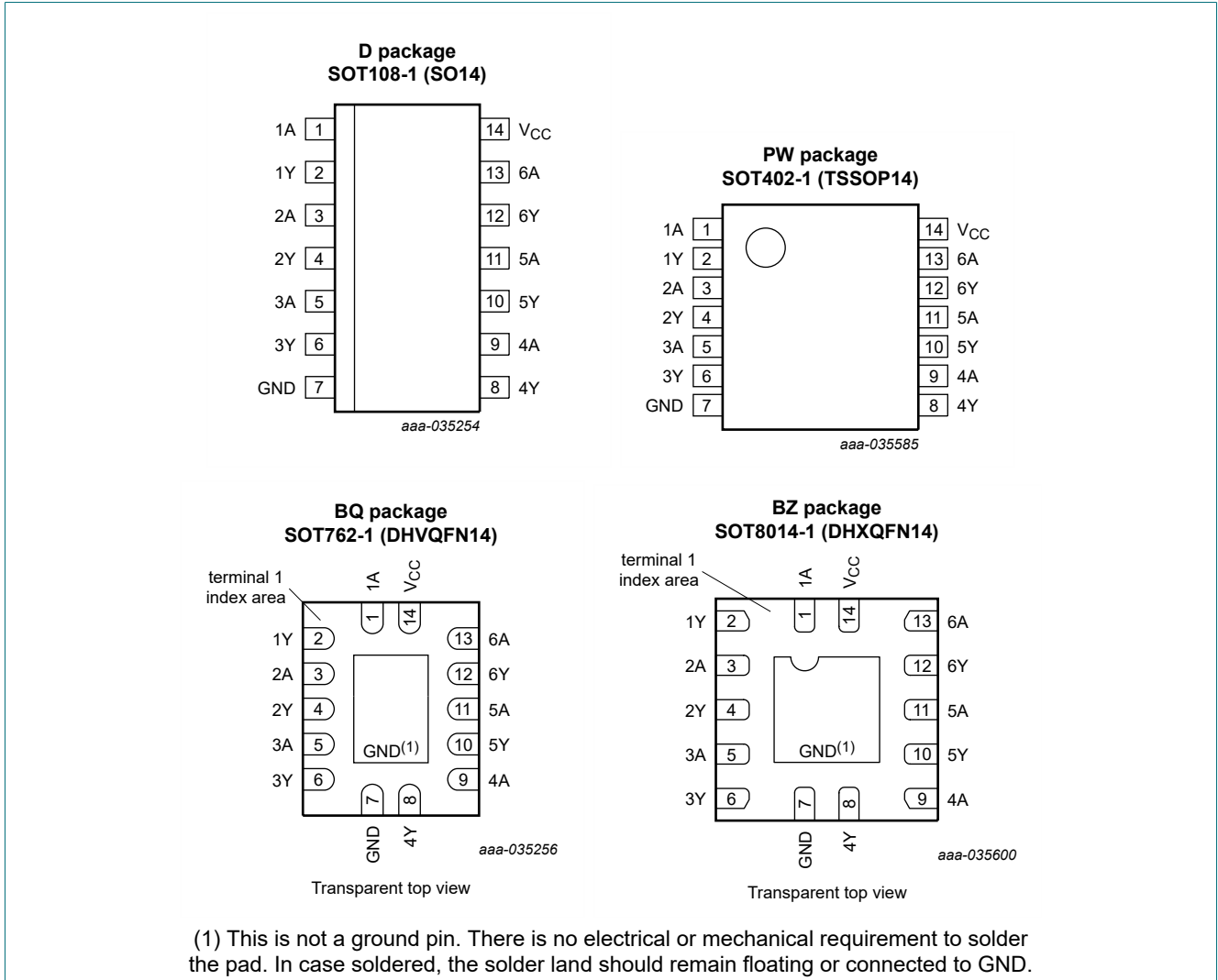

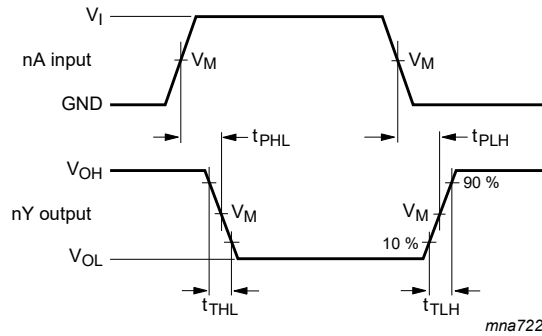

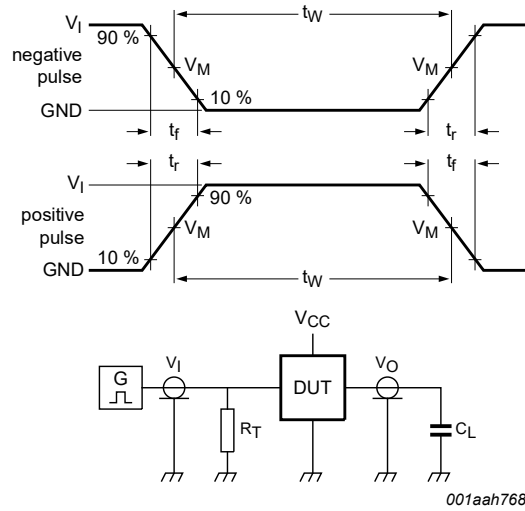

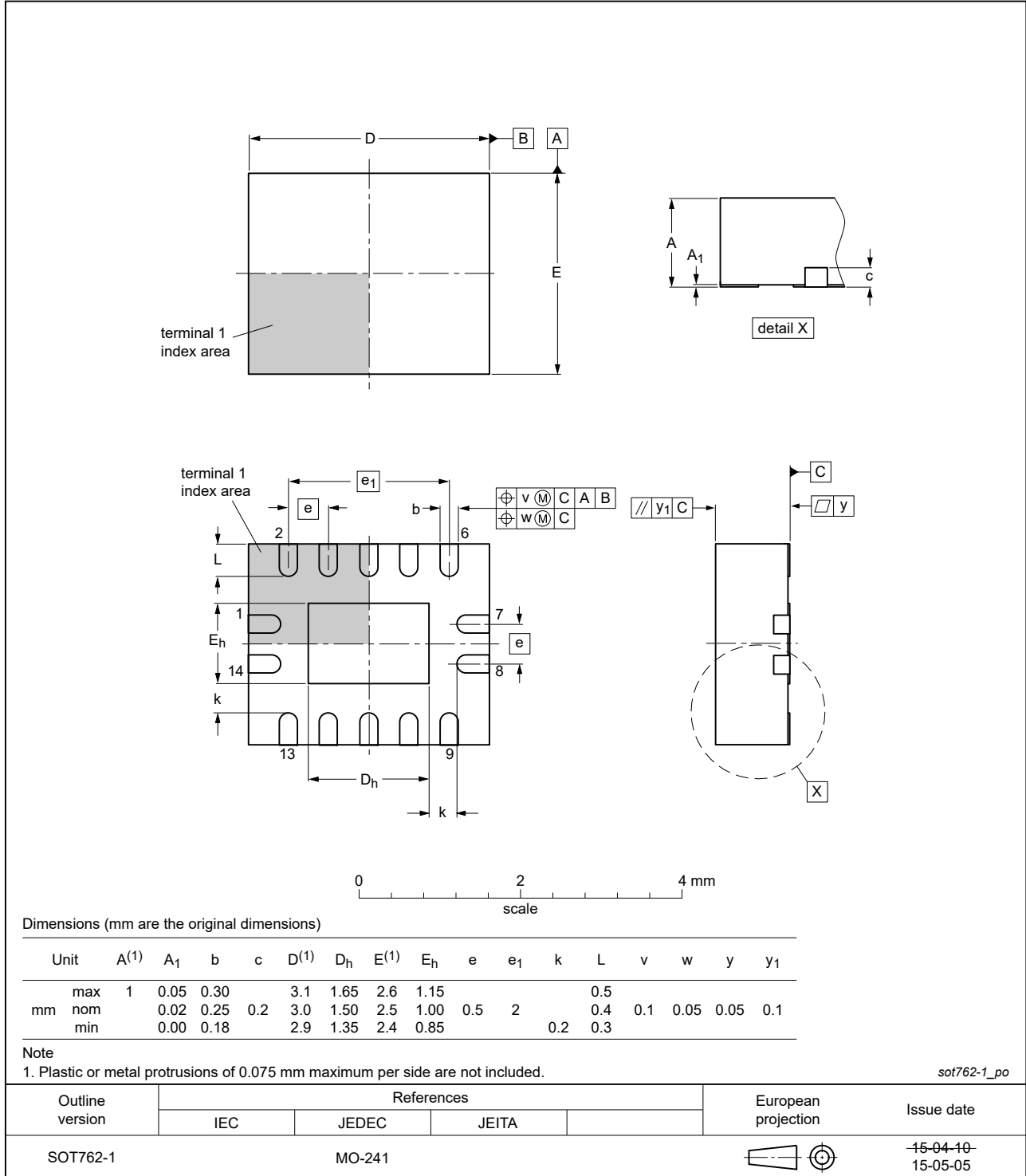


Fig. 8. Package outline SOT762-1 (DHVQFN14)

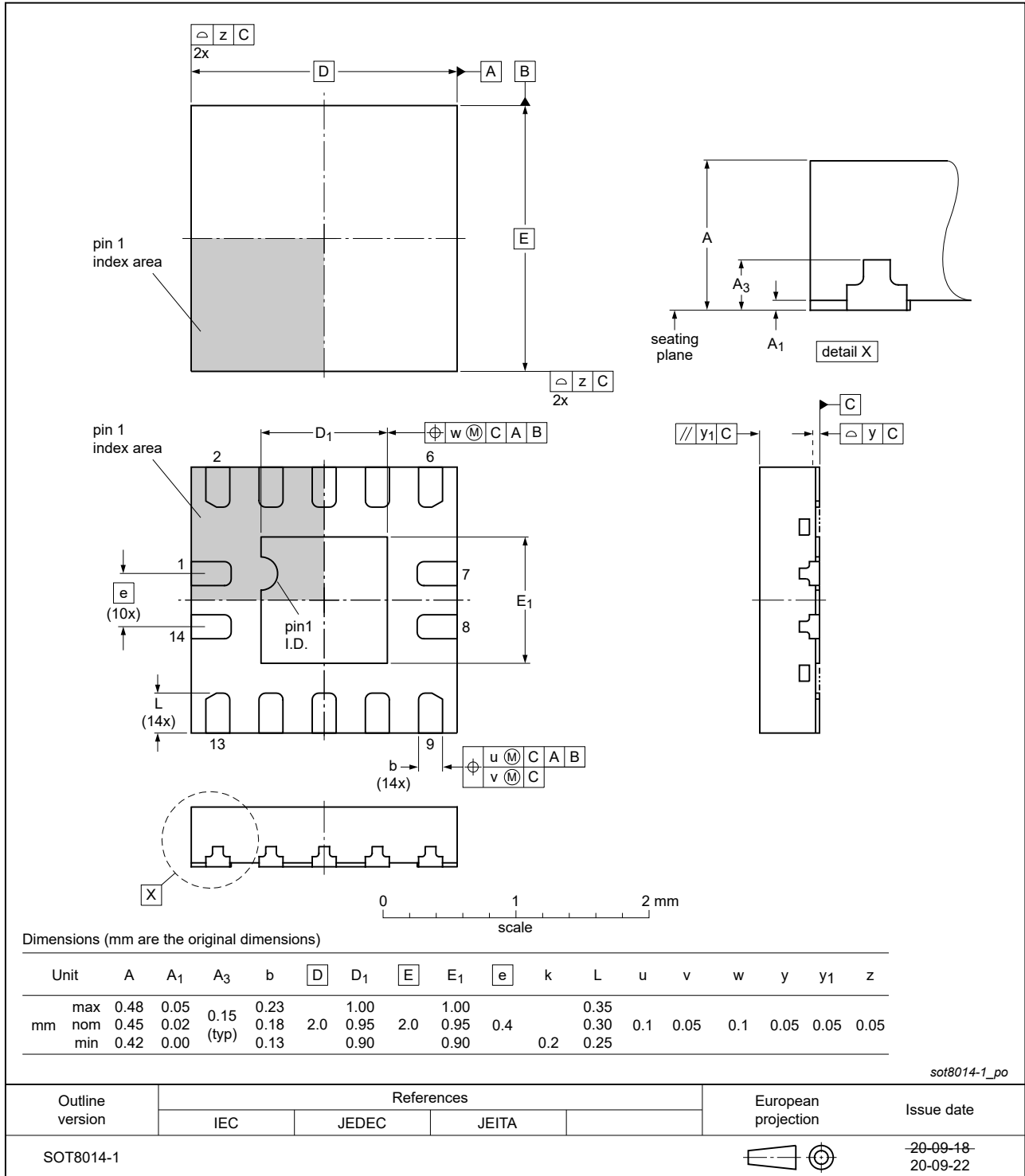


Fig. 9. Package outline SOT8014-1 (DHXQFN14)
