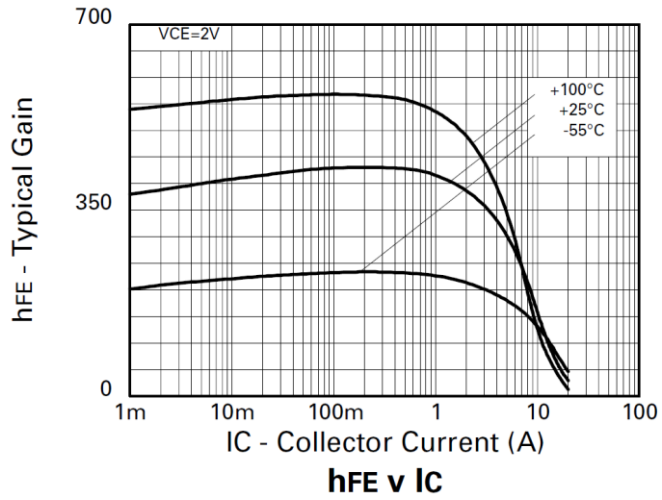

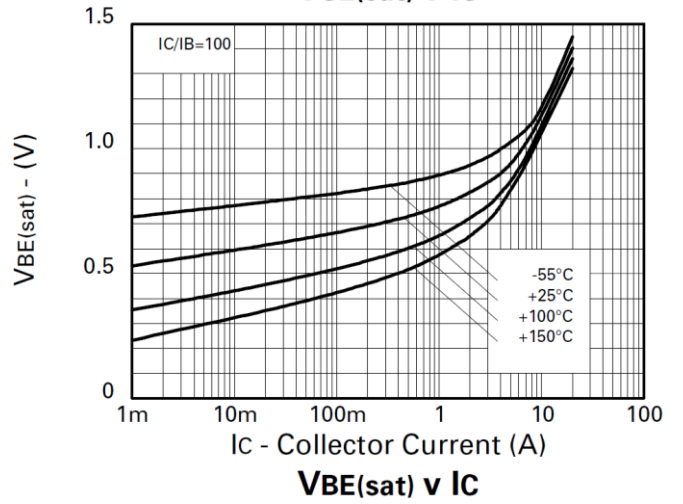
**V<sub>CE(sat)</sub> v I<sub>C</sub>**



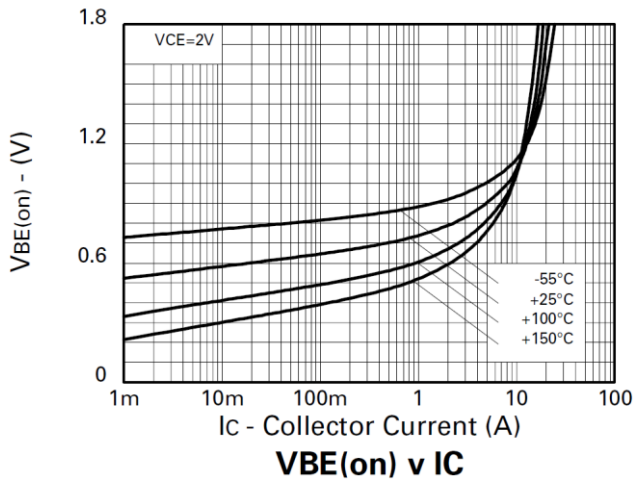
**V<sub>CE(sat)</sub> v I<sub>C</sub>**



**h<sub>FE</sub> v I<sub>C</sub>**



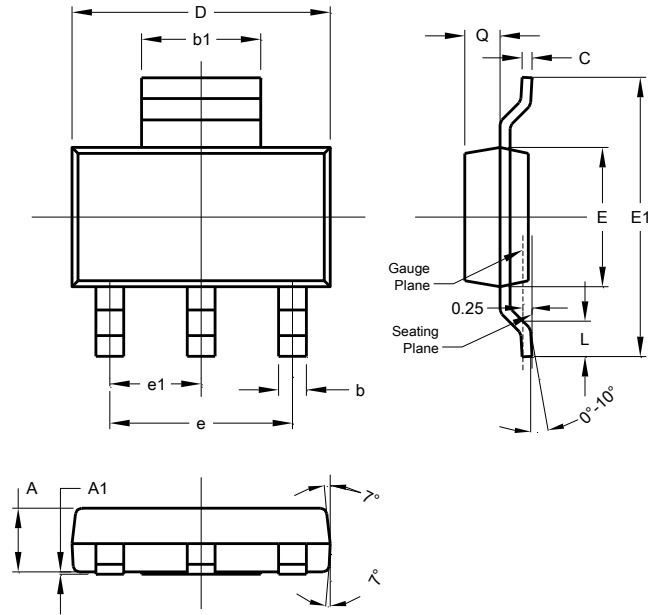

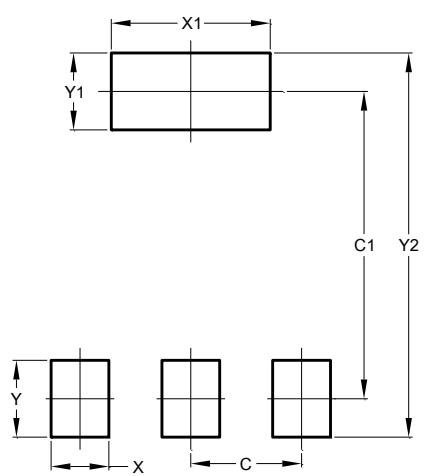
