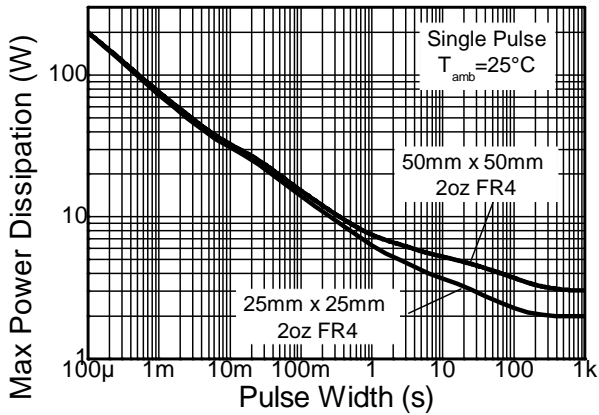
Thermal Characteristics and Derating Characteristics



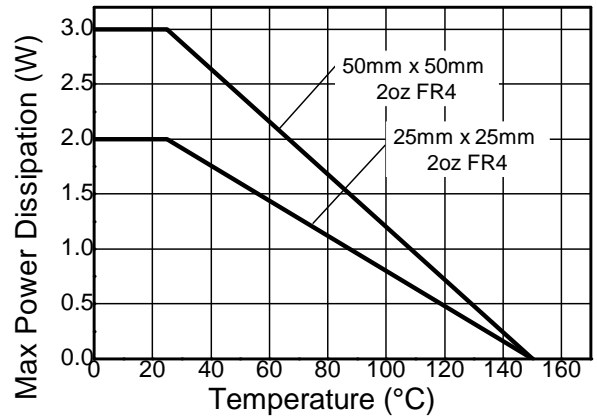
Transient Thermal Impedance

Pulse Power Dissipation



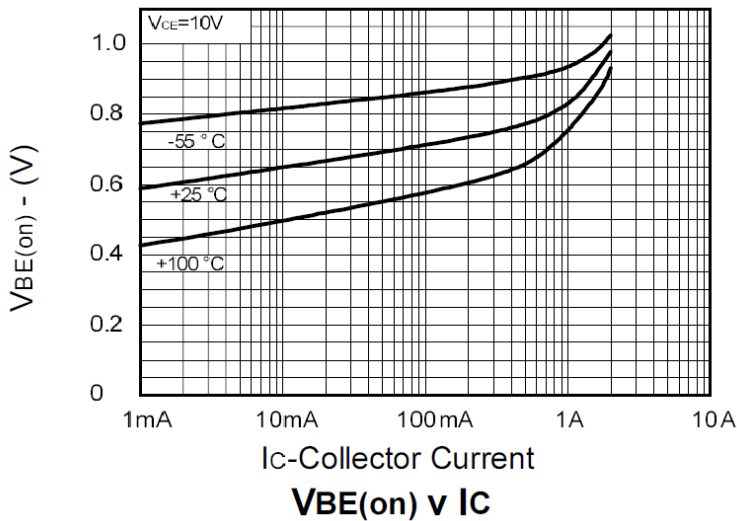
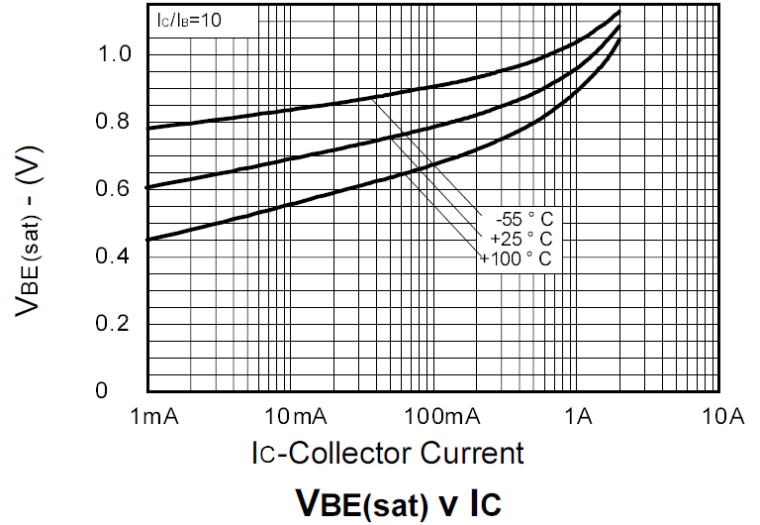
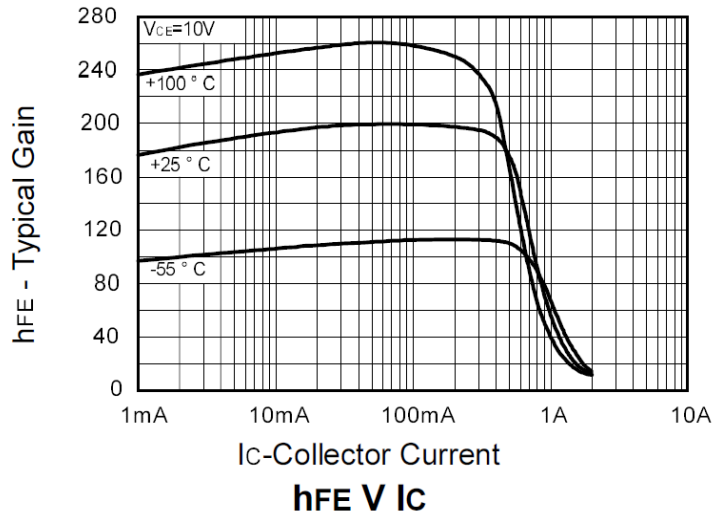
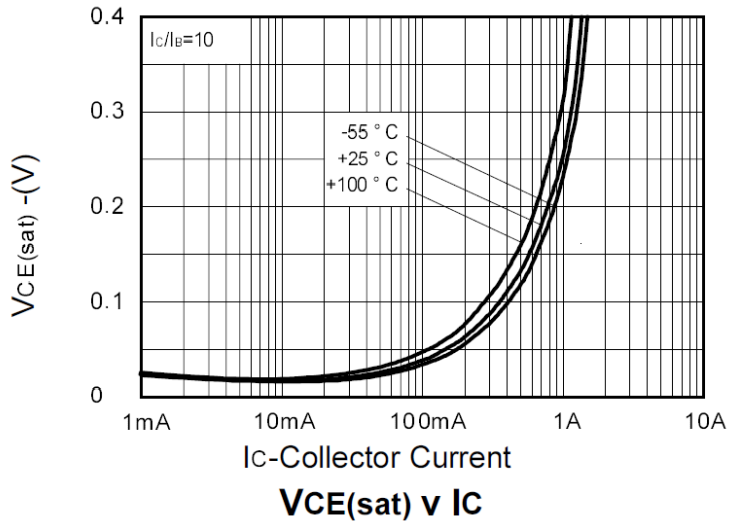
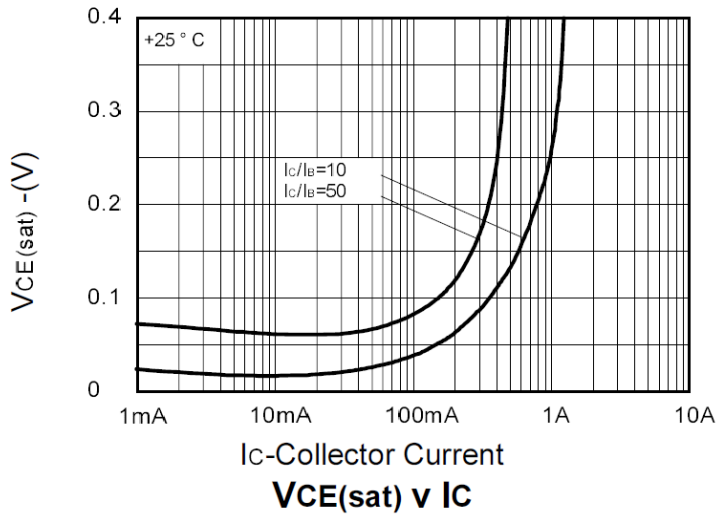

Package Outline Dimensions

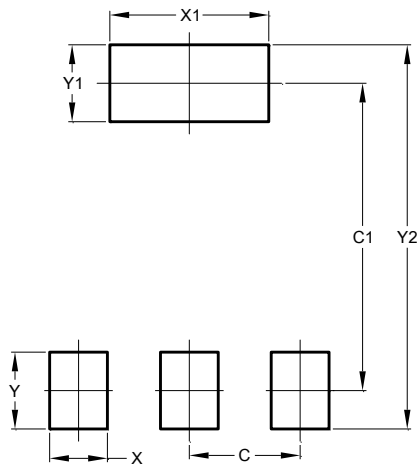
