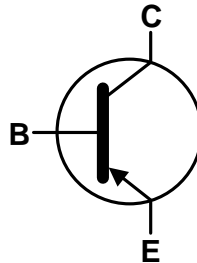

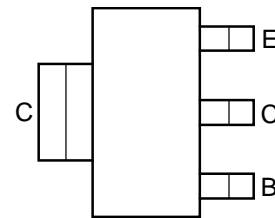

Device Symbol



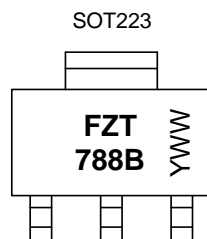
Top View

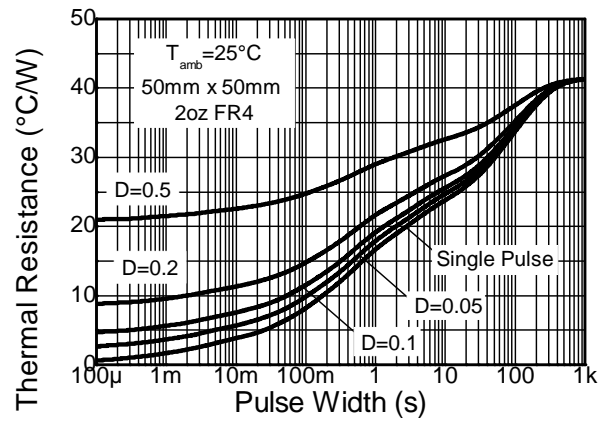

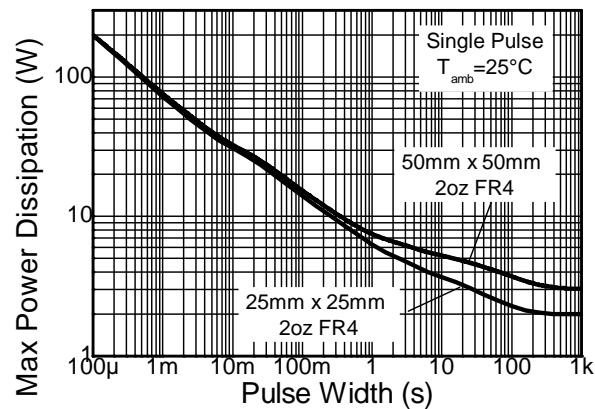
**Safe Operating Area**



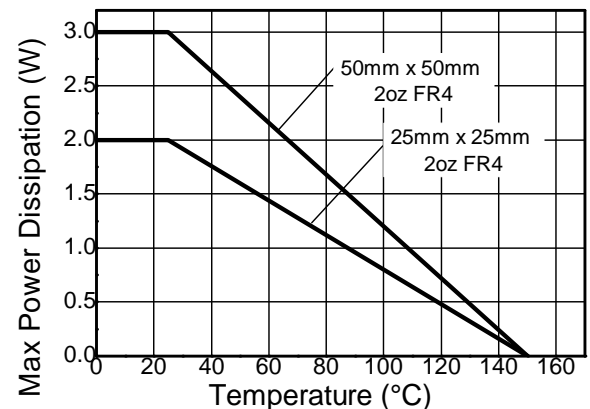
**Transient Thermal Impedance**

**Pulse Power Dissipation**



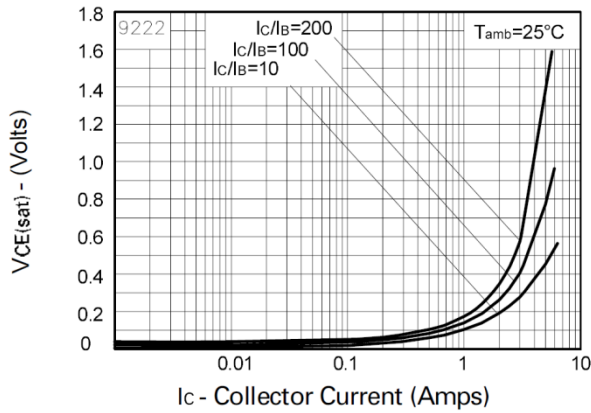
**Derating Curve**

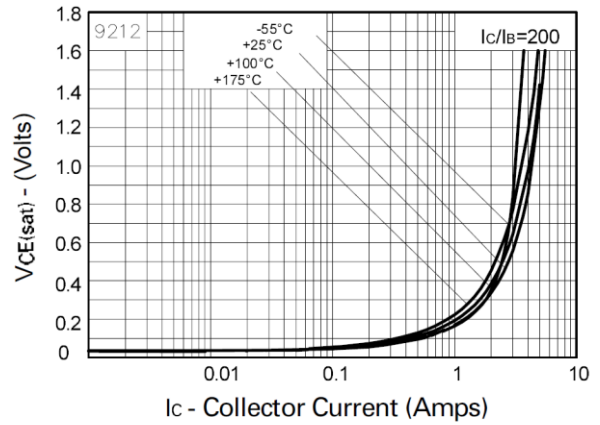

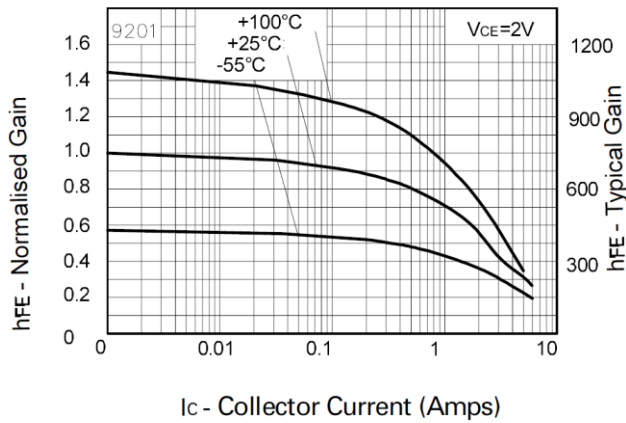

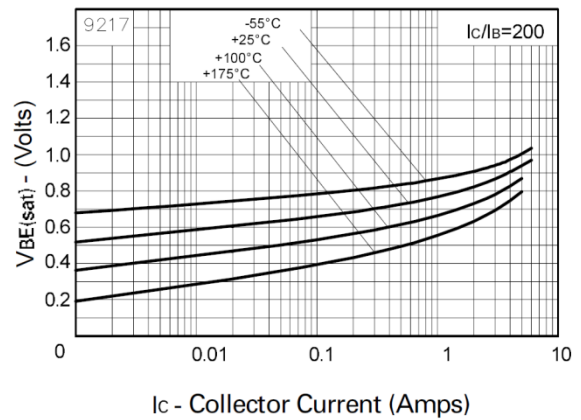
**VCE(sat) v IC**



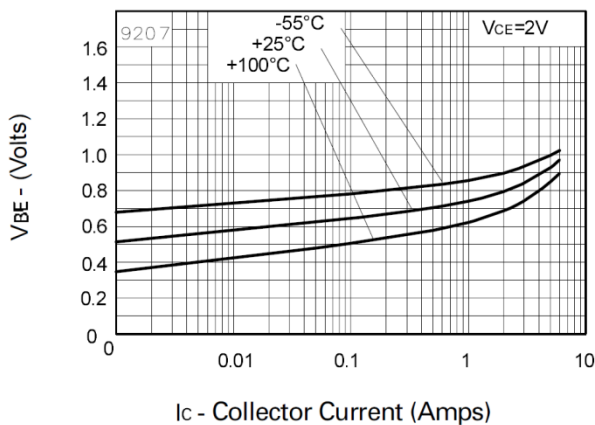
**VCE(sat) v IC**



**hFE v IC**



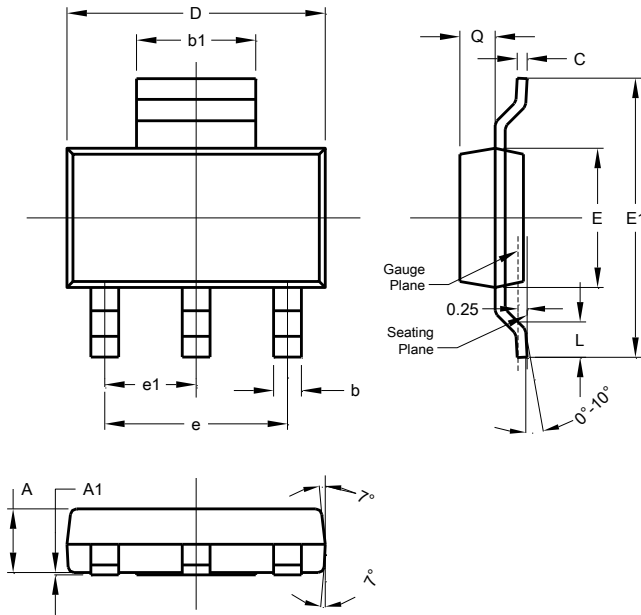
**VBE(sat) v IC**

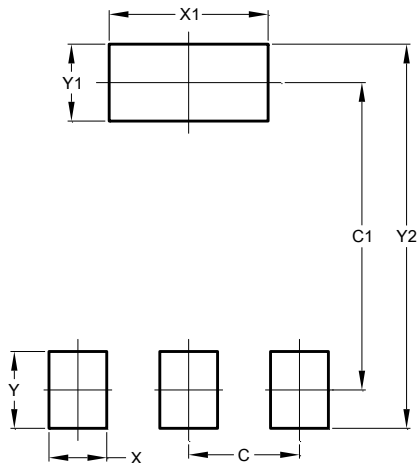
