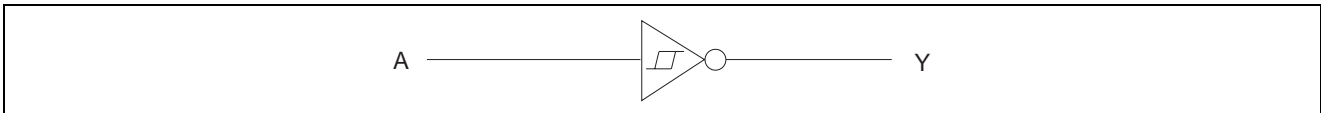

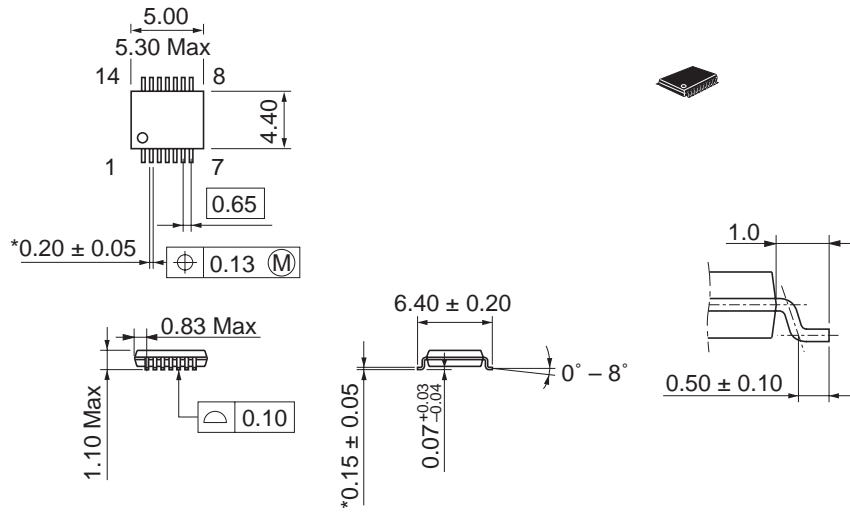
Test Circuit
