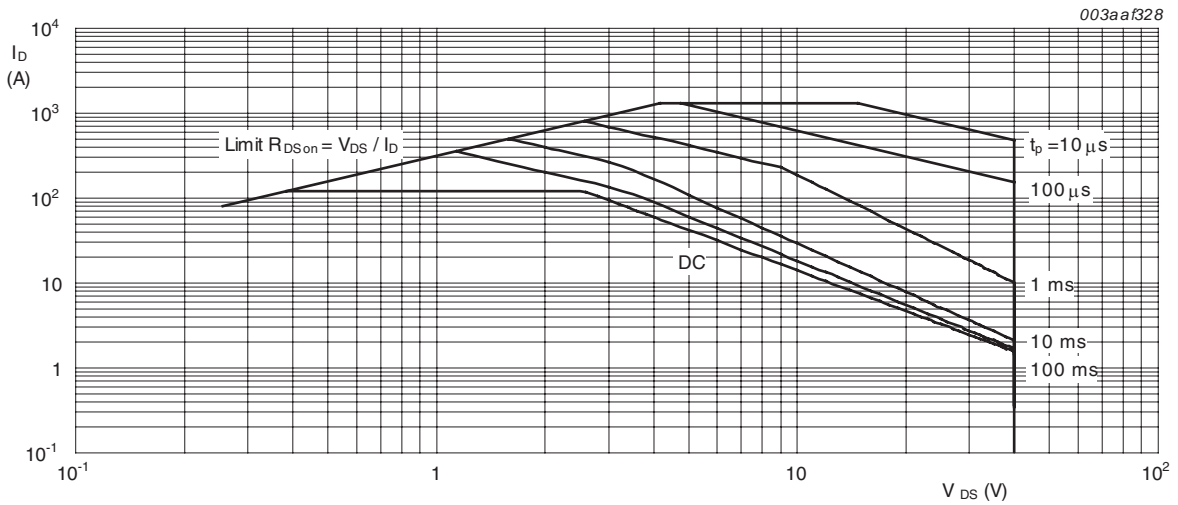

Fig 2. Normalized total power dissipation as a function of mounting base temperature



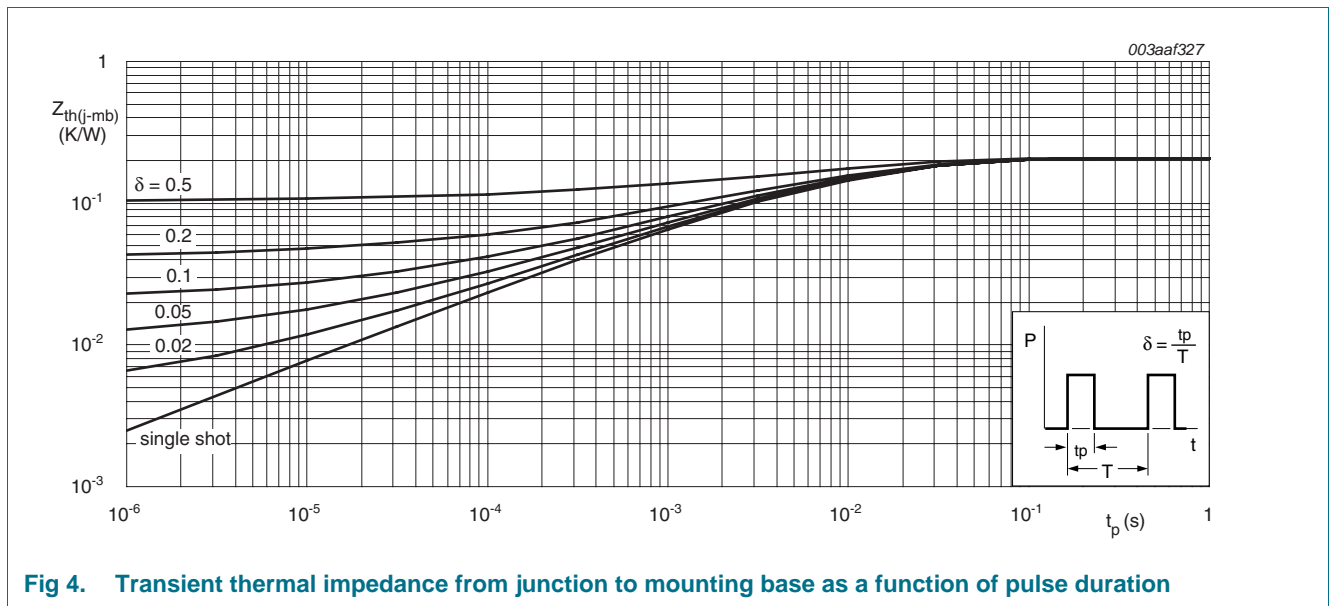

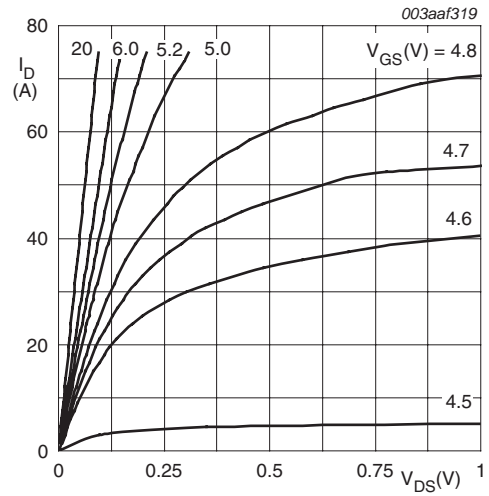

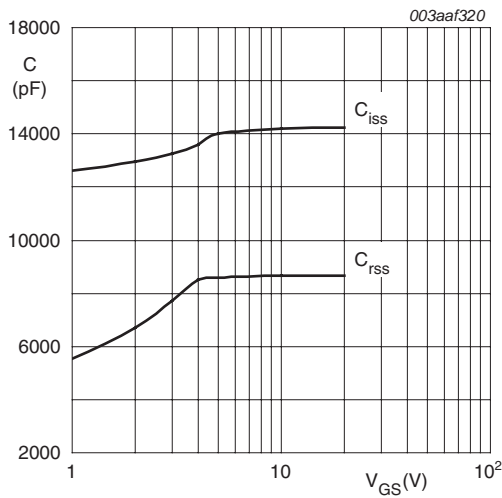

Fig 7. Drain-source on-state resistance as a function of gate-source voltage; typical values.



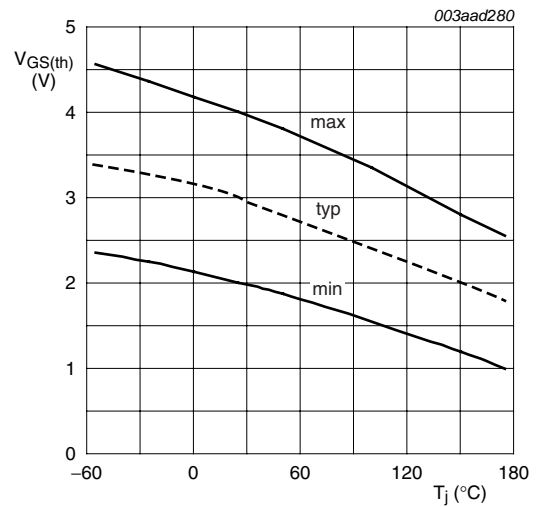

Fig 10. Gate-source threshold voltage as a function of junction temperature

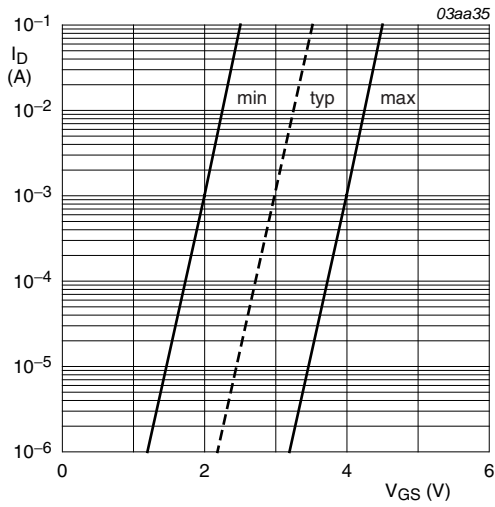


Fig 11. Sub-threshold drain current as a function of gate-source voltage

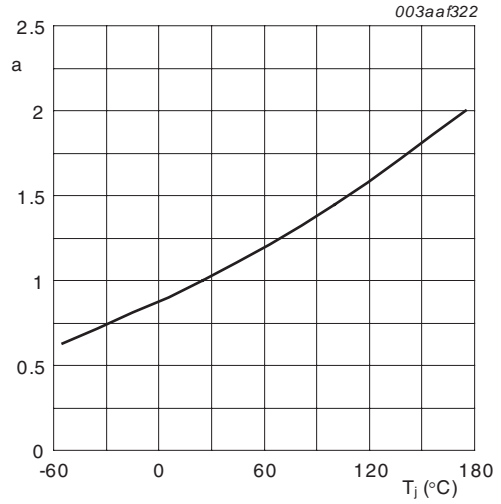


Fig 12. Normalized drain-source on state resistance factor as a function of junction temperature

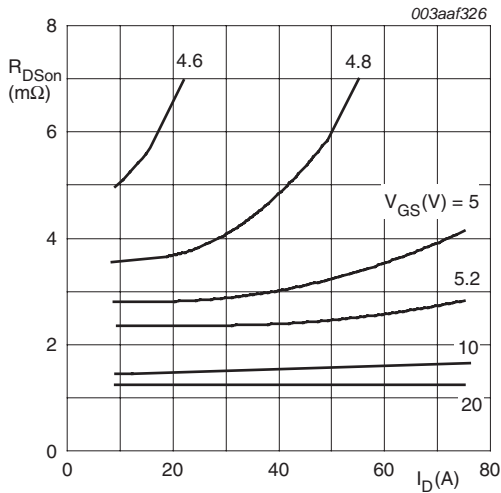


Fig 13. Drain-source on-state resistance as a function of drain current; typical values

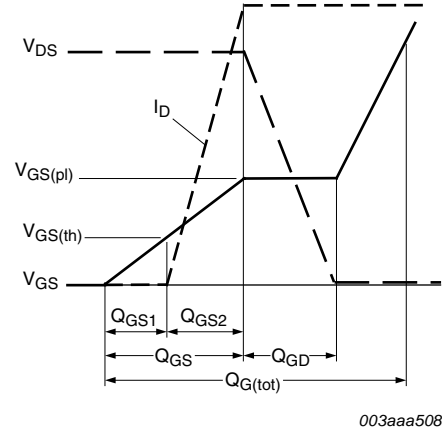
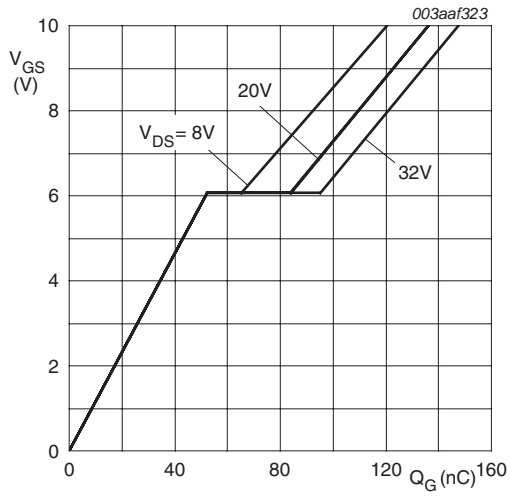
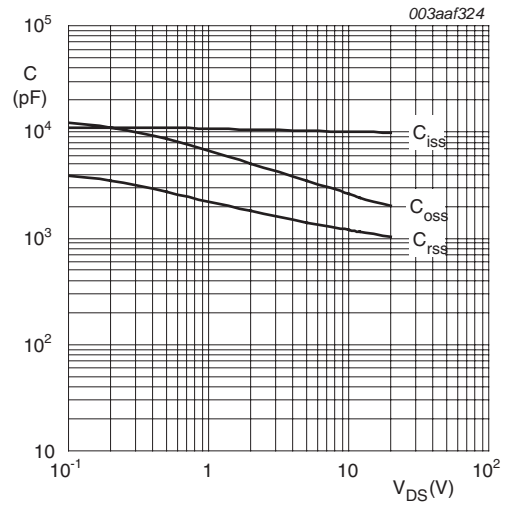


Fig 14. Gate charge waveform definitions



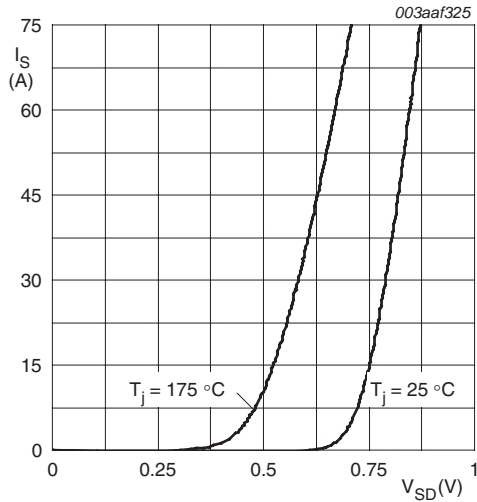

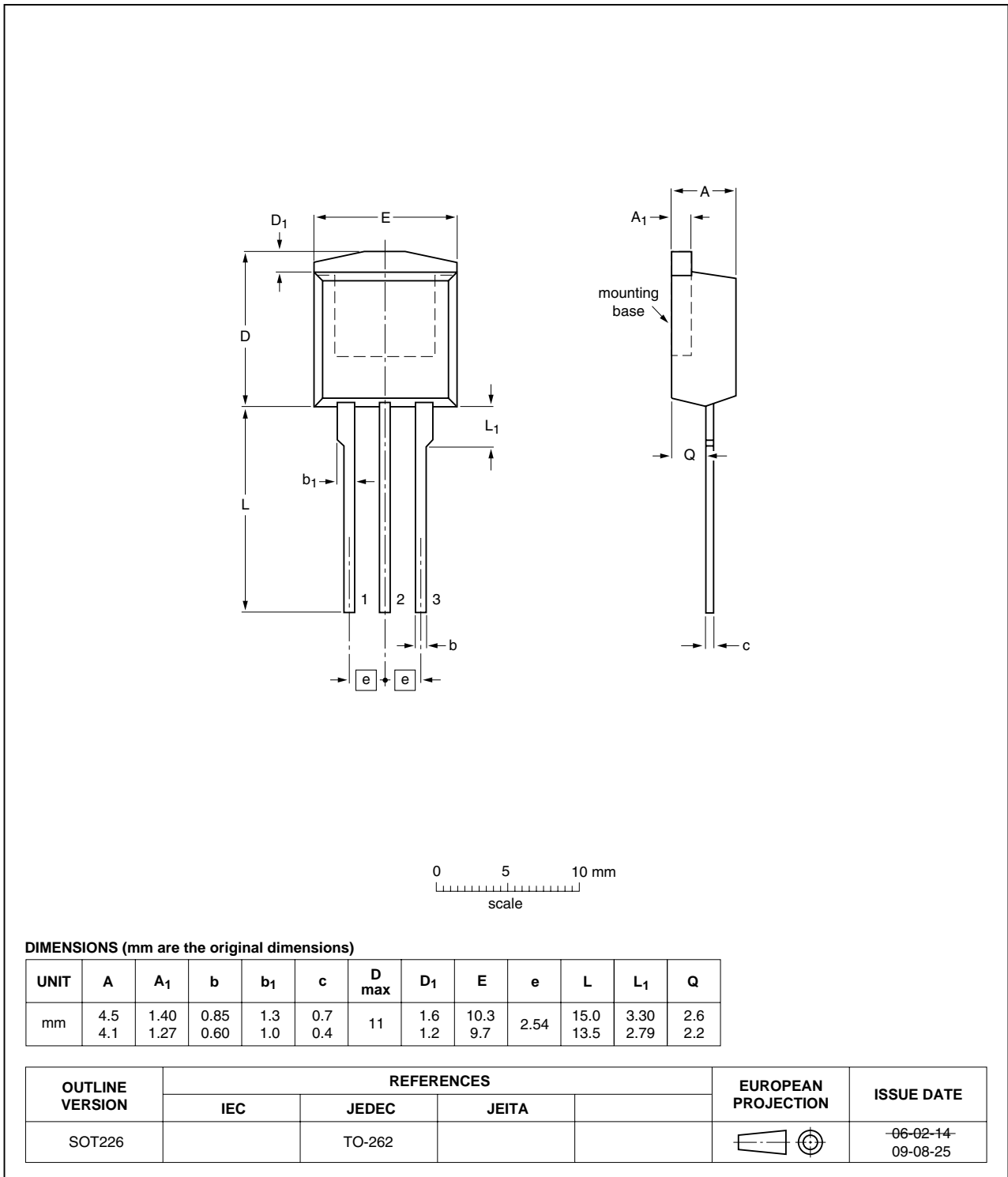


Fig 18. Package outline SOT226 (I2PAK)
