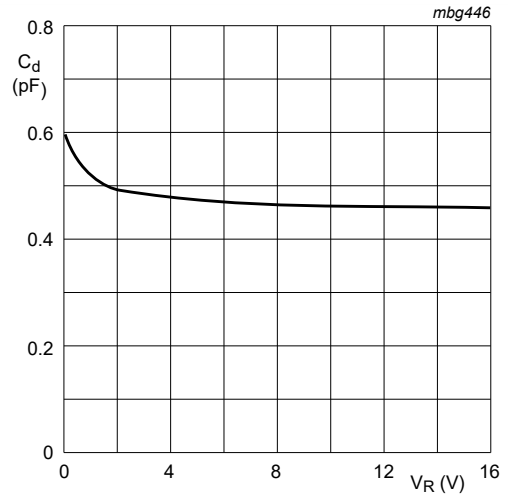

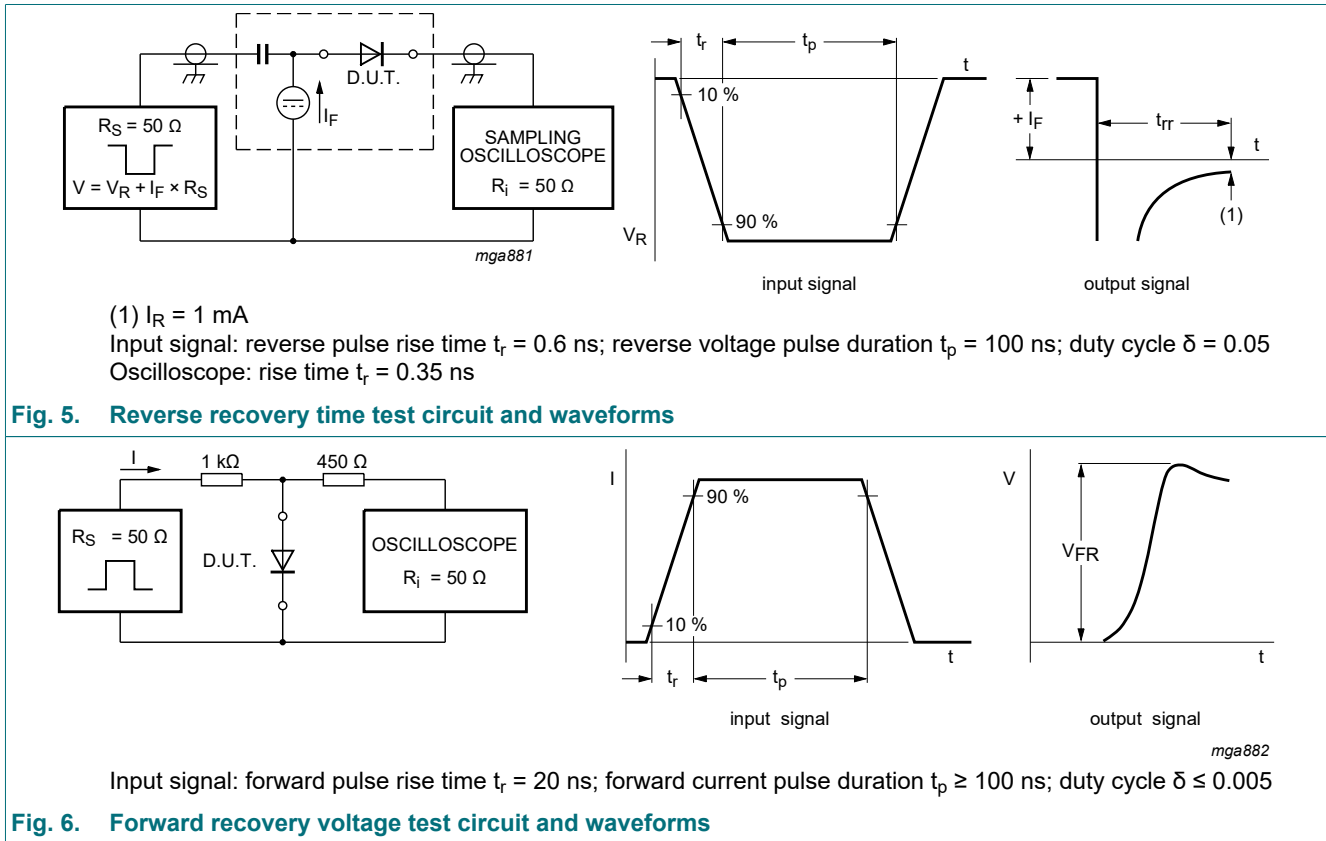
**Fig. 3. Reverse current as a function of reverse voltage; typical values**

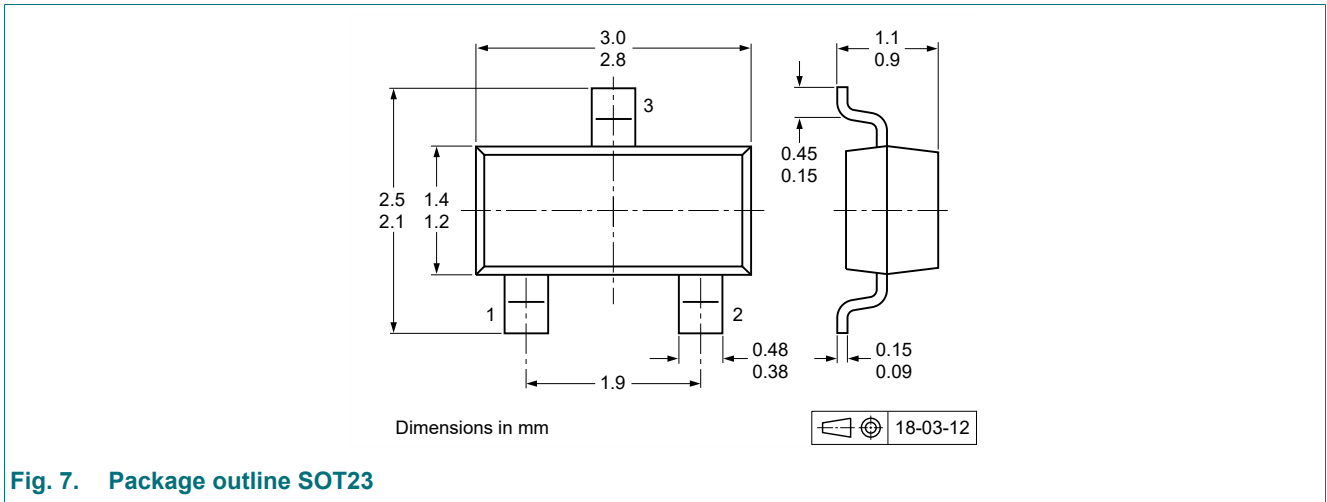


Fig. 7. Package outline SOT23

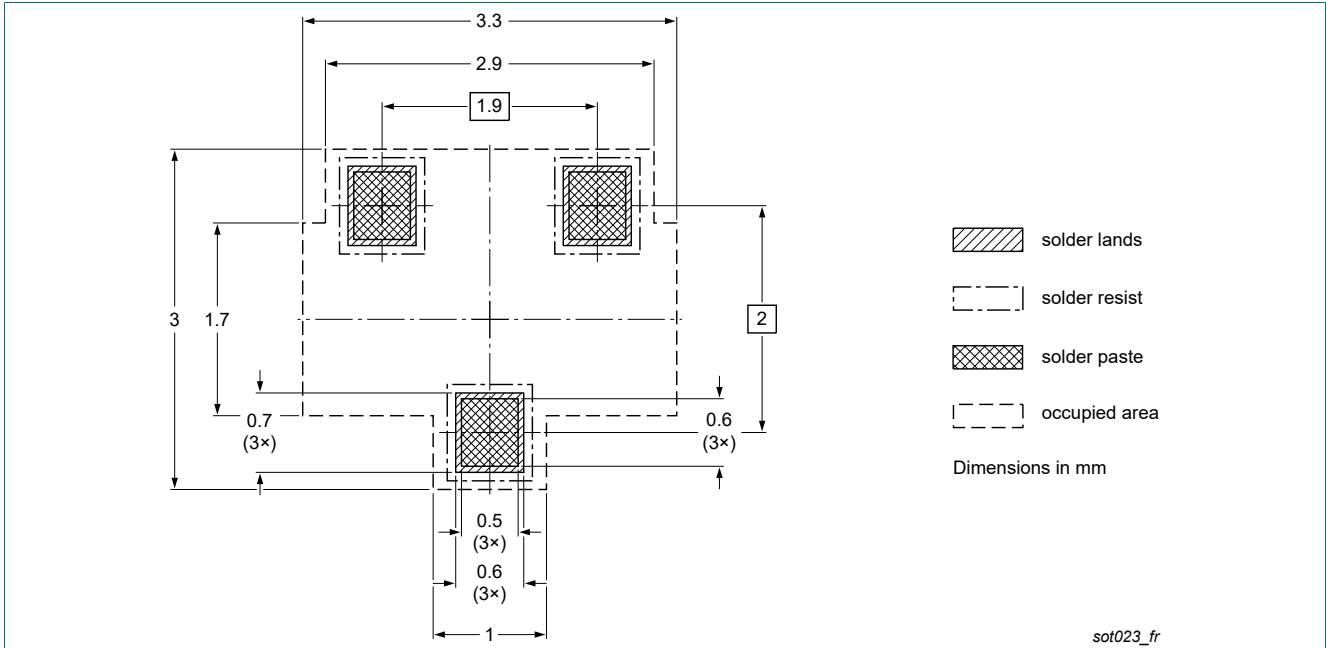


Fig. 8. Reflow soldering footprint for SOT23

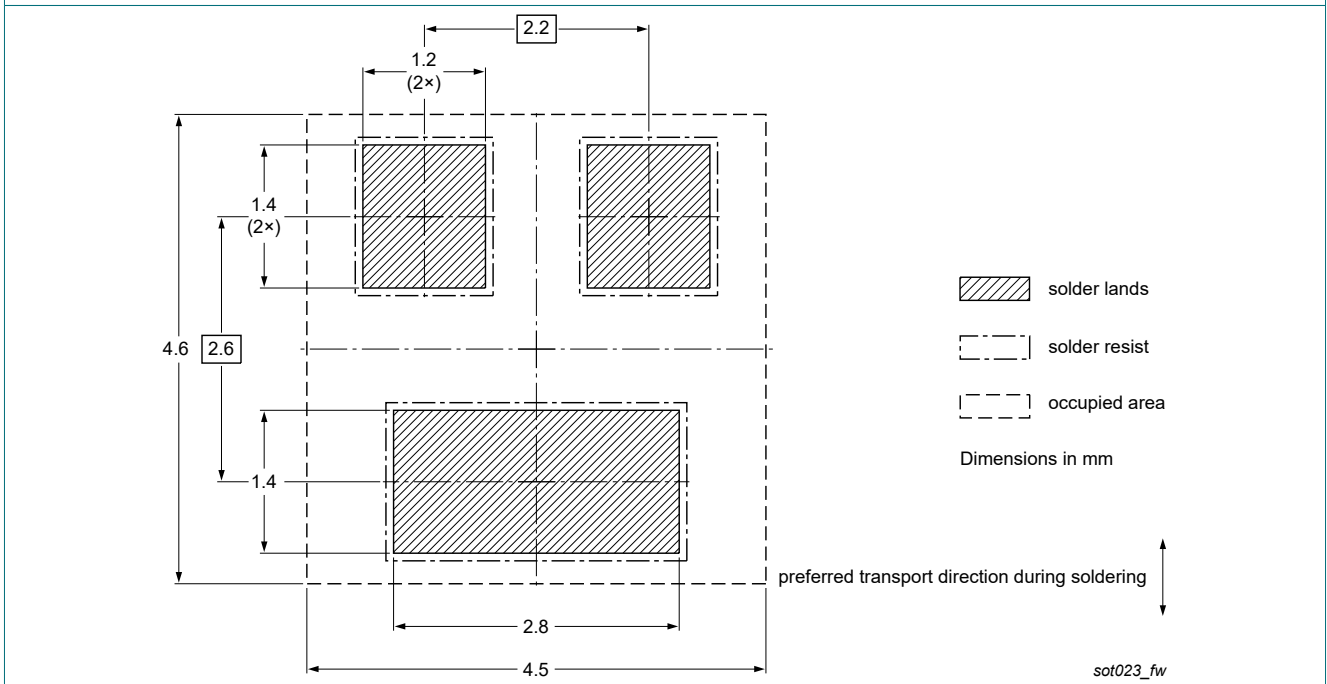


Fig. 9. Wave soldering footprint for SOT23
