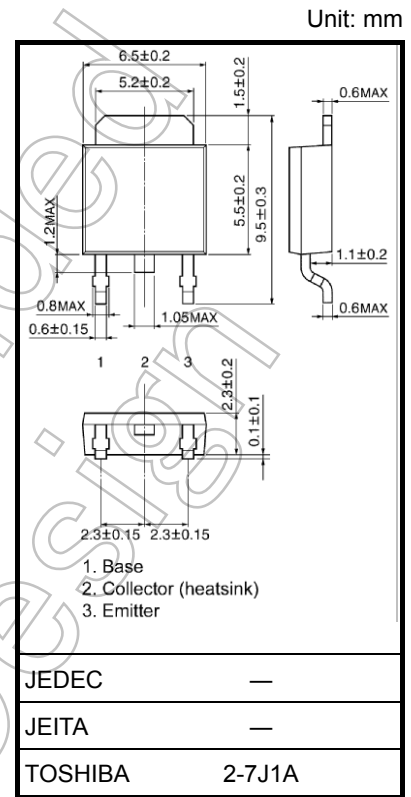

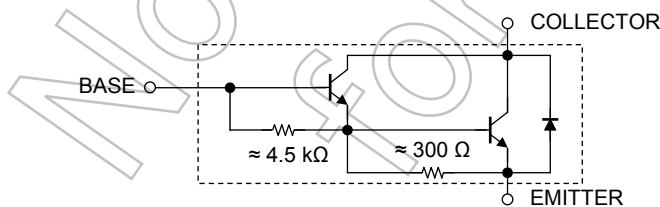

Equivalent Circuit

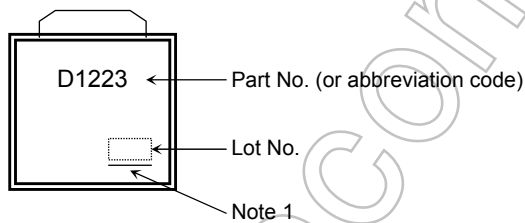
