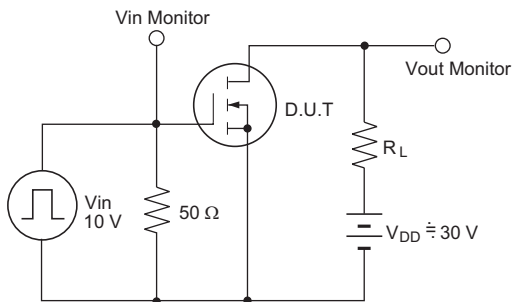




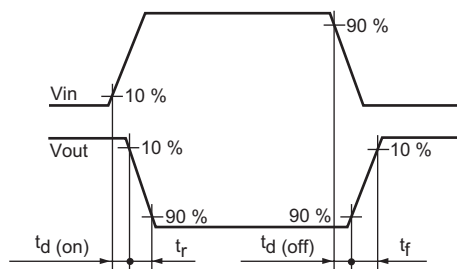
Reverse Drain Current vs. Source to Drain Voltage



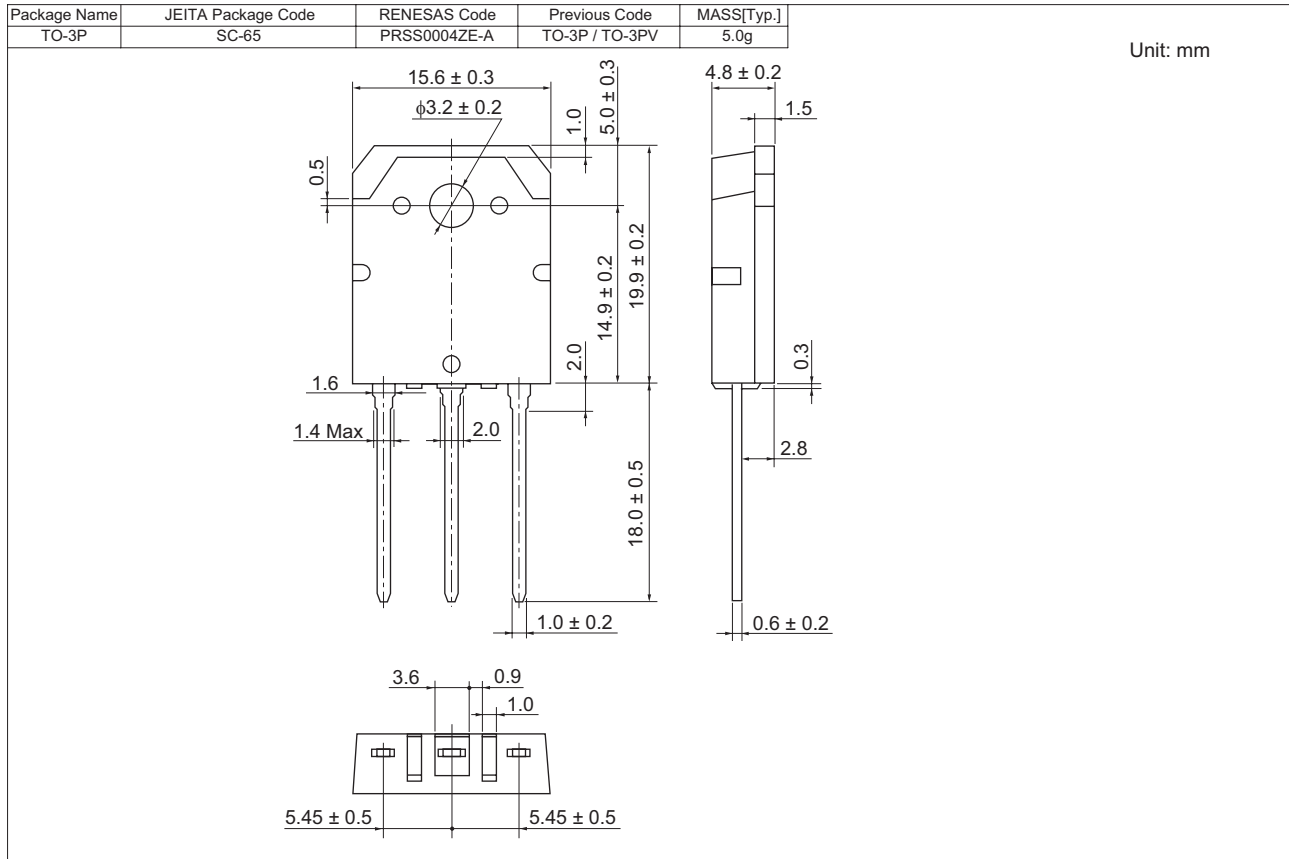
Switching Time Test Circuit
