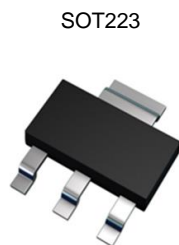

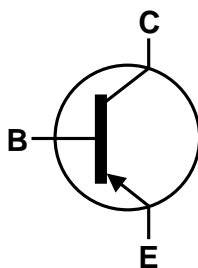

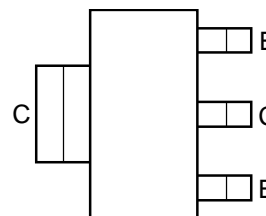

Device Symbol



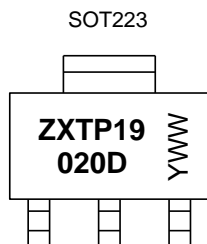
