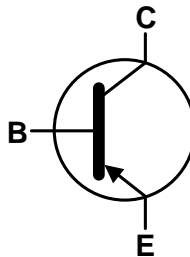

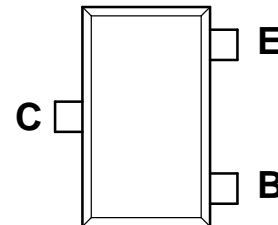

Pin Configuration

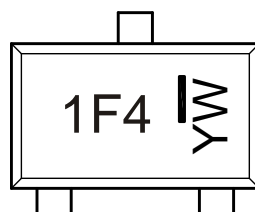

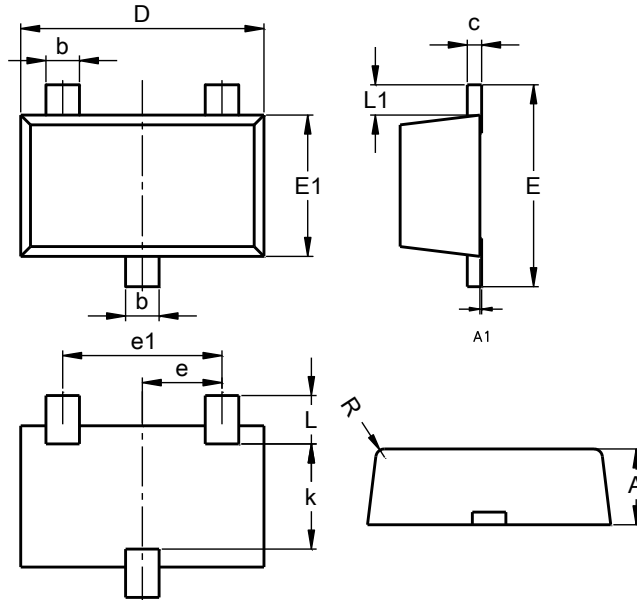
