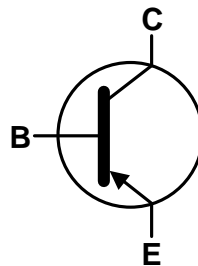

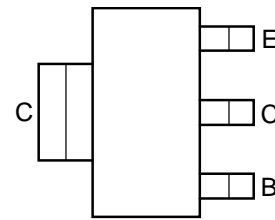

Device Symbol



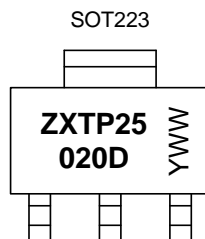
Top View

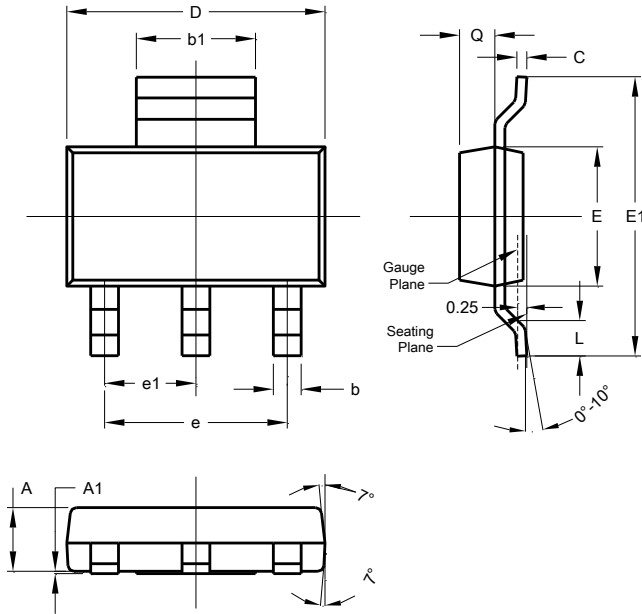

Package Outline Dimensions

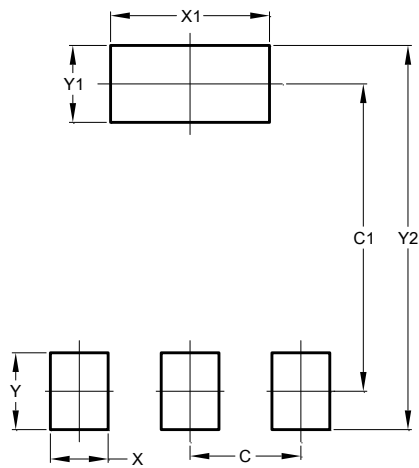
