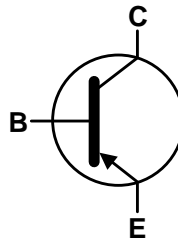

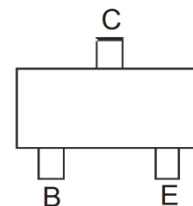

Device Symbol



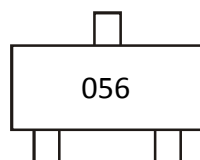

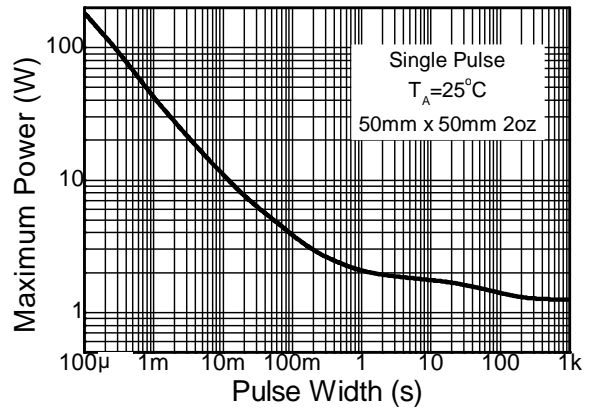
**Safe Operating Area**

**Transient Thermal Impedance**



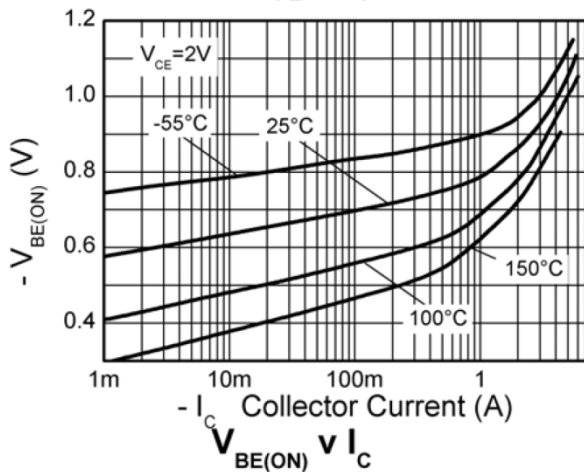
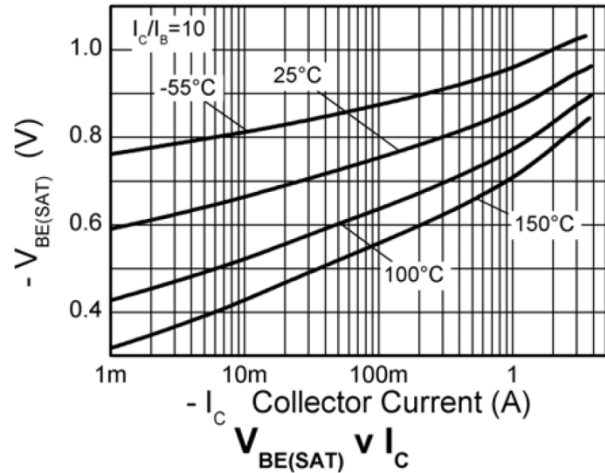
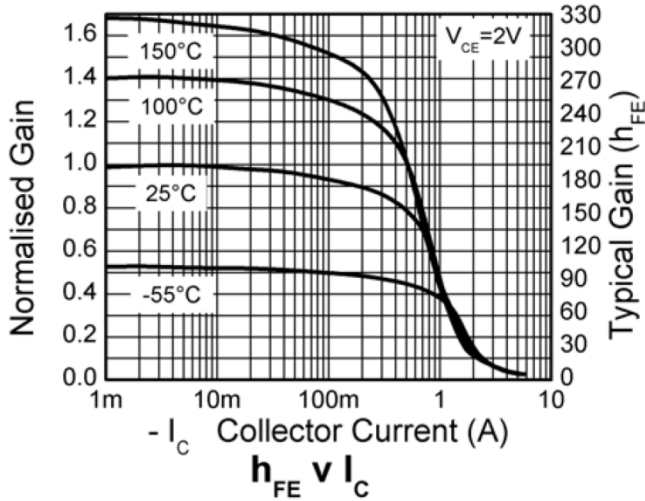
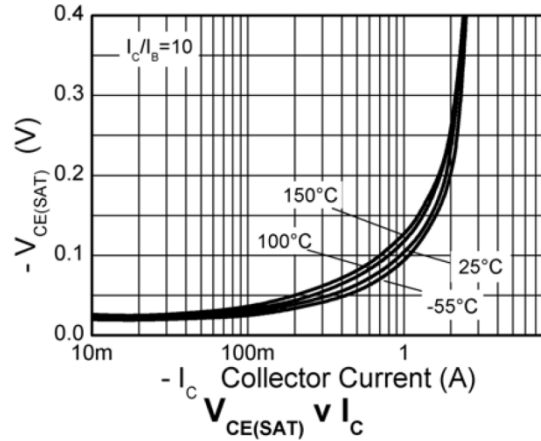
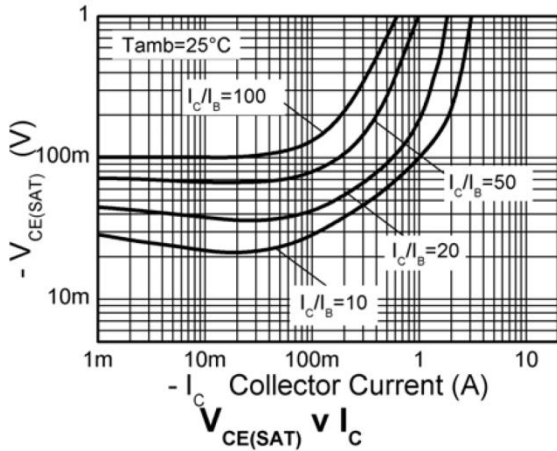
