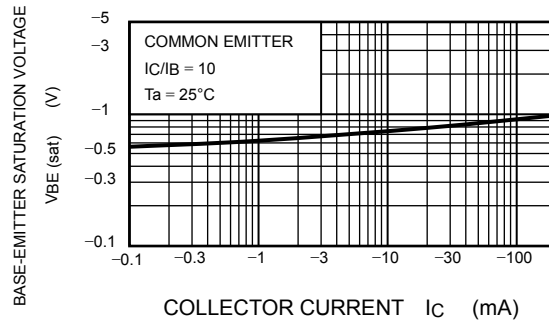
$I_B - V_{BE}$



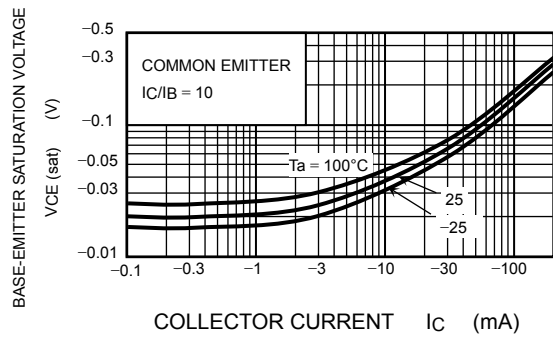
$h_{FE} - I_C$



$V_{BE(sat)} - I_C$

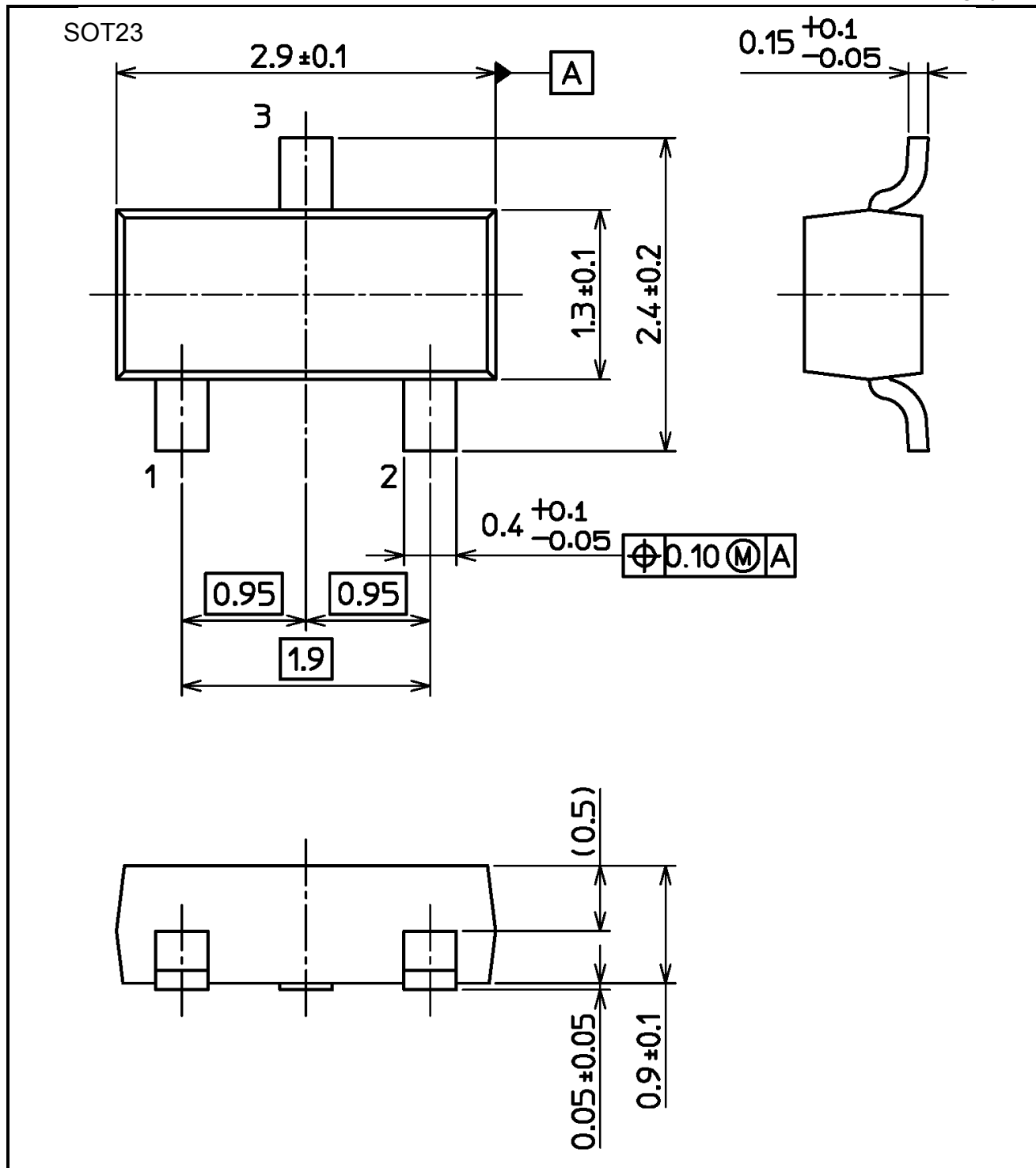


$V_{CE(sat)} - I_C$
