## 1. General description

The 74HC1G04; 74HCT1G04 is a single inverter. Inputs include clamp diodes that enable the use of current limiting resistors to interface inputs to voltages in excess of  $V_{CC}$ .

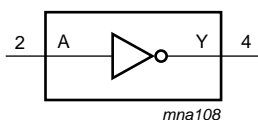


Fig 1. Logic symbol

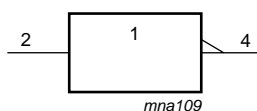


Fig 2. IEC logic symbol

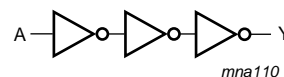


Fig 3. Logic diagram

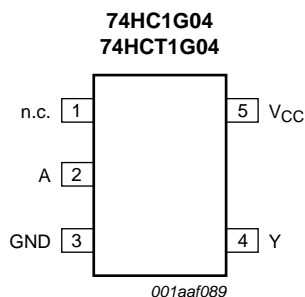


Fig 4. Pin configuration

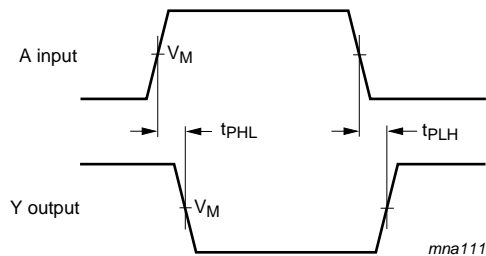

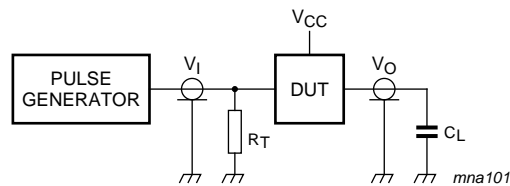

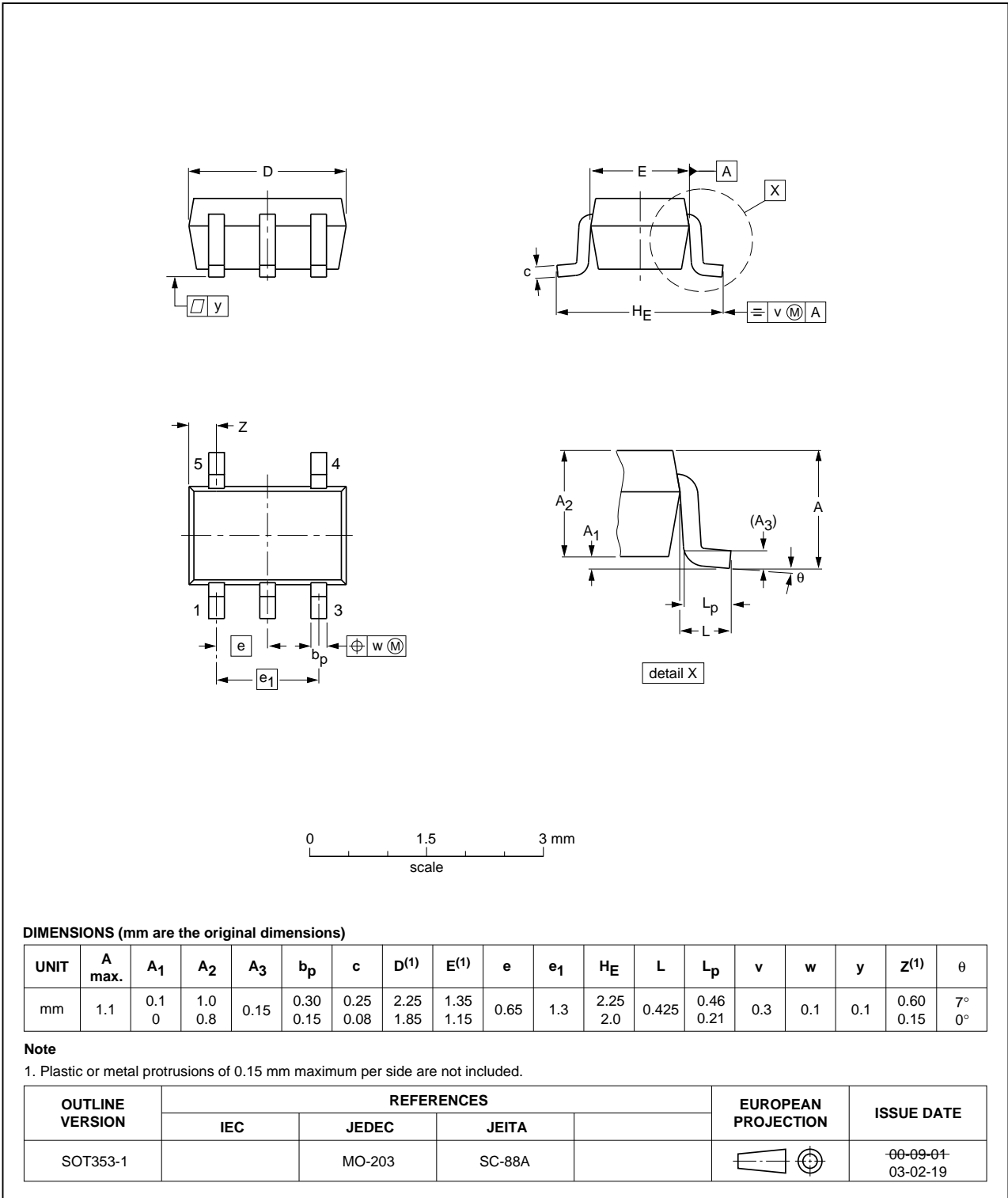


Fig 7. Package outline SOT353-1 (TSSOP5)

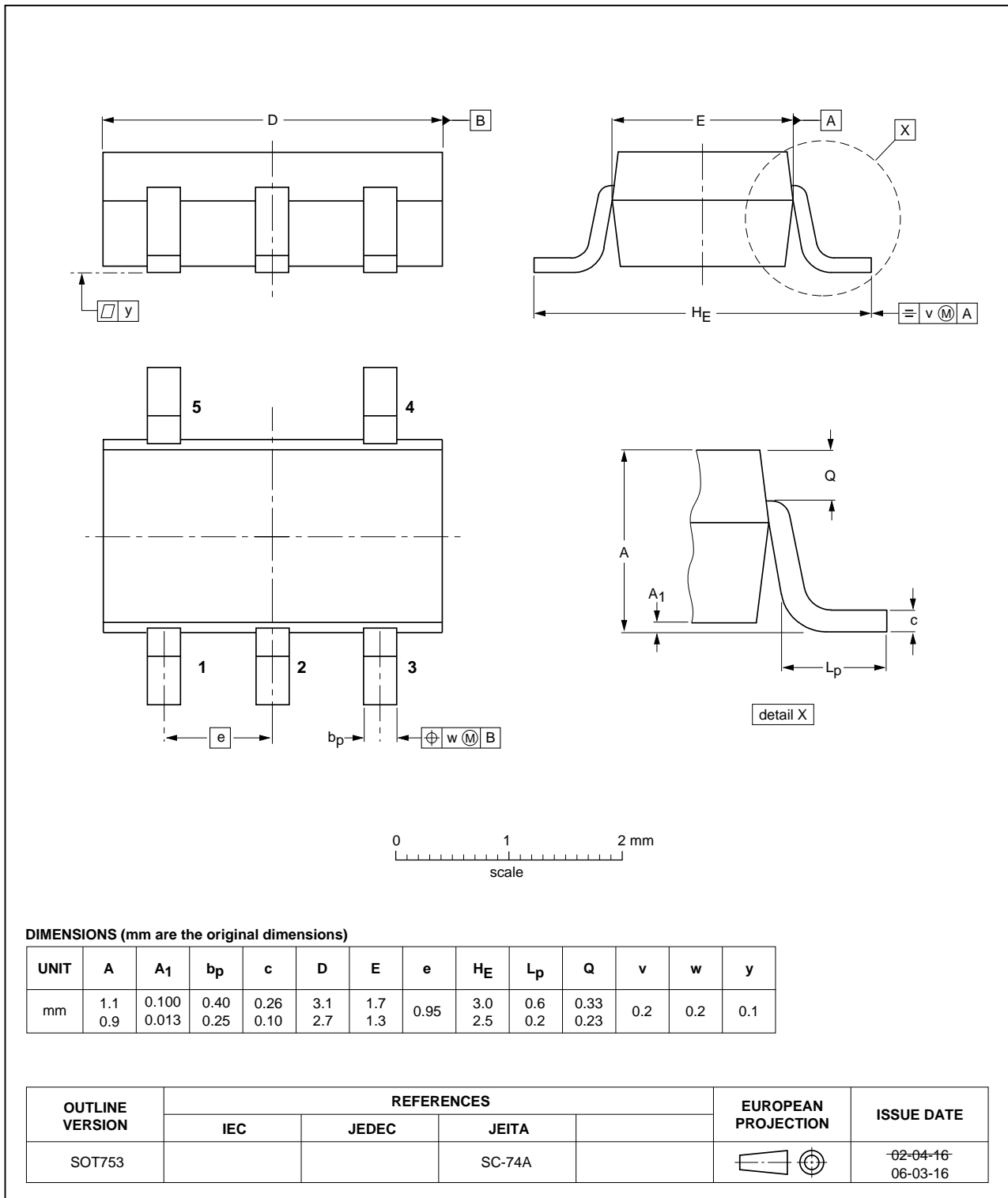


Fig 8. Package outline SOT753 (SC-74A)
