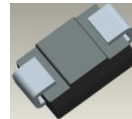

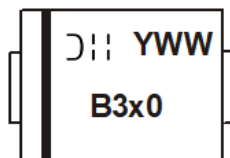

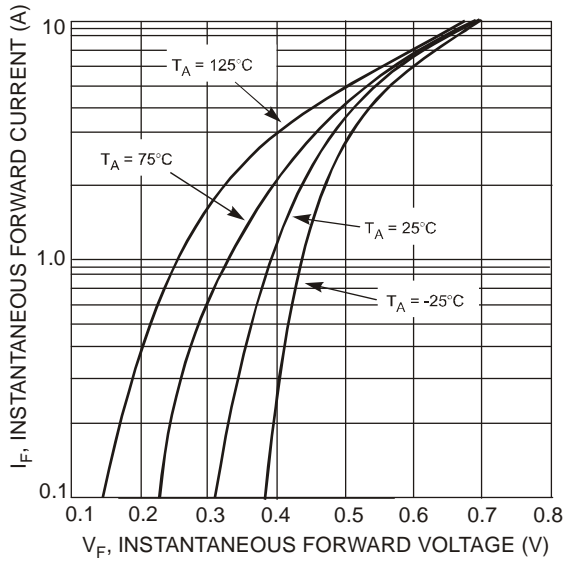


Fig. 1 Typical Forward Characteristics, B320B-B340B

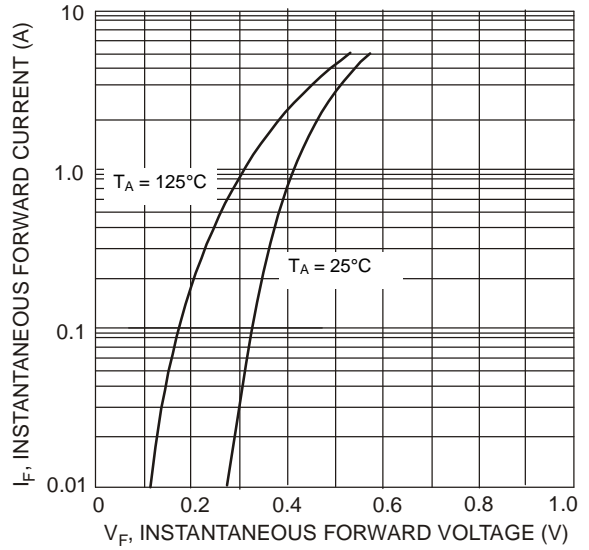


Fig. 2 Typical Forward Characteristics, B350B-B360B

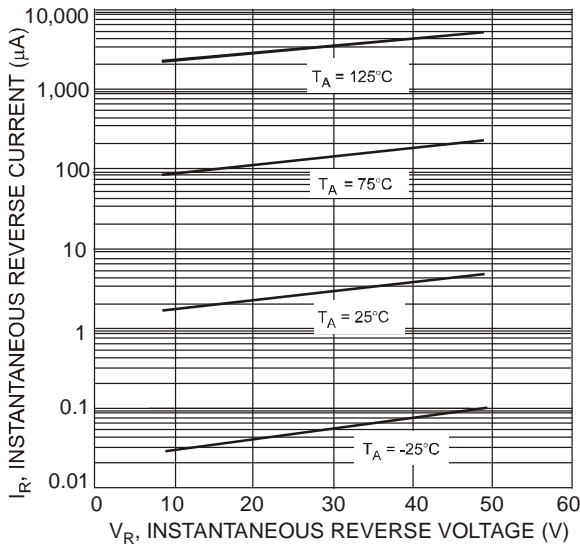


Fig. 3 Typical Reverse Characteristics, B320B-B340B

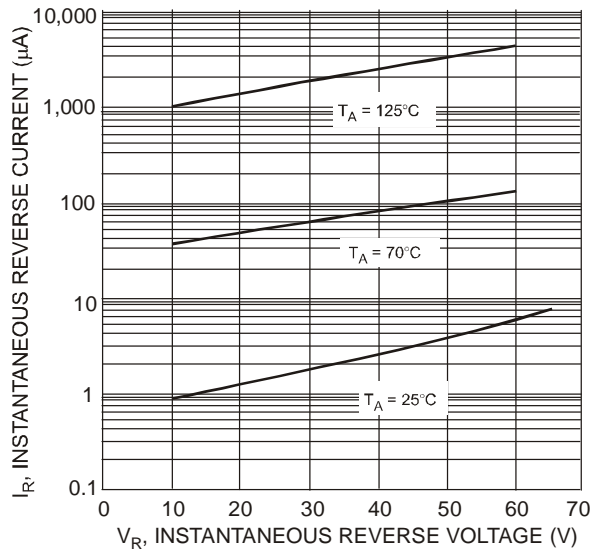


Fig. 4 Typical Reverse Characteristics, B350B-B360B

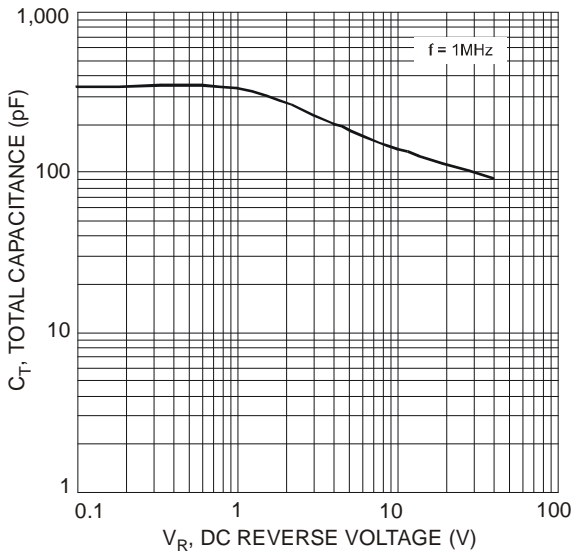


Fig. 5 Total Capacitance vs. Reverse Voltage

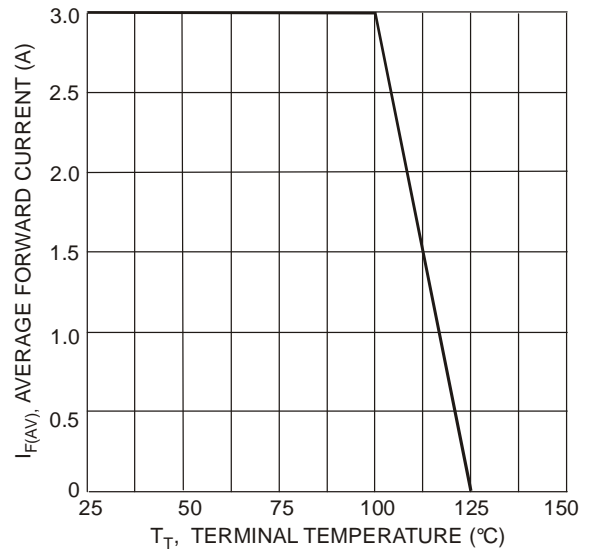


Fig. 6 Forward Current Derating Curve

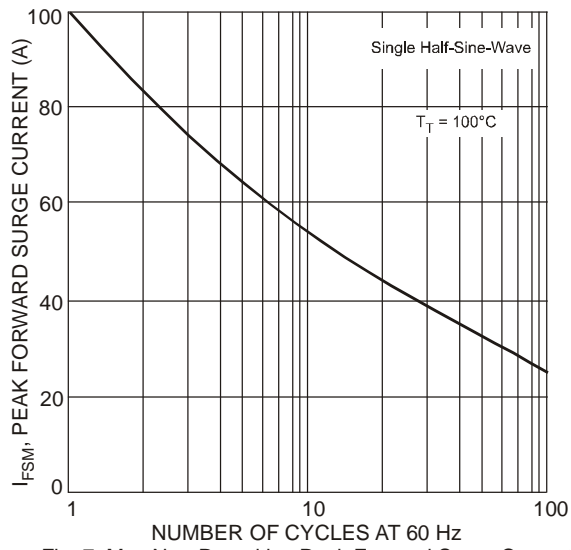
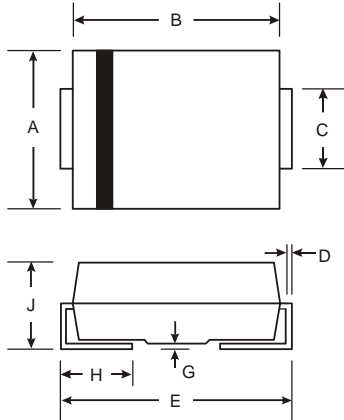


Fig. 7 Max Non-Repetitive Peak Forward Surge Current

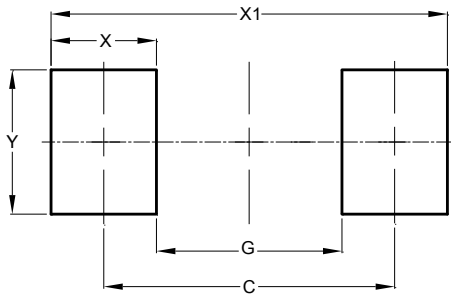
