## 1 General description

---

The 74LVC2G86 provides a dual 2-input EXCLUSIVE-OR gate.

Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in a mixed 3.3 V and 5 V environment.

This device is fully specified for partial power-down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.

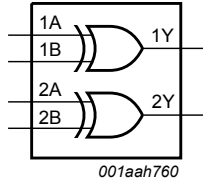


Figure 1. Logic symbol

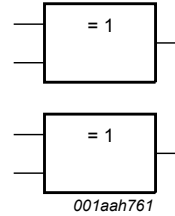


Figure 2. IEC logic symbol

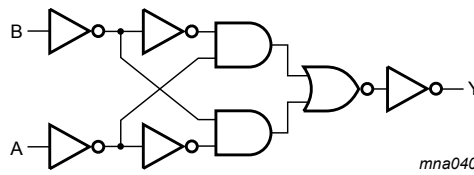


Figure 3. Logic diagram (one driver)

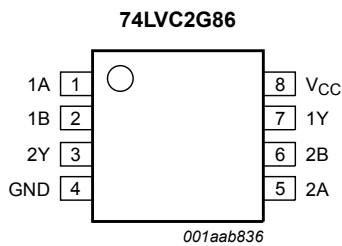


Figure 4. Pin configuration SOT505-2 and SOT765-1

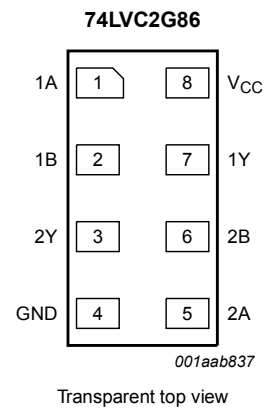


Figure 5. Pin configuration SOT833-1, SOT1089, SOT1116 and SOT1203

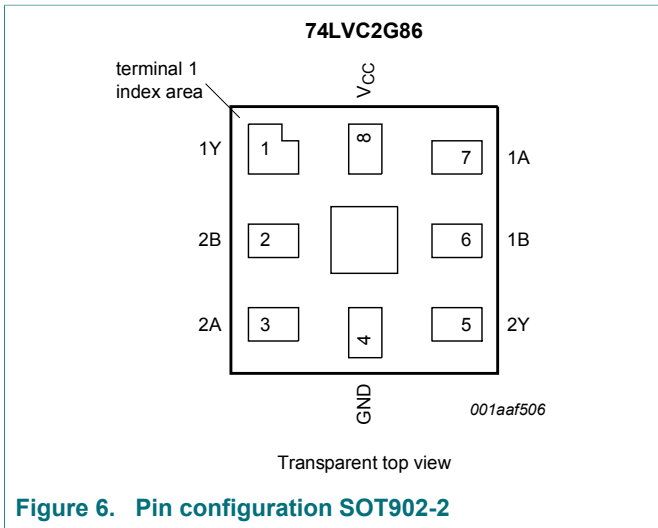


Figure 6. Pin configuration SOT902-2

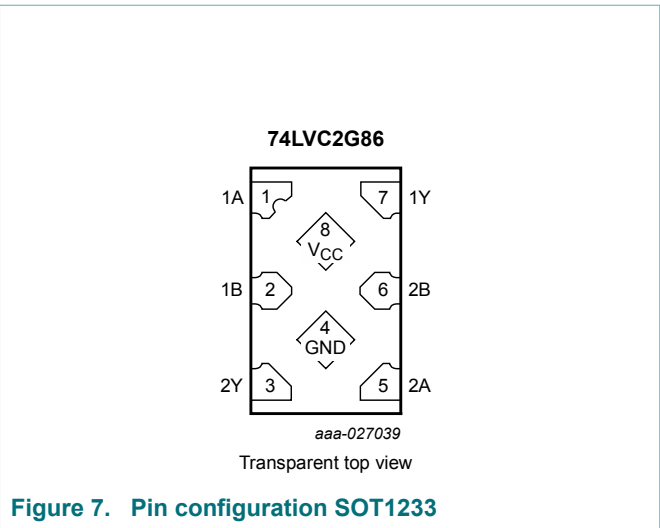


Figure 7. Pin configuration SOT1233

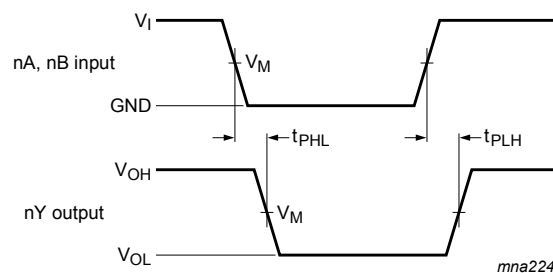

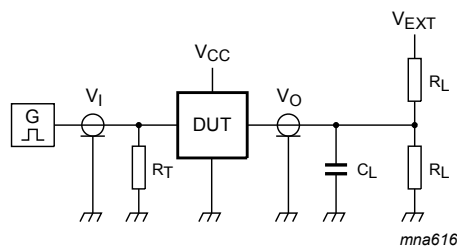

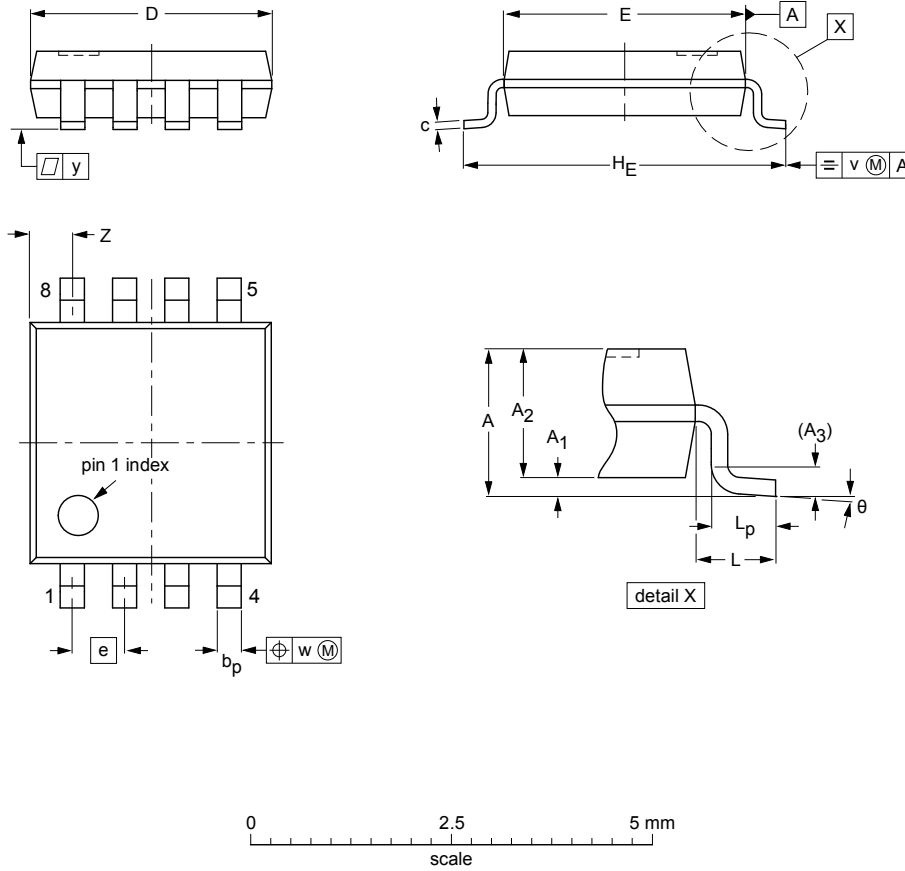
**Figure 9. Test circuit for measuring switching times**

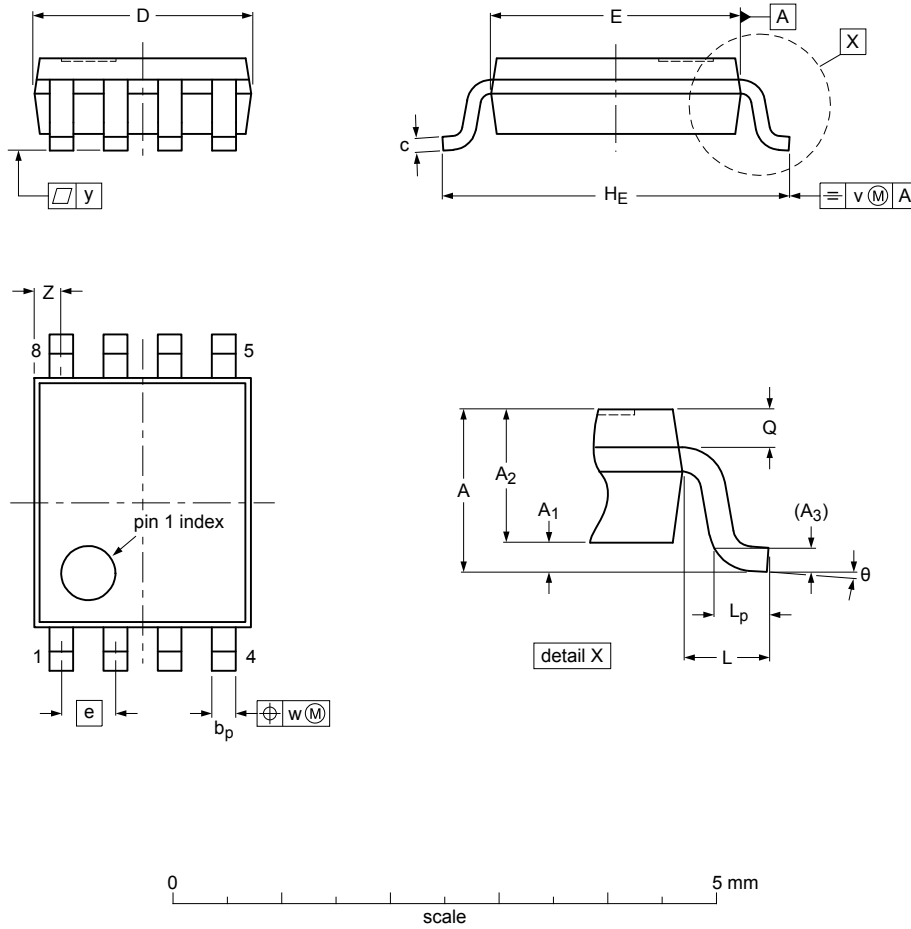

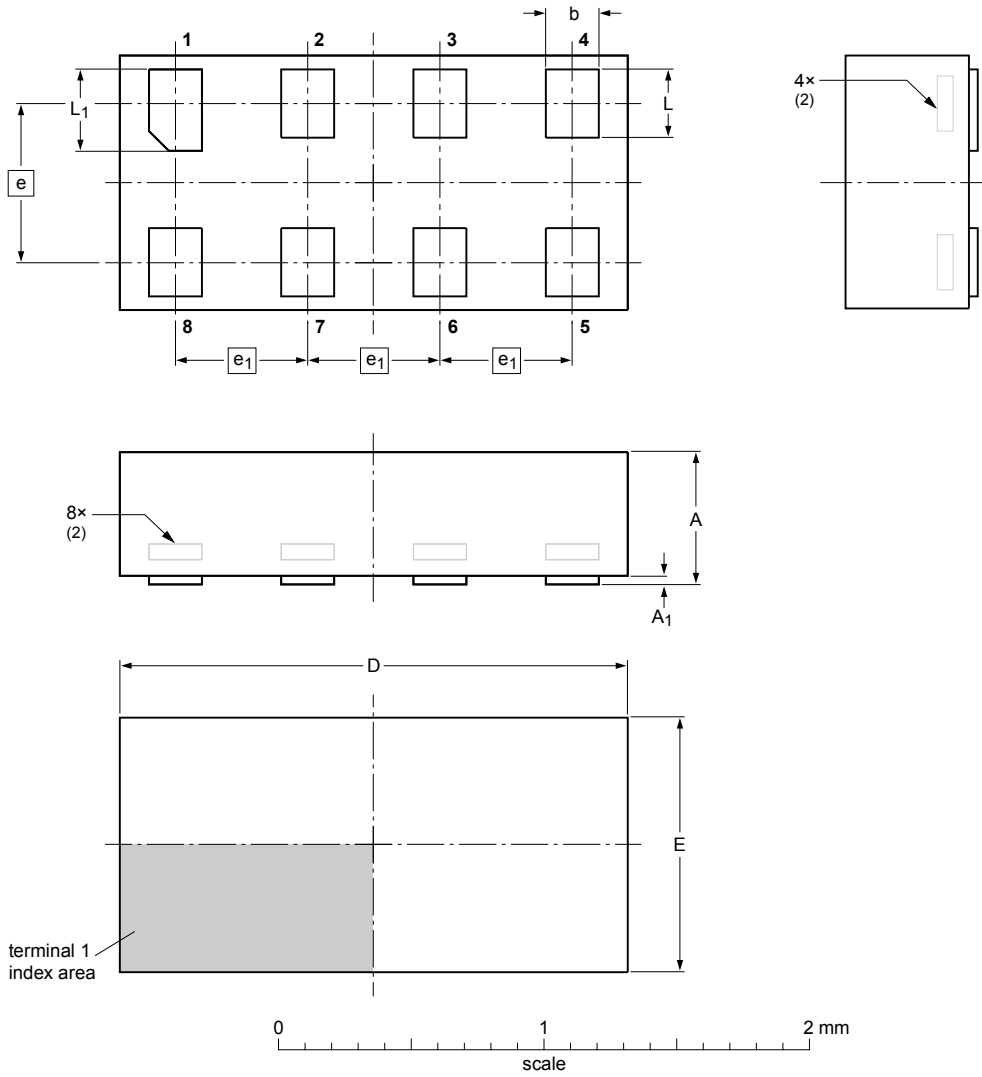

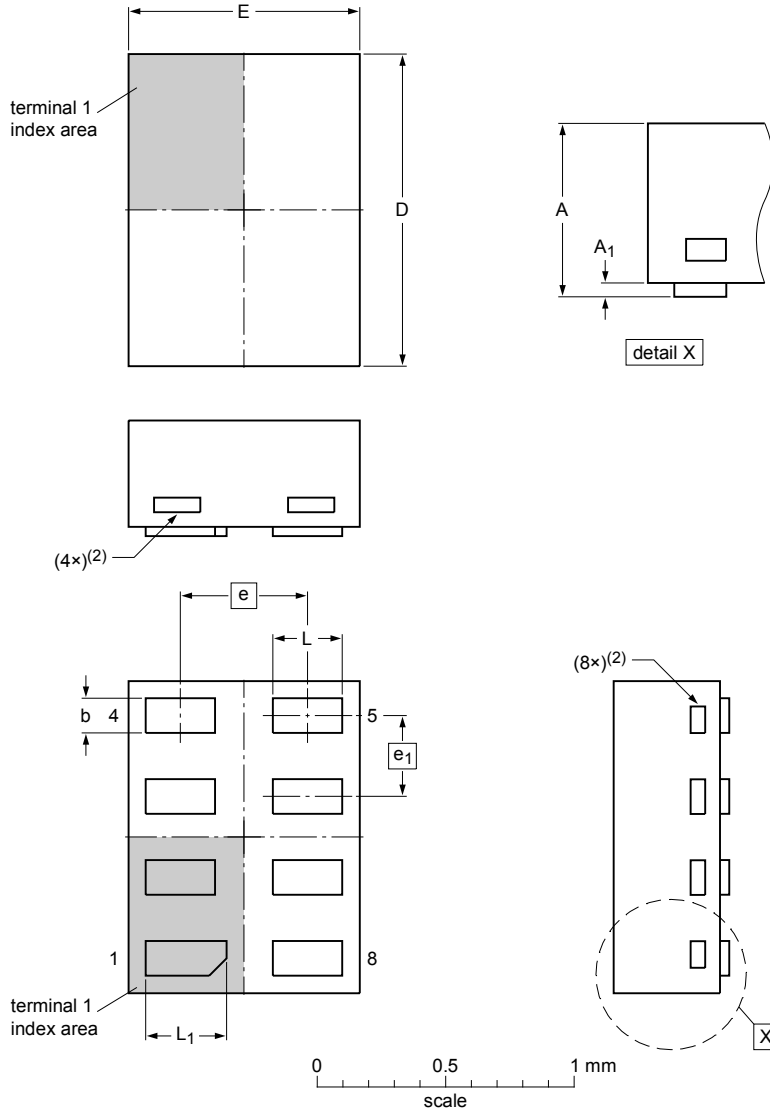

Figure 13. Package outline SOT1089 (XSON8)

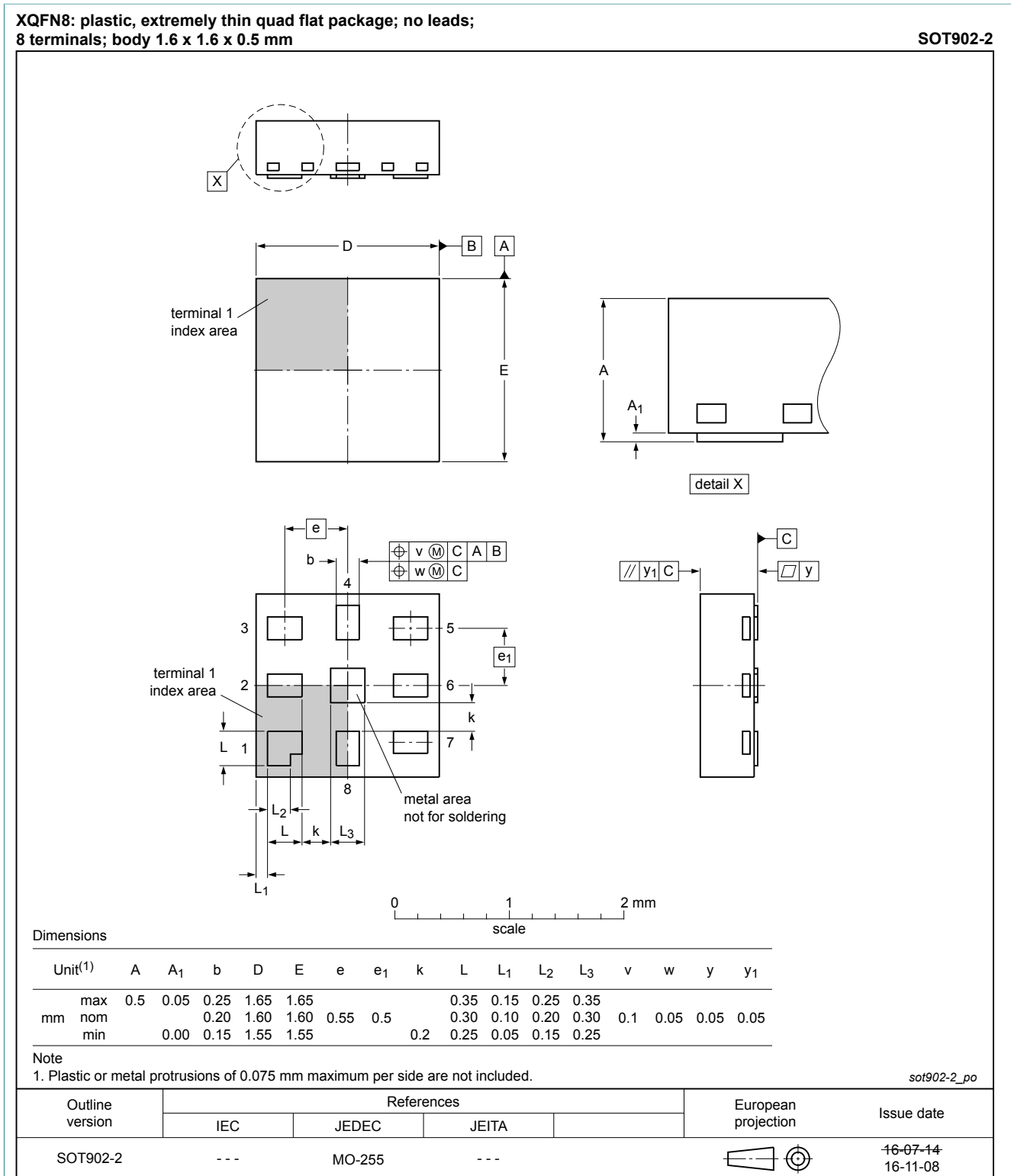
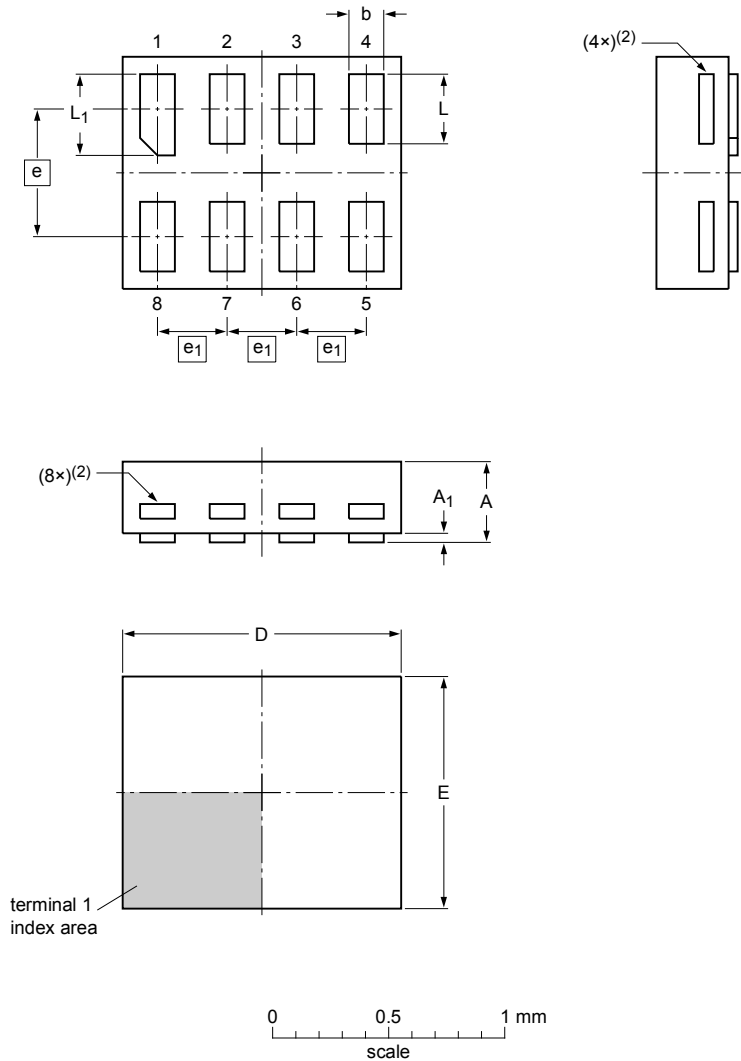


Figure 14. Package outline SOT902-2 (XQFN8)

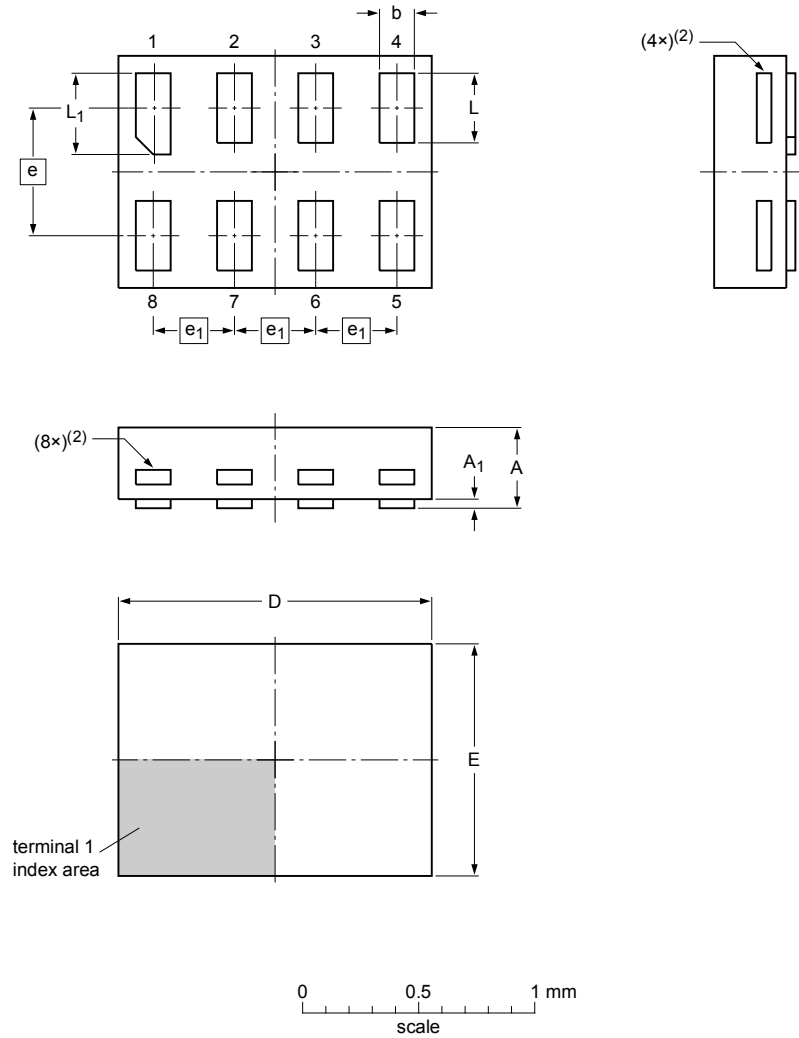

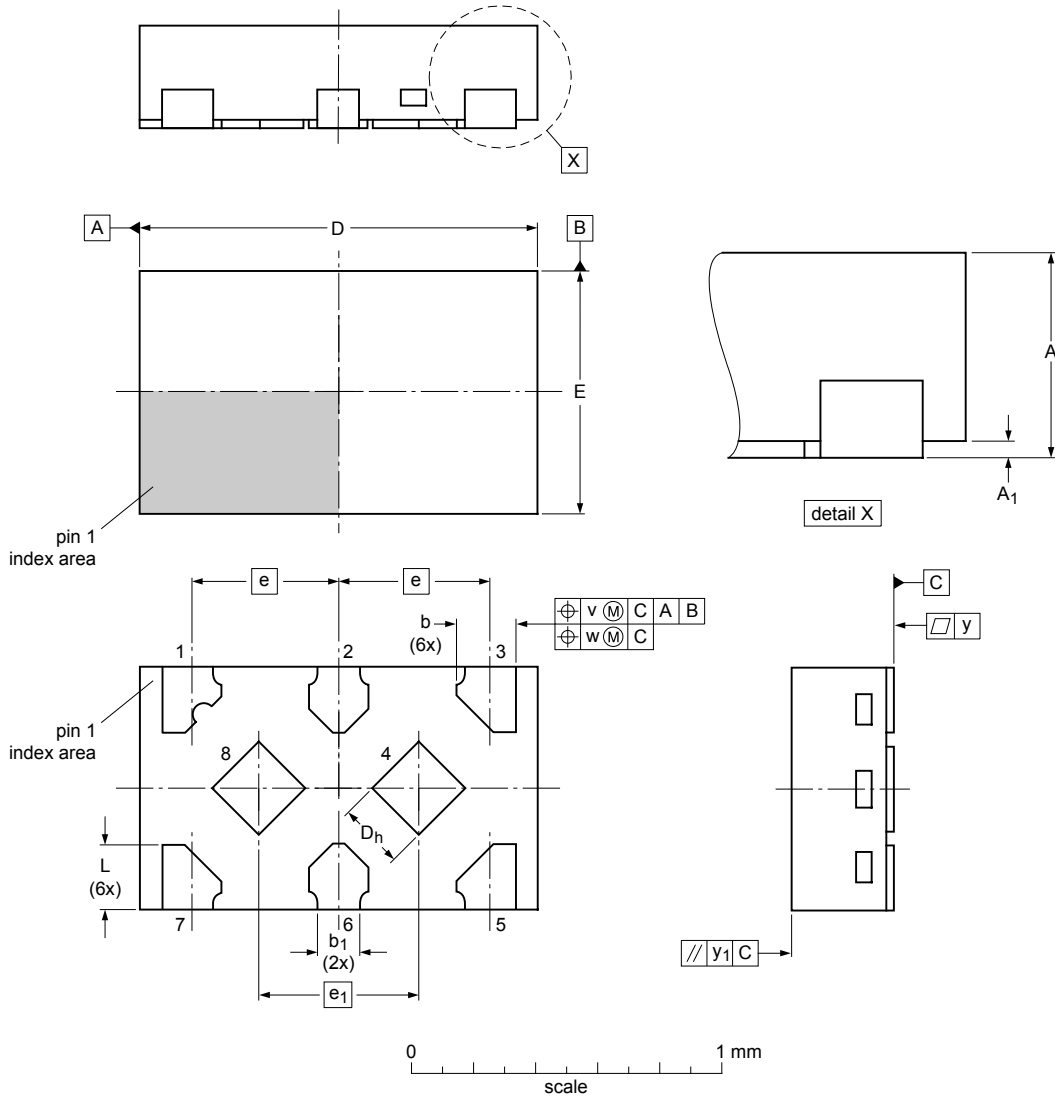
