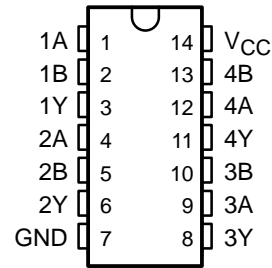

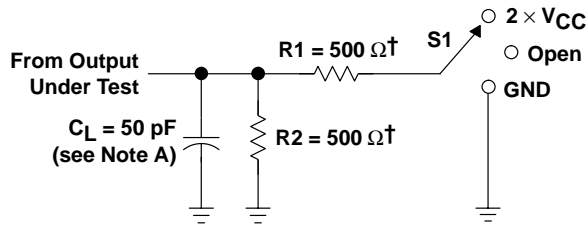

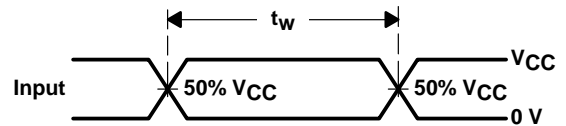

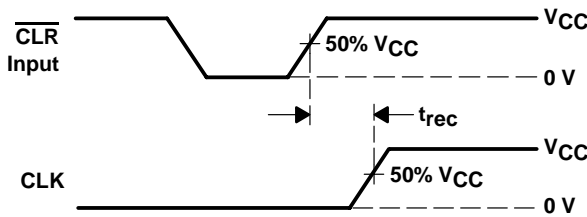

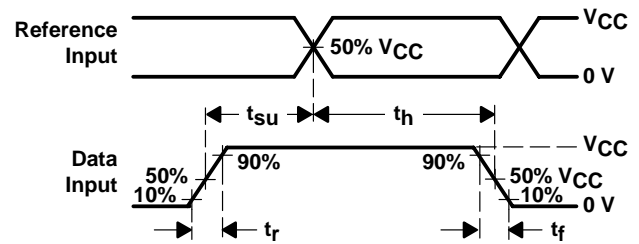

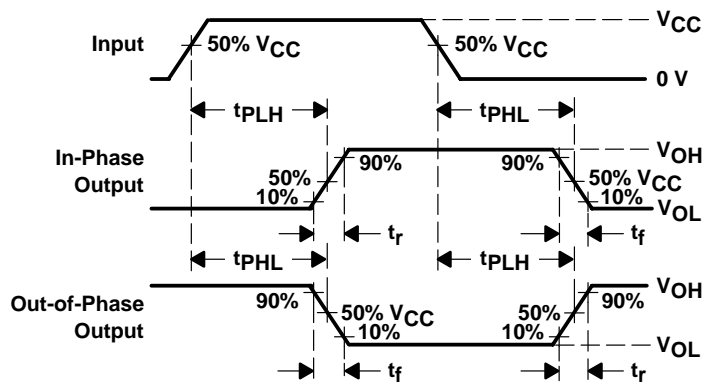
VOLTAGE WAVEFORMS
 PULSE DURATION



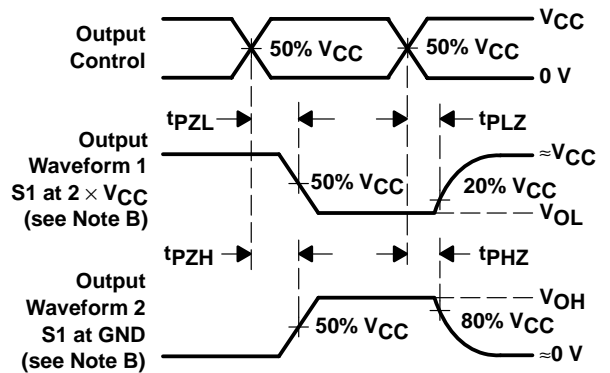
VOLTAGE WAVEFORMS

(1) The marketing status values are defined as follows:

ACTIVE: Product device recommended for new designs.

LIFEBUY: TI has announced that the device will be discontinued, and a lifetime-buy period is in effect.

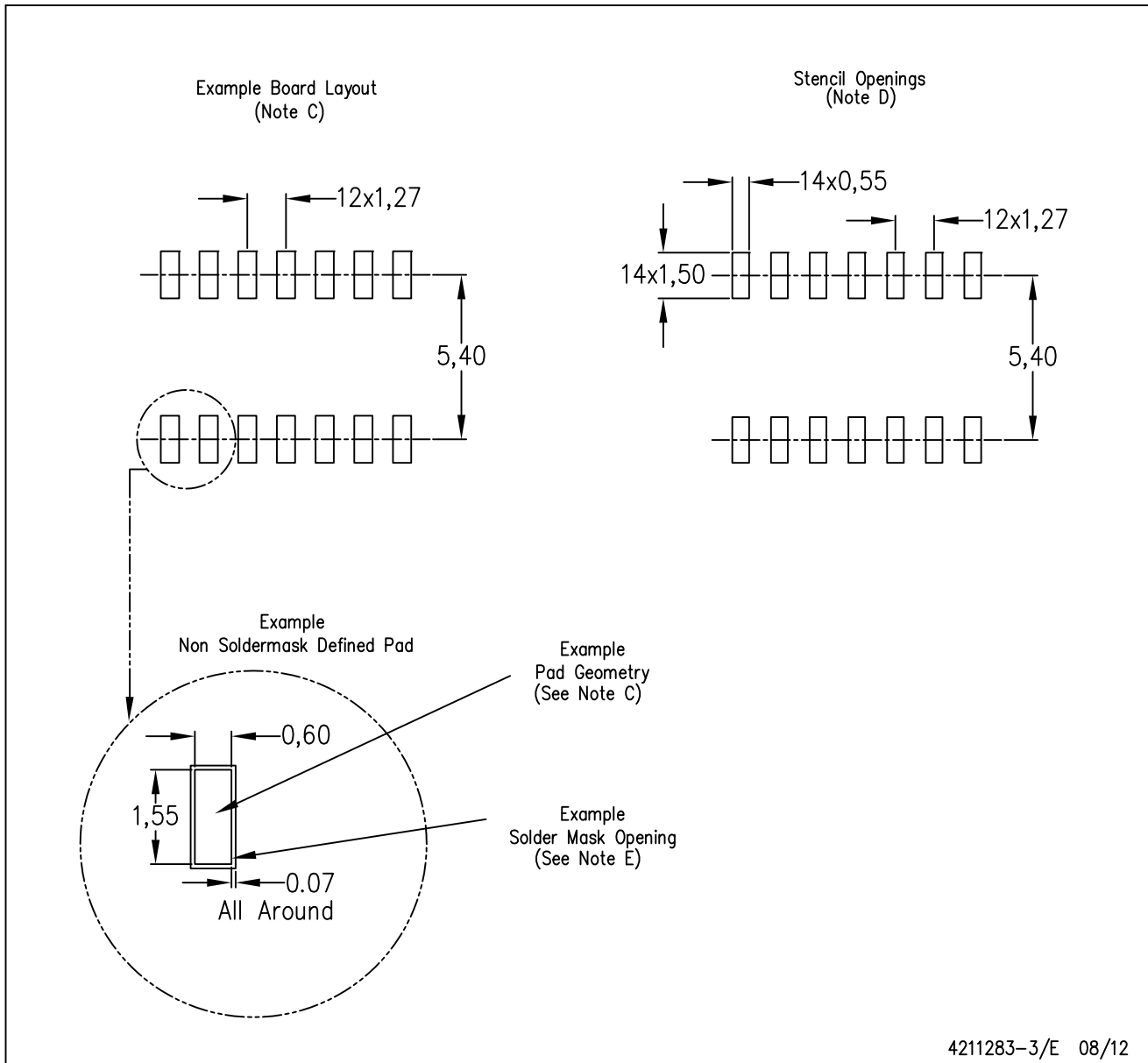
