


7.1 Ruggedness in class-AB operation

The BLF8G20LS-160V is capable of withstanding a load mismatch corresponding to VSWR = 10 : 1 through all phases under the following conditions: $V_{DS} = 28\text{ V}; I_{Dq} = 800\text{ mA}; P_L = 140\text{ W (CW)}; f = 1805\text{ MHz}$.

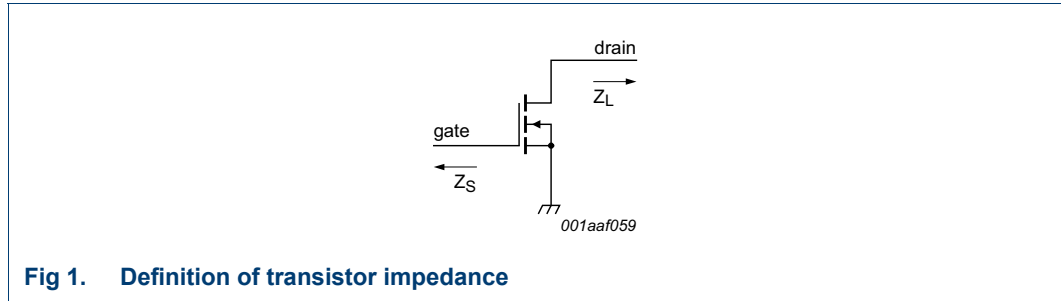


Fig 1. Definition of transistor impedance

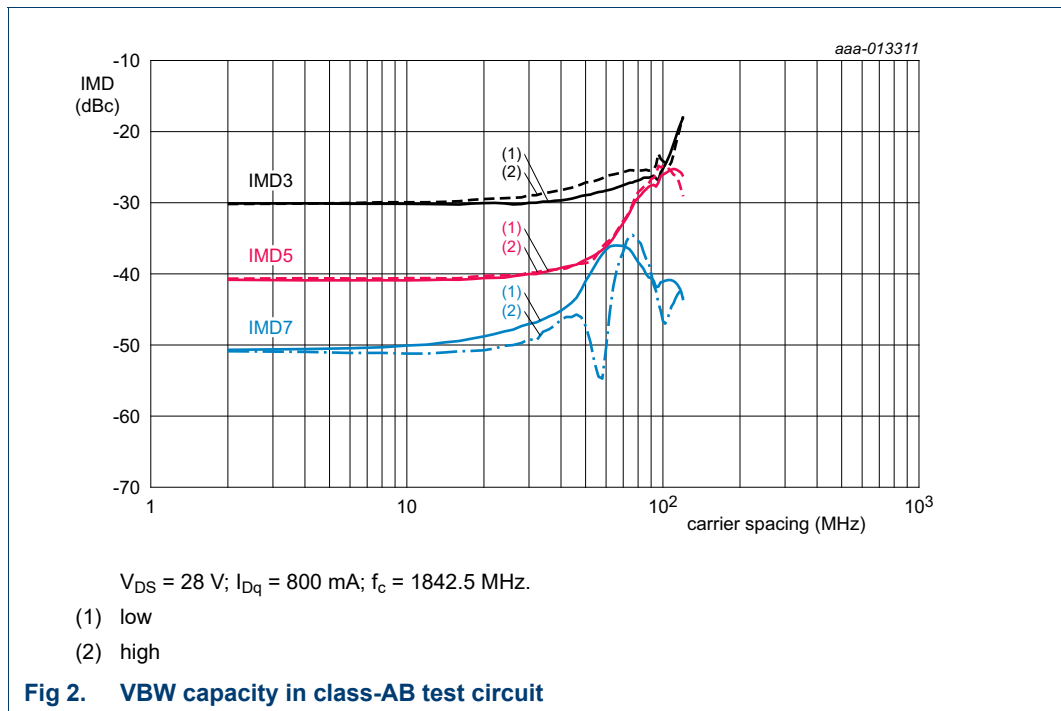


Fig 2. VBW capacity in class-AB test circuit

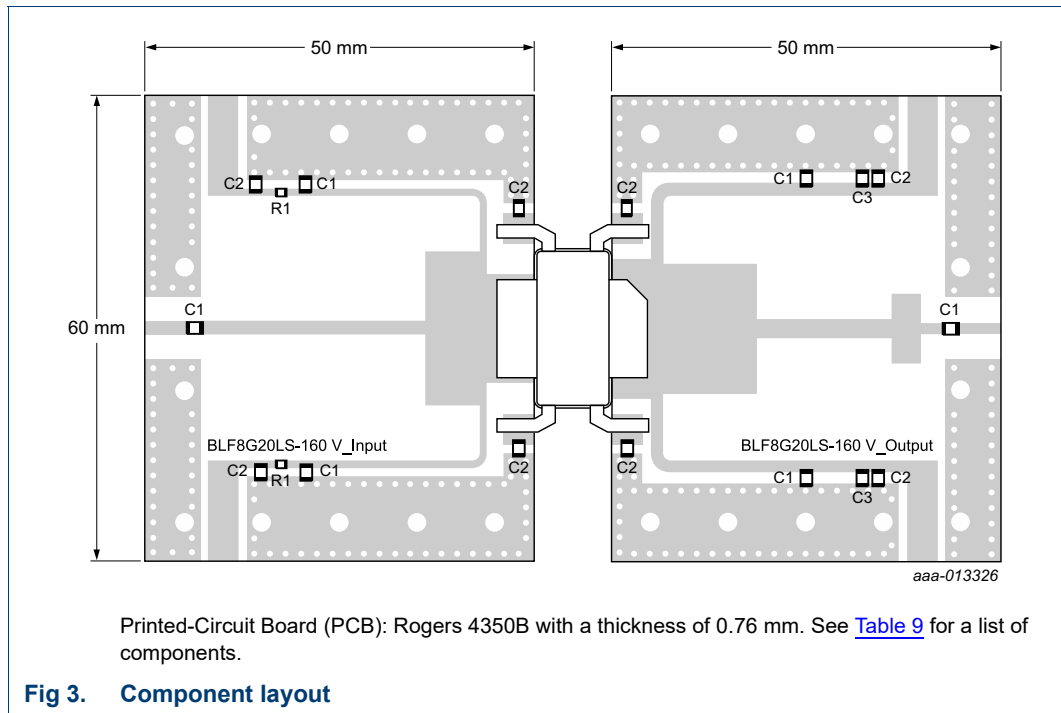


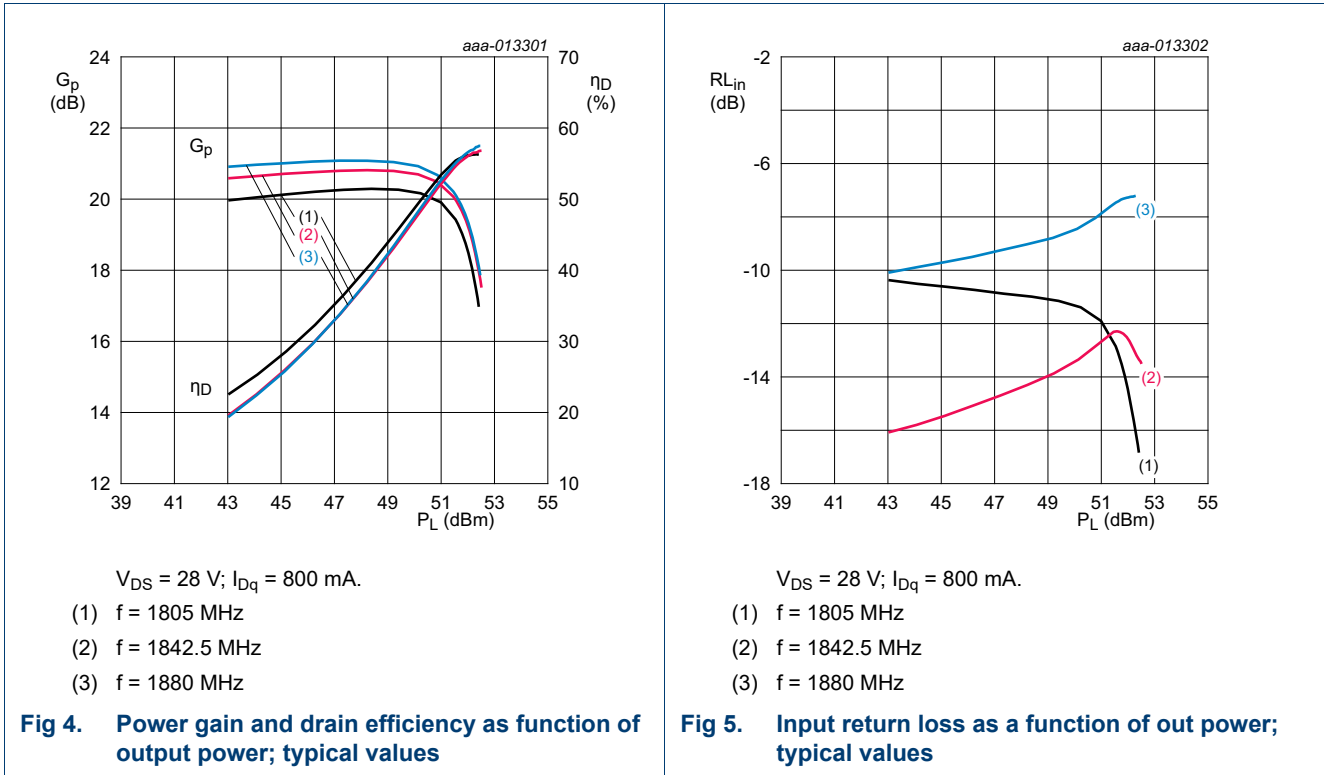

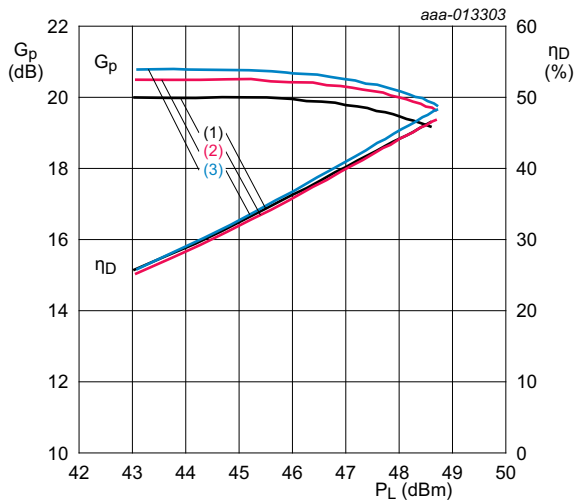

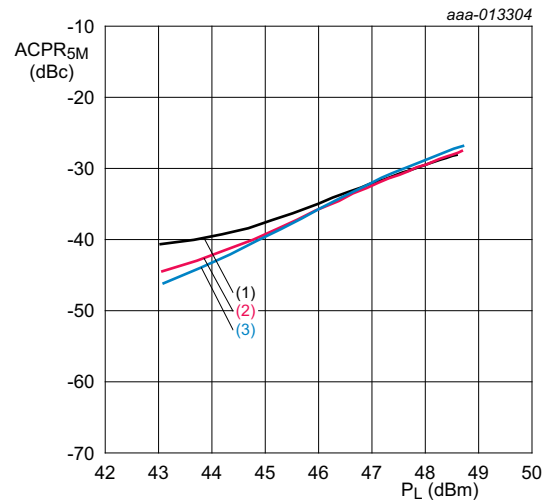

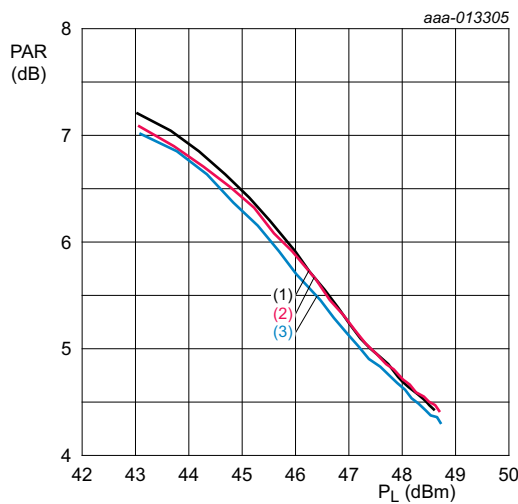

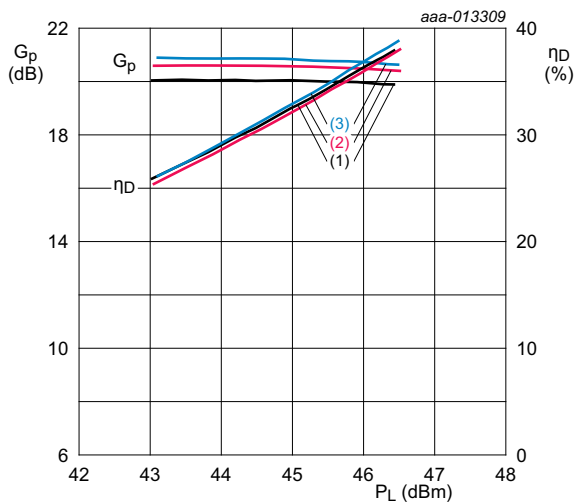
Fig 7. Adjacent channel power ratio (5 MHz) as a function of output power; typical values

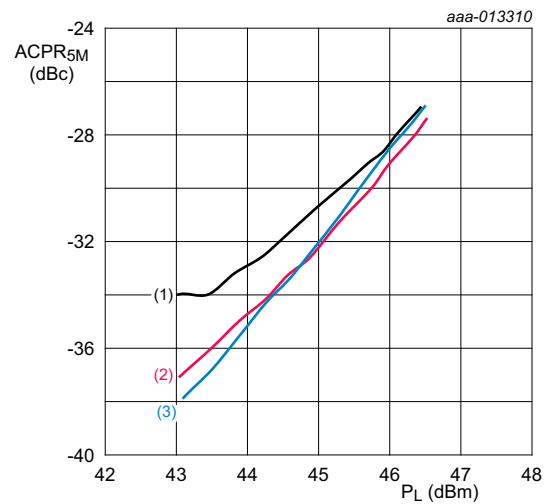
Fig 8. Peak-to-average ratio as a function of output power; typical values

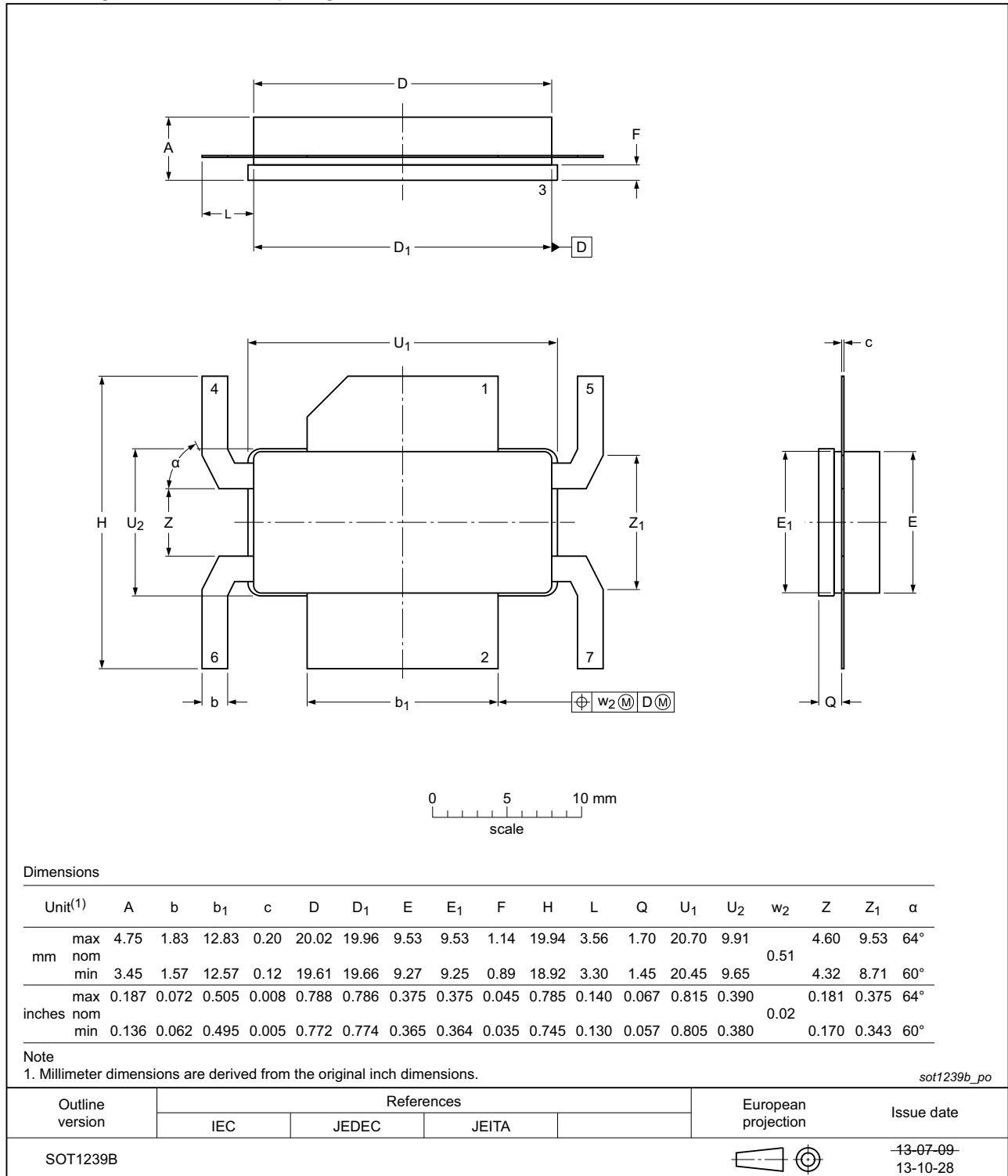



Fig 11. Package outline SOT1239B
