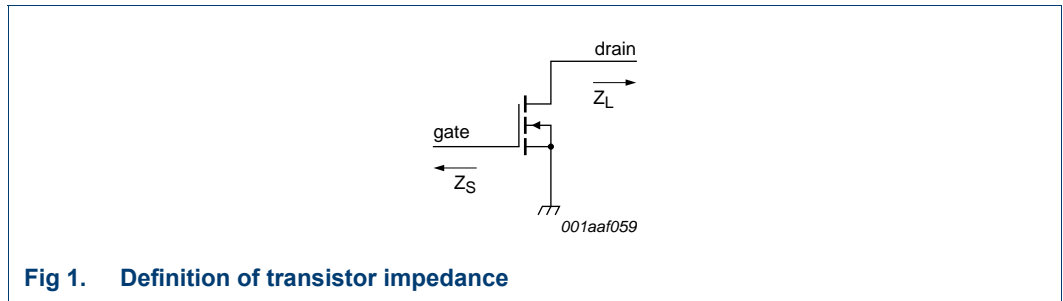

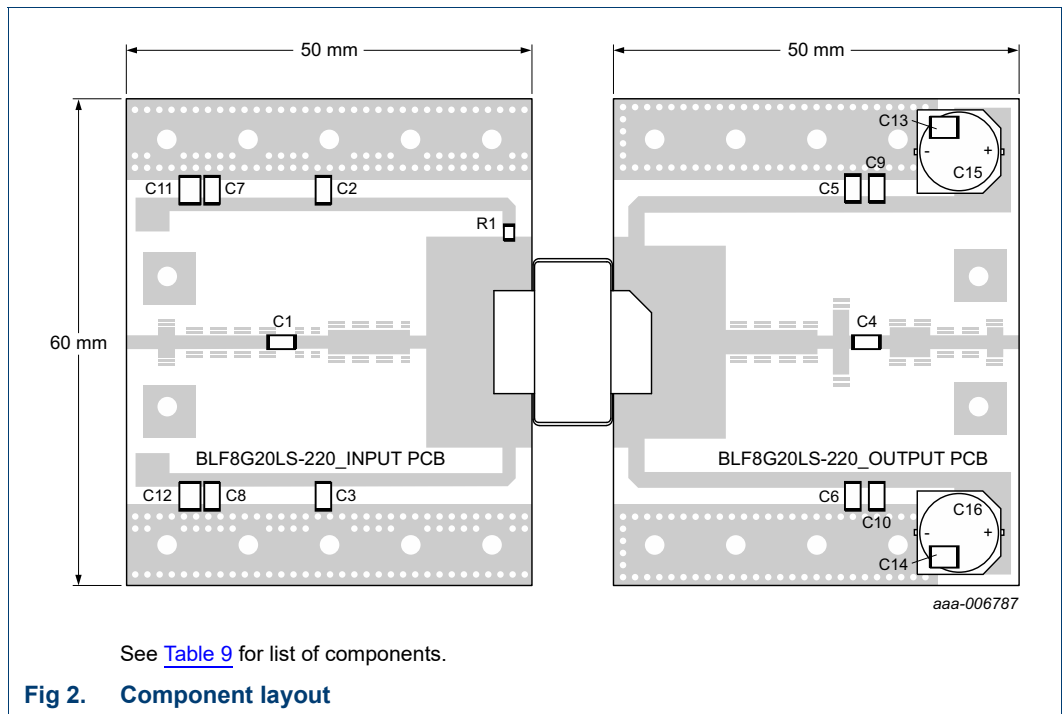

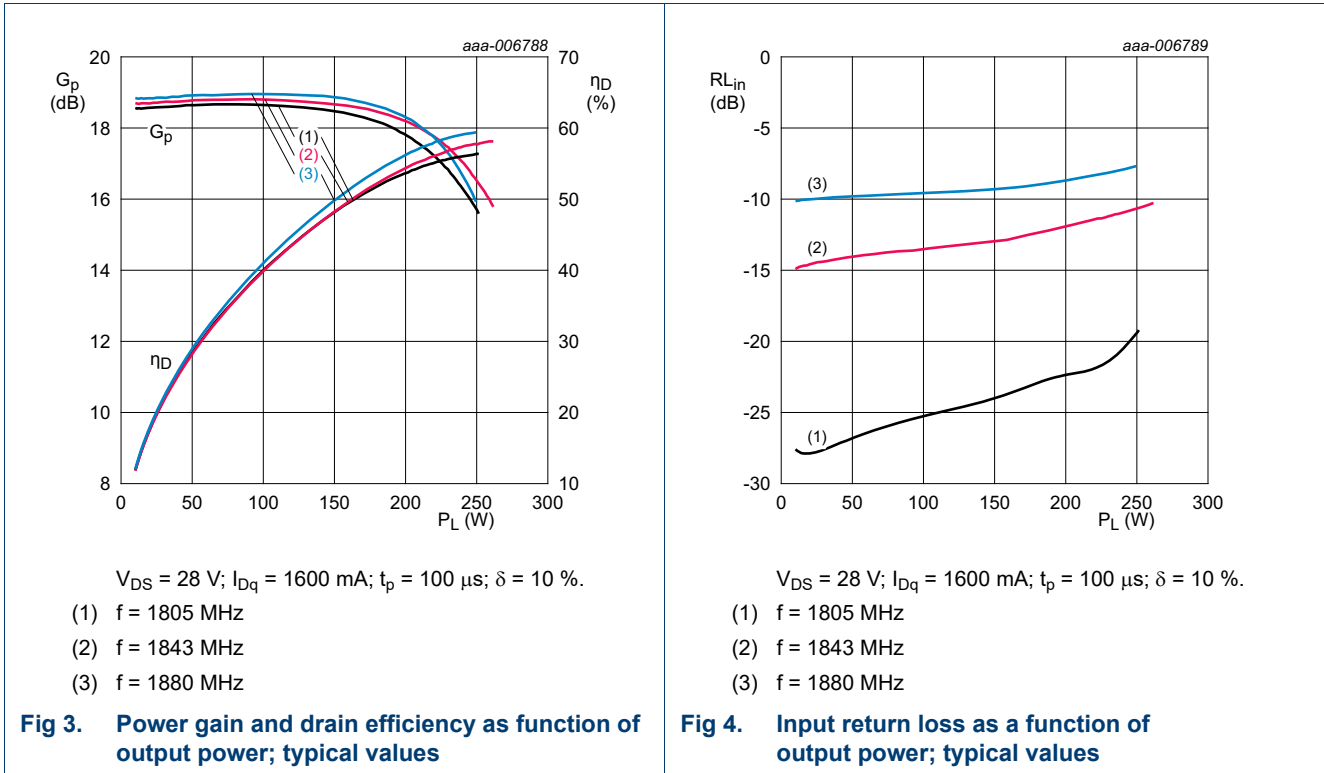

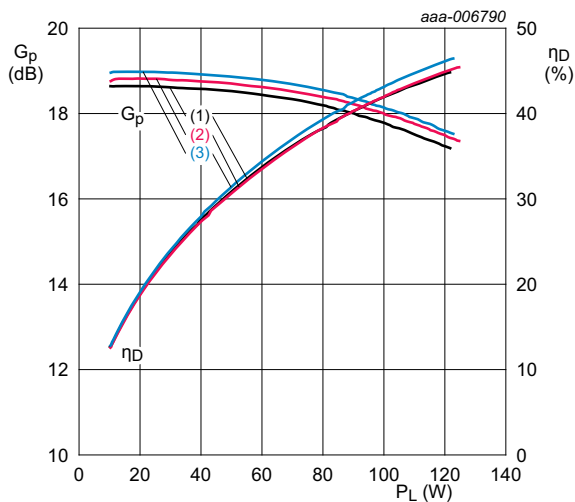

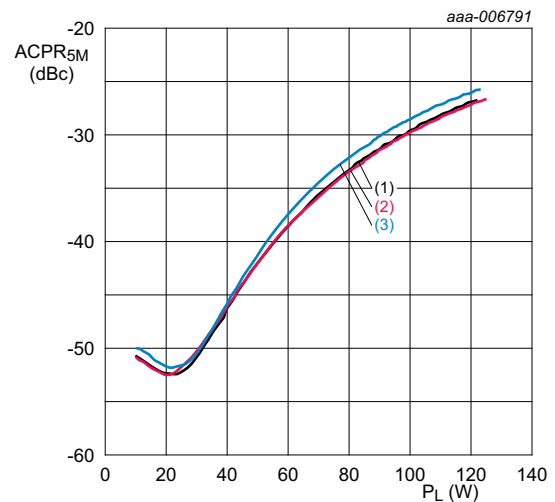

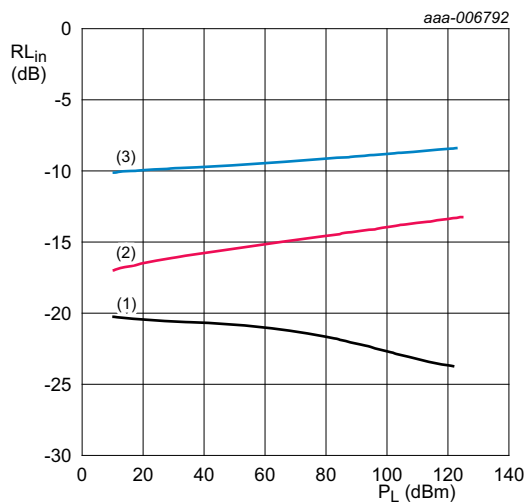

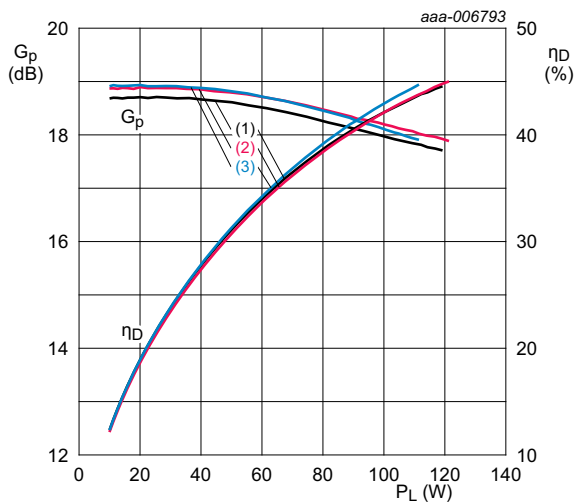
Fig 6. Adjacent channel power ratio (5 MHz) as a function of output power; typical values

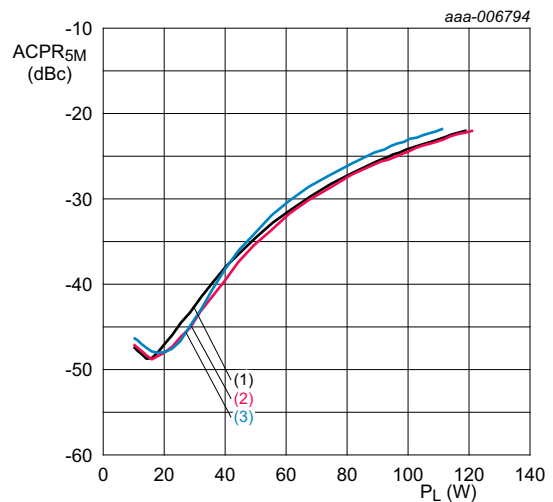
Fig 7. Input return loss as a function of output power; typical values

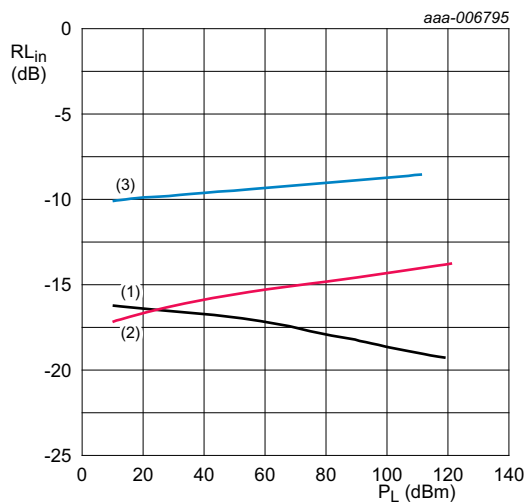

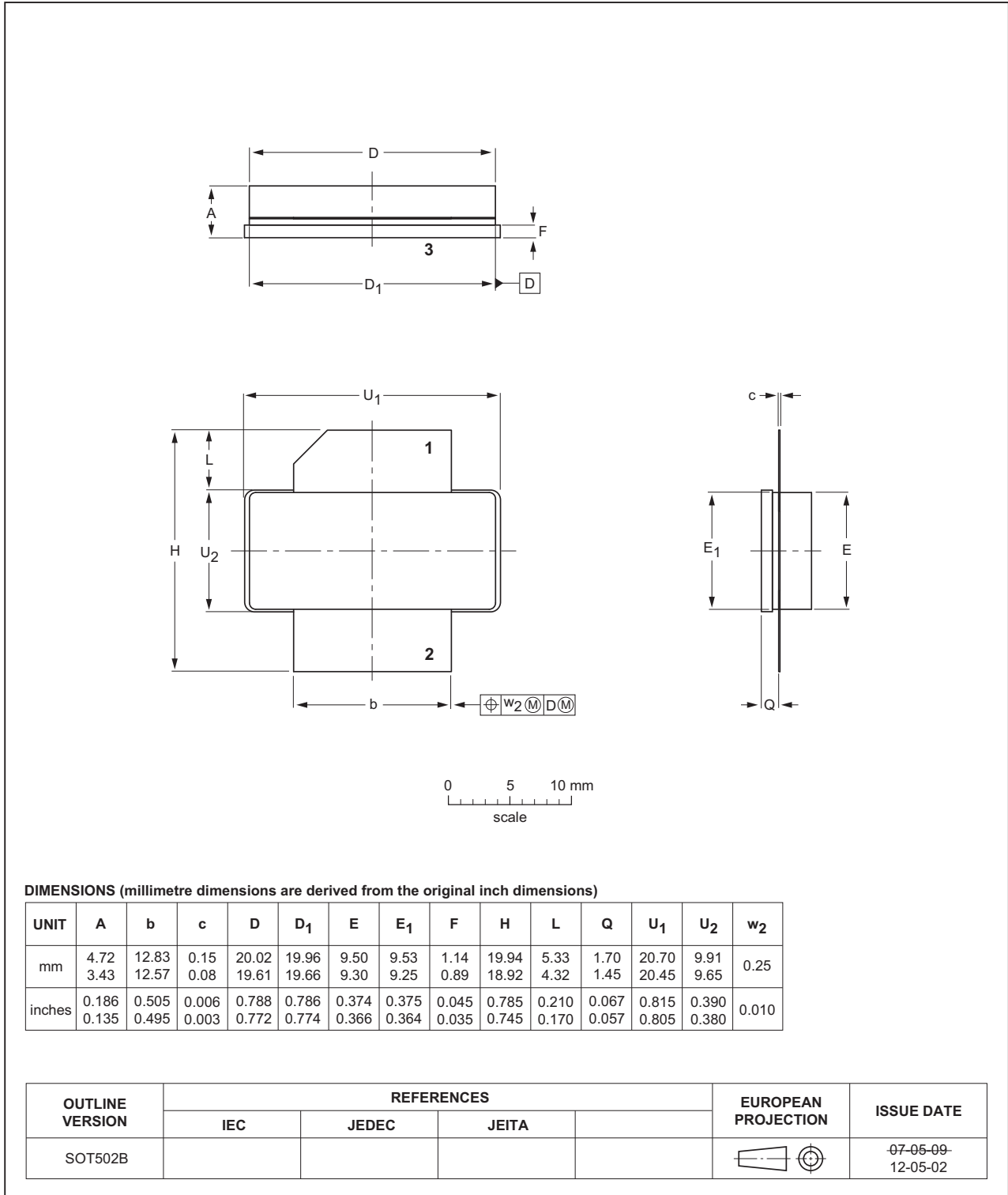


Fig 11. Package outline SOT502B
