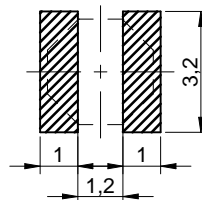

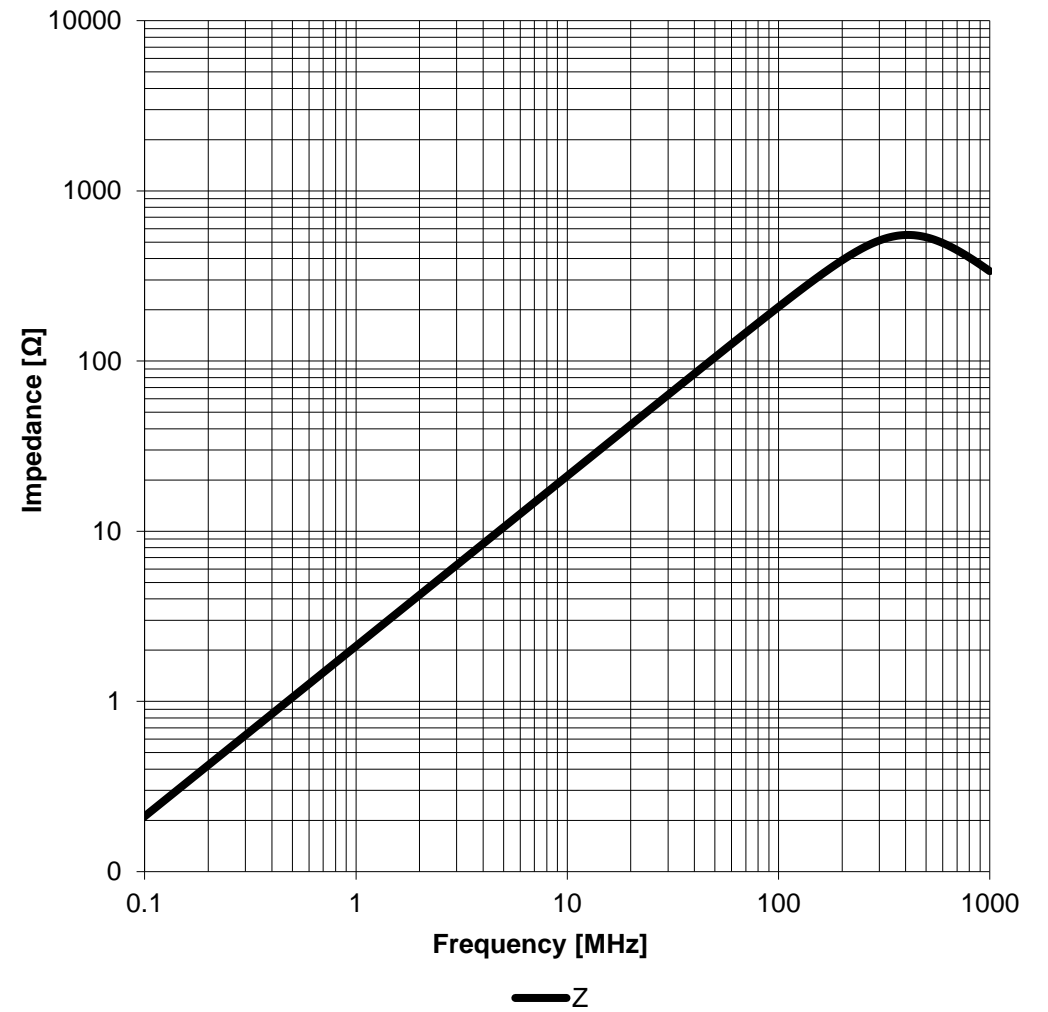

#### Soldering




