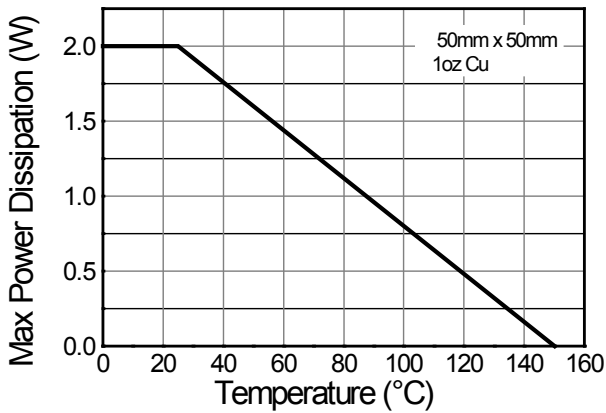

Pulse Power Dissipation



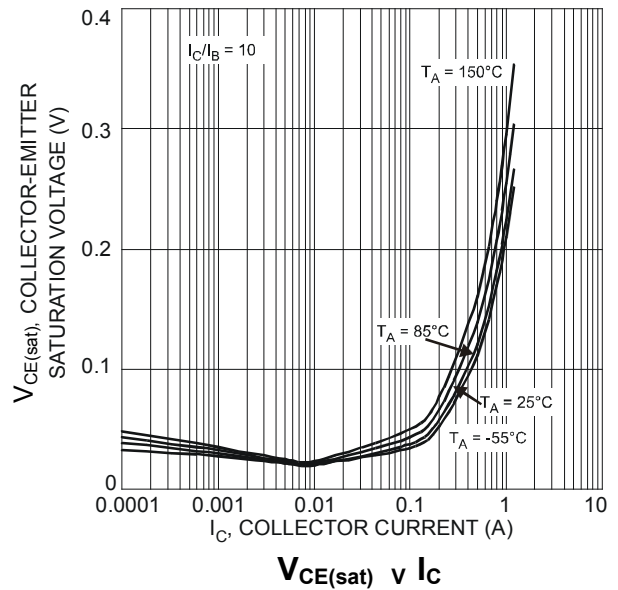
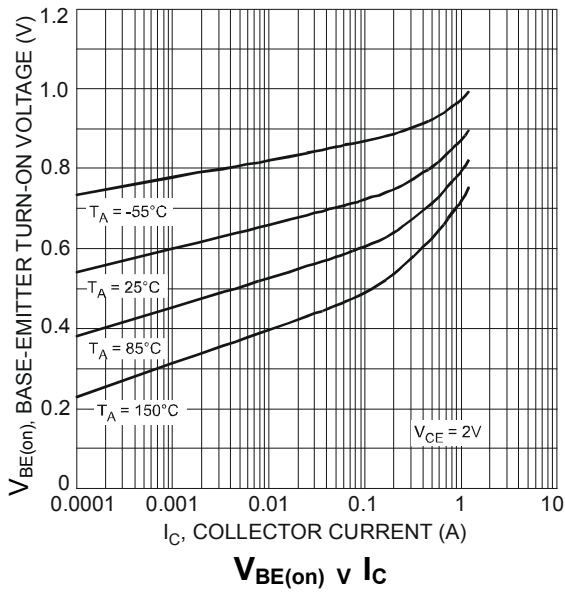
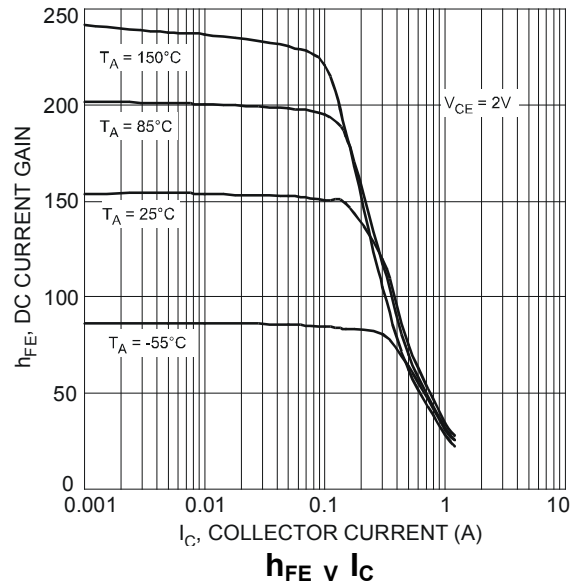
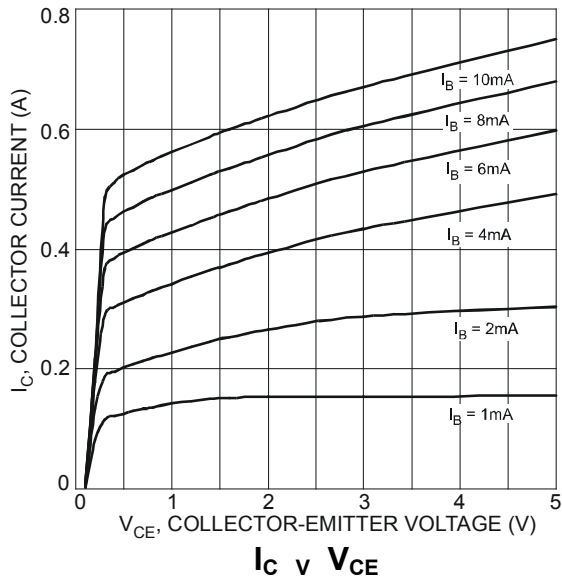
