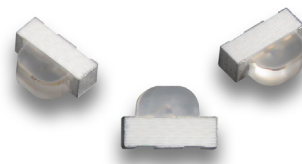

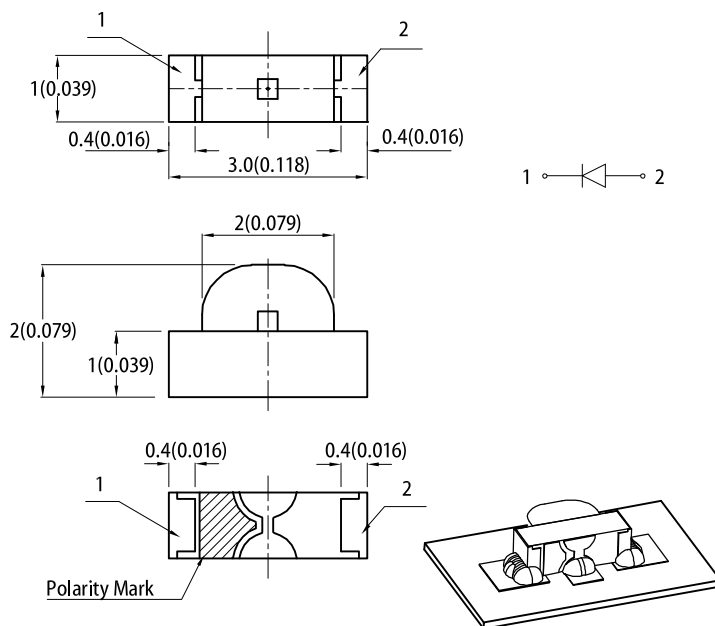

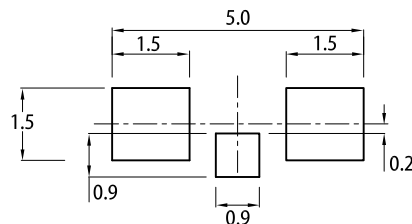

- For right angle SMD LEDs, the solder stencil should be at least 5mil in thickness, to prevent poor solder wetting due to insufficient solder paste.

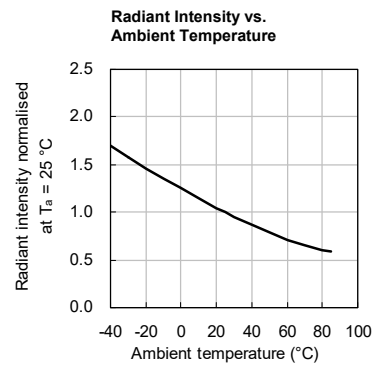
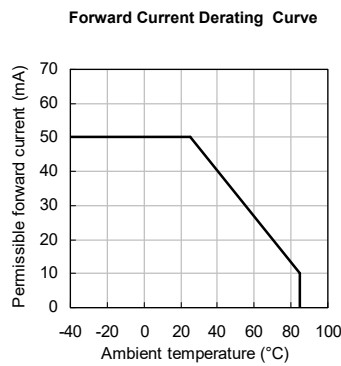
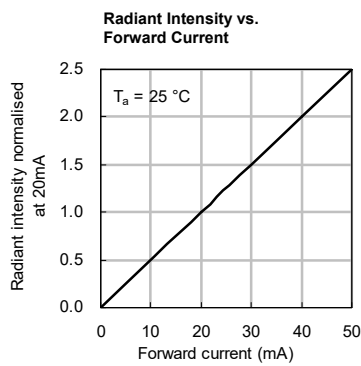
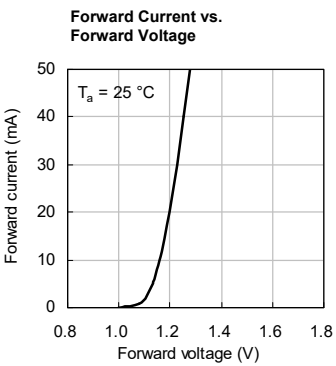
#### RELATIVE INTENSITY vs. WAVELENGTH



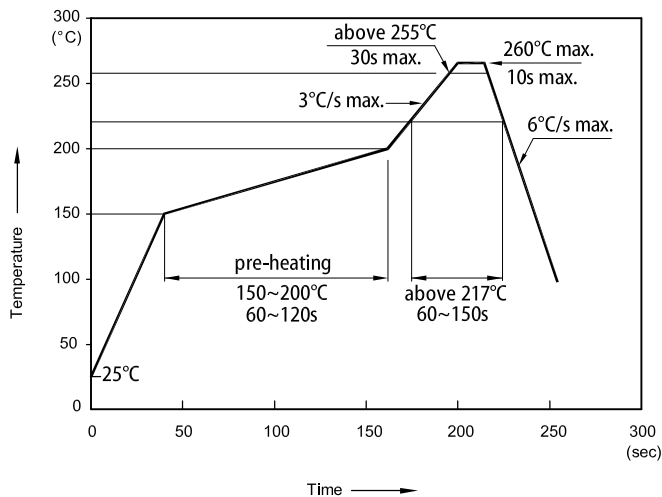
#### SPATIAL DISTRIBUTION



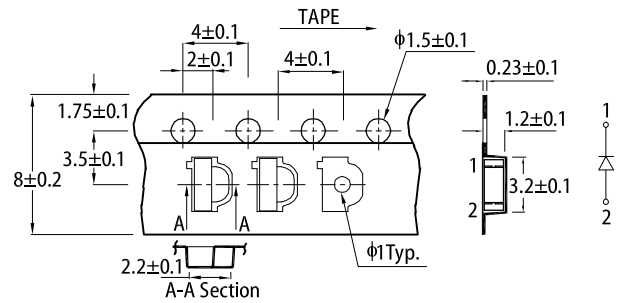

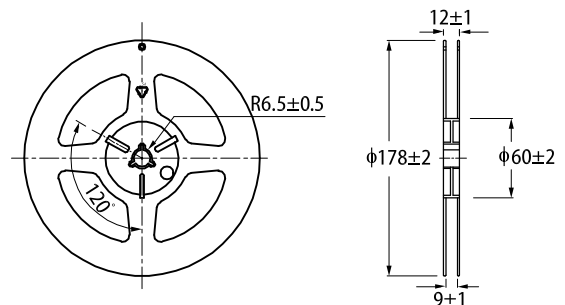
#### REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS

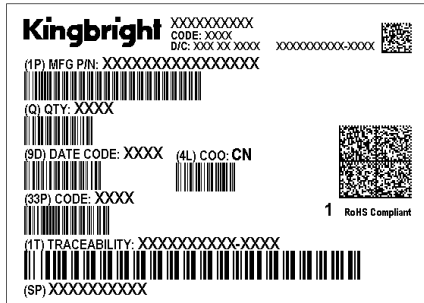
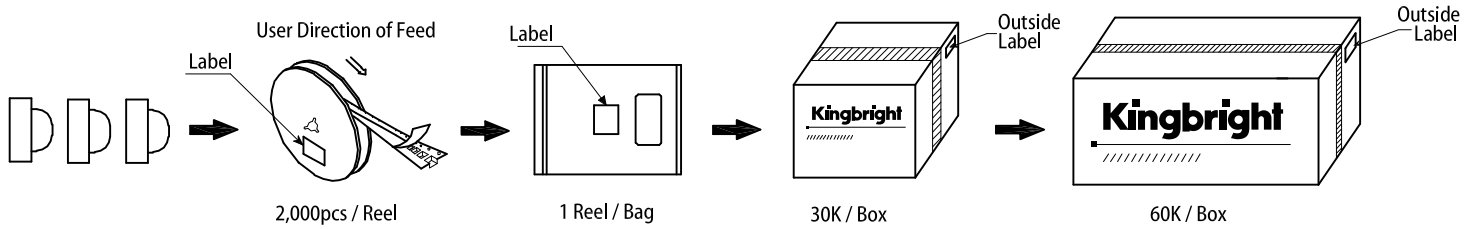


#### REEL DIMENSION (units : mm)
