NTE958 Integrated Circuit 3-Terminal Positive Voltage Regulator, 18V

The NTE958 fixed-voltage regulator is a monolithic integrated circuit in a TO220 type package designed for use in a wide variety of applications including local, on-card regulation. This regulator employs internal current limiting, thermal shutdown, and safe-area compensation. With adequate heat-sinking it can deliver output currents in excess of 1.0 ampere. Although designed primarily as a fixed voltage regulator, this device can be used with external components to obtain adjustable voltages and currents.

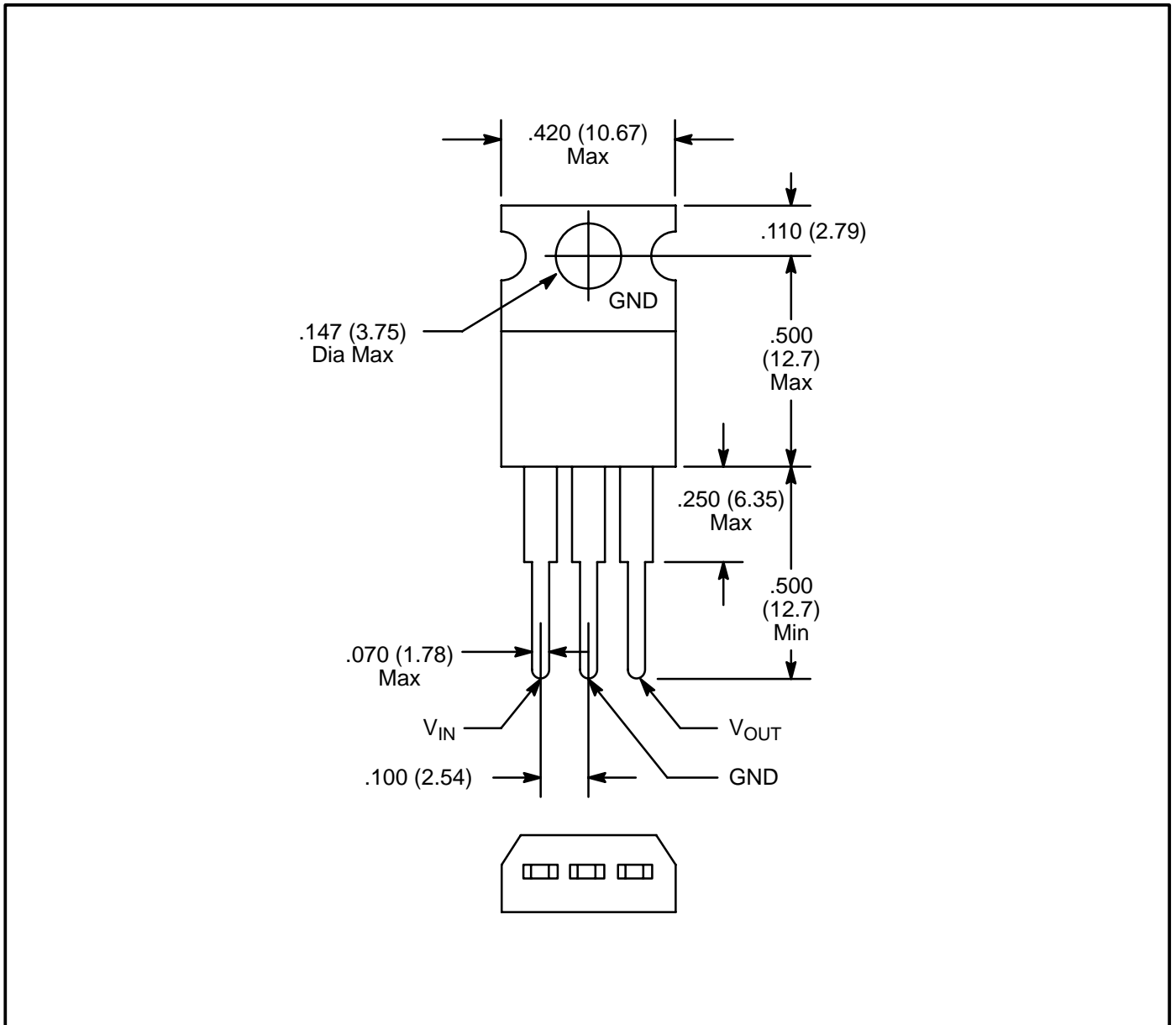
